- 3. If MTSA gave the student any equipment, it must be returned within 30 days of the cancellation date. If the student does not return the equipment within the 30-day period, MTSA may charge the cost of the equipment. The amount charged for each item shall not exceed its fair market value. MTSA shall have the burden of proof to establish the equipment's fair market value.
