**Definitions**

- “Number of Students Who Began the Program” means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- “Students Available for Graduation” is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.

**STUDENT'S RIGHT TO CANCEL**

**Student's Right to Cancel** -The student has the right to cancel an enrollment agreement and obtain a refund of charges paid until midnight of the fifth school day following the first day of class or the seventh day after enrollment, whichever is later. Cancellation shall occur when the student gives written notice of cancellation to the school at the address specified in the agreement. The school shall refund all monies paid by the student within 30 days after it receives the notice of cancellation that is received within the cancellation period. Any Student Kit received by a student after the end of the cancellation period is not returnable to the school and students will be charged for the Student Kit.

**Cancellation Notice** -If a student (or, in the case of a student under legal age, his/her parent or guardian) cancels his/her enrollment prior to midnight of the fifth school day following the first day of class or the seventh day after enrollment, all monies collected by the school shall be refunded. The cancellation date will be determined by the postmark on the written notification or the date said information is delivered to the school administrator in person.
