STUDENT'S RIGHT TO CANCEL

- “Passage Rate” is calculated by dividing the number of graduates who passed the exam by the number of graduates who took the reported licensing exam.
- “Number Who Passed First Available Exam” is the number of graduates who took and passed the first available licensing exam after completing the program.
- “Salary” is as reported by graduate or graduate’s employer.
- “No Salary Information Reported” is the number of graduates for whom, after making reasonable attempts, the

school was not able to obtain salary information.

STUDENT'S RIGHT TO CANCEL

The student has the right to withdraw from the program of instruction or cancel the enrollment agreement at any time and obtain a refund according to the following refund policy. To withdraw or cancel enrollment, the Student must send, via email or letter, or deliver in person, a written Notice of Cancellation or Letter of Withdrawal postmarked **NO LATER THAN** the end of the day of: (a) the first class session or (b) the seventh day after enrollment, whichever is later. Compliance with this policy will result in a full refund.

The amount of the Registration Fee and the Equipment Fee, as provided in the Registration Form, will not be refunded when the Notice of Cancellation or Letter of Withdrawal is sent or delivered after the day of the first class session or the seventh day of enrollment, whichever is later. The refund will be given within 30 days after the submission of the Notice of Cancellation or Letter of Withdrawal. However, if the Student owes the School equipment, the Student must return the equipment in good condition to the School within 30 days before receiving the refund. If the Student fails to return it within 30 days, the fair market value of the equipment will be deducted from the amount of the refund.
