REMEMBER, YOU MUST CANCEL IN WRITING. You do not have the right to cancel just by telephoning the school or by not coming to class. Your cancellation request will only be accepted in writing. If you simply telephone or stop attending class, it will not be considered an official cancellation. A withdrawal may be effectuated by the student's written notice or by the student's conduct, including, but not necessarily limited to, a student's lack of attendance. Students are entitled to a refund of 100 percent of the amount paid for institutional charges, less the \$250 registration fee, if notice of cancellation is made through attendance at the first-class session, or the seventh day after enrollment, whichever is later. Program Refund Calculations Chart

Refund examples are based on the percentage of clock hours completed. The amount owed by the student is calculated by multiplying the total hourly charge for instruction by the number of hours attended. The hourly charge for instruction is derived by calculating the total institutional charge, less any non-refundable fees, divided by the number of program hours. The hourly charge for instruction is then multiplied by the total hours attended by the student to calculate the amount owed by the student. If the tuition has been paid in full, the following reflects a refund for the amount paid in excess by the student:
