ADMISSIONSPOLICY

All students must submit a high school diploma/ GED or high school equivalency test result in order to be admitted into Fair Oaks Massage Institute for certificated programs.

FINANCIAL ASSISTANCE AVAILABLE

Federal and state financial aid programs are available. Fair Oaks Massage Institute accepts funding from S.E.T.A., benefits from V.A., vocational rehabilitation grants, and Social Security Disability Income Passport programs.

ATTENDANCE POLICY

Students are asked to contact the school immediately if they will be late or unable to attend class.

Attendance Policy for Certification Programs:

Attendance will be recorded for each class. Fifteen minutes late is considered tardy and consistent tardiness must be made up. It is the student's responsibility to makeup missed time which may include setting up a meeting to go over what that student has missed with a staff member, as well as acquiring any handouts and homework that may have been assigned. Students who fail to maintain satisfactory attendance will be counseled. Attendance will be deemed unsatisfactory if more than 20% of hours are missed. If attendance fails to improve, the Director may dismiss a student for unsatisfactory attendance. Re-admittance may be permitted if the cause for unsatisfactory attendance has been corrected.

Students must attend or satisfactorily complete all instructional hours. Applicants for CAMTC certification shall have attended 500 supervised hours total with 100 of those hours satisfying CAMTC specified subjects. When unable to attend, the hours that are missed must be made up and approved by

Student Services for satisfactory completion. Students that are missing hours will not receive their certificate until all hours and class work is completed. Lost attendance hours must be made up as described below.

Students may makeup lost attendance hours by:

- a) Per approval: Students attending the missed class(es) will have 20 free make up hours to make up misses time. After the initial 20 free hours are used to make up classes, students must pay a make-up fee at a rate of \$10.00/hour.
- b) All make up hours MUST be completed at Fair Oaks Massage Institute.
- c) All make up hours must be completed during the week and not at a weekend workshop. This means that you may have to wait for your class to cycle through when the topic is offered again.
- d) If a student misses hands on bodywork practice, they may make up hours by doing clinic massage. There will be no charge for students to do clinic massage on the public for make-up hours. Students can being friends and family to work on but they need to pay for the clinic massage. The clinic is subject to availability.

Attendance Policy for Non-certification programs:

Students must attend or satisfactorily complete all instructional hours for non-certificated programs or workshops. When unable to attend, the hours that are missed must be made up and approved by Student Services for satisfactory completion. Students not meeting the attendance requirements will not receive a certificate of completion unless they are able to make up hours when the class is offered again at a make-up fee at a rate of \$10.00/hour.

PROGRESSREPORTSAND GRADING

Our school's grading system is a pass/fail at 70% for each individual exam. Students must score 70% on any examinations to pass the course, including written and practical examinations.

Practical examinations typically consist of one 1 hour massage as well as a continuous dialogue between the student and instructor/staff member regarding professional consultations with clients. Students that fail an exam must retake the exam.

ENGLISH ASA SECONDLANGUAGE

Fair Oaks Massage Institute only offers instruction in English, including lectures, textbooks, handouts, etc.

TUTORING

Fair Oaks Massage Institute offers group and one-on-one tutoring based upon the need of the student. The tutoring need and program will be determined by the administrative staff for :availability of days, times, and curriculum available. The rate for tutoring is \$10.00/hour.

DESCRIPTION OF FACILITIES

The Fair Oaks Massage Institute Director's office, student store, Learning Resource Center and Student Services are located in the Administration office in suite C-1 at 9833 Fair Oaks Boulevard, Fair Oaks, CA 95628. Behind the administration office are two classrooms. There is one large classroom totaling 1000 square feet that includes ample room for chairs and 8-10 massage tables. Next door to the large classroom, there is a mid-sized room that is used for instruction and student clinic massages that holds up to four massage tables comfortably. Restrooms are located in a shared courtyard directly next to the classrooms. Access to the restrooms is limited to those with a key to restrict access to individuals

not affiliated with Fair Oaks Massage Institute. Free parking is available in front of the Administration Building and on the side of the building.

STUDENT SERVICES

Students of Fair Oaks Massage Institute are entitled to the library resources center, study groups, peer mentoring, discounted prices for personal clinics and some products, CAMTC counseling, career counseling, registration counseling, and financial assistance counseling. The Student Services staff is here to answer questions regarding registration/enrollment, provide copies of transcripts or certificates and to accept student tuition payments. Upon graduation, students will receive one copy of their transcript. Additional copies to be mailed are \$25 each. Student Services Staff can also accept student clinic hour sheets and related paperwork, make copies of incoming student documents and make appointments to speak with our Director.

DESCRIPTION OFLIBRARYAND OTHER RESOURCESAVAILABLE TOSTUDENTS

Fair Oaks Massage Institute is in the progress of making books and other learning resources available to students through a formal Learning Resource Center. Access to books and other resources are available by appointment. Students have access to visiting professionals through our workshop series.

HOUSINGINFORMATION

The Fair Oaks Massage Institute does not offer housing, facilitate housing plans nor help students find roommates. A rough estimate of apartment living is between \$700-\$1000 a month.

PLACEMENT ASSISTANCE

No placement service or guarantee of employment is made to graduates of Fair Oaks Massage Institute; however, we do have known opportunities and vacancies in the field of massage that will be posted on the school bulletin board for our students and graduates.

RETENTION OF STUDENT RECORDS

Enrollees are advised and cautioned that California State law requires this educational institution to maintain school and student records for five (5) years. In addition, all transcripts are kept indefinitely in digital form. Upon written request, a student will have the ability to review their transcripts on file.

STUDENT COMPLAINTS

Complaints may be directed to the school's Director either verbally or in writing. The complaint will be investigated thoroughly and if the complaint is not unfounded she will work to resolve the issue(s). A summary of the complaint, its disposition and the reasons will be placed in the students file and entry of the complaint will be made in the log of Student Complaints as required by California State Education Code Section 73870.

A student may lodge a complaint by communicating verbally/or writing to any teacher or office personnel. The recipient of the complaint shall transmit it as soon as possible to the Director. If an oral complaint is not resolved within a reasonable period or before another complaint is made, the student will be advised to submit a complaint in writing. If a student complaint is in writing, the institution shall, within 10 days of receiving the complaint, provide the student with a written response, including a summary of the institution's investigation and disposition. If the complaint or relief requested by the student is rejected, the reasons for the rejection will be stated. The student's participation in the complaint procedure and the disposition shall not limit or waive any of the student's rights or remedies. Any document signed by the student that purports to limit or waive the student's rights and remedies is void.

A student or any member of the public may file a complaint about this institution with the Bureau for Post Secondary Education by calling (888)370-7589 or by completing a complaint form, which can be obtained on the bureau's Web site, www.bppe.ca.gov.

DRESSCODE AND HYGIENE

As students represent the school and the therapeutic massage profession, it is imperative that certain standards be met and dress code and hygiene standards followed. During class periods, students may use their own judgment in attire, but it must conform to the codes of decency. During practicum, students are asked to abide by the following:

- 1. All Students will wear comfortable pants that allow for movement and a short sleeved shirt or polo shirt.
- 2. Appropriate undergarments will be worn.
- 3. Shoes will be practical walking shoes that have non-slip soles and closed toes. Socks will be worn.
- 4. Clothes will be clean and free of odor.
- 5. Student will be clean, free of body odor, and have well-trimmed fingernails.
- 6.Long hair will be pulled back. Beards and mustaches will be neatly trimmed.
- 7. Rings and bracelets will not be worn and should be left at home.

CLASSAND CLINIC DRAPING

FOMI maintains strict standards of draping and modesty in all bodywork sessions taught in class and performed by students in the clinic. Students are taught to drape with care, intention, and regard for modesty and comfort and to always respect the rights of the person they are treating, be it a class mate or a client. No exposure of a person's private genital region will be permitted. Female breast are covered at all times.

PROBATION

Students that receive complaints may be immediately placed on probation depending upon the nature of the situation. The probation period will last for a total of two weeks. If within this time frame additional complaints are received, the student may be dismissed from the program. The following reasons may be cause for probation but are not limited to these situations:

- Being intoxicated or in a drugged state on school grounds.
- Behavior that creates a safety hazard to other people at the school.
- Failure to comply with instructor's requirements, or disrespectful behavior to other students, an administrator, faculty member or student clinic client. Rumors and gossip will not be tolerated.
- Making any verbal or physical threats against other students or staff/faculty.
- Receiving a complaint from any student, staff/faculty

CONDITIONSFOR DISMISSAL

At the discretion of the school's Director, or, her designee, a student may be suspended and/or dismissed from the school for the following reasons but are not limited to these situations:

- Being intoxicated or in a drugged state on school grounds.
- Possession or use of illegal drugs or alcohol on school grounds.
- Behavior that creates a safety hazard to other people at the school.
- Failure to comply with instructor's requirements, or disrespectful behavior to other students, an administrator, faculty member or student clinic client. Rumors and gossip will not be tolerated.
- Bringing any type of weapon onto school property.
- Making any verbal or physical threats against other students or staff/faculty.
- Sexual harassment toward any student, staff, instructor, or student clinic client is not permitted and will not be tolerated.

WITHDRAWAL FROMTHEPROGRAM

You may withdraw from the school at anytime after the cancellation period of the Enrollment Agreement and receive a pro-rated refund if you have completed 50 percent or less of the period of attendance. No refund is available if you have completed 50 percent or more of the program. The amount of that refund is to be "pro-rated" according to the incomplete portion of the program less the cost of any equipment returned in good condition (good condition does not include equipment that a seal is broken, log-on occurred, or is marked or damaged in anyway)and less a registration or administration fee not to exceed \$200.00. Textbooks and materials are non-refundable. The refund is to be paid within 45 days of withdrawal.

For the purpose of determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absence in excess of maximum set forth by the institution and/or failure to meet financial obligations to the school.
- The student has failed to attend class for 8 days.
- Failure to return from a leave of absence.
- For the purpose of determining the amount of the refund, the date of the student's withdrawal shall be deemed the last date of recorded attendance. For the purpose of determining when the refund must be paid, the student shall be deemed to have withdrawn at the end of 8 days.

STUDENT'S RIGHTTO CANCEL

To cancel the contract for school/courses and receive a refund the student must mail, deliver, or fax a signed and dated copy of the written cancellation notice, or any other written notice to:

YOU MUSTCANCEL IN WRITING

The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage. You do not have the right to cancel by calling the school or by solely verbally communicating your request.

A student has the right to cancel his/her agreement for a course of instruction, without any penalty or obligations through attendance at the first class session or the seventh day after enrollment, whichever is later. After the end of the cancellation period, you also have the right to stop school at any time and you have the right to receive a pro rata refund if you have completed fifty(50) percent or less of the program and less a registration or cancellation fee not to exceed \$200.00. Textbooks and materials are non-refundable. The refund is to be paid within 45 days of withdrawal.

However, if the school provided you with any equipment, you must return that equipment on the date that you signed a cancellation notice. If you do not return the equipment on this day, the school will keep the amount that is equal to the cost of the equipment. The equipment must be returned in good condition (good condition does not include equipment that a seal is broken, log-on occurred, or is marked or damaged in anyway).

REFUNDPOLICYFOR CORE PROGRAMS

If the Enrollment Agreement is cancelled, the school will refund the student any money he/she paid, less a registration or cancellation fee not to exceed \$250(less any deduction for equipment not returned or not returned in good condition) within 45 days after the notice of cancellation is received. There is no refund on textbooks and materials. Students who have dropped from the program without written notice, have 90 days to submit a written request for withdrawal and refund for the pro-rated amount of the program if they have completed 50 percent of the program or less. After 90 days of no written contact, the student is considered dropped and forfeits their refund.

REFUNDPOLICYFOR WORKSHOPS

Workshop tuition includes any applicable material fees and cancellation fees. Fair Oaks Massage Institute retains the cancellation fee should the student withdraw, cancel or fail to appear in the workshop. Cancellation feesare 20% of the cost of any workshop or \$200 whichever is less. Students will receive a full refund in the event that the Fair Oaks Massage Institute cancels the workshop.

LEAVE OFABSENCE

Students may request a leave of absence(LOA) from a certification program in the event of emergency or other compelling reasons. The request must be submitted in writing and reviewed by Student Services. A leave of absence is granted one time per student. The maximum amount of time for a leave of absence is one year. The student may then be admitted to a later course. Graduation will be delayed until attendance requirements are met. If a student does not return to complete the program after a leave of absence of one year, a refund will be calculated and paid based on the percentage of the program they completed within 45 days. If 50% or more of the program was completed, no refund is available.

DROPPINGOUT

Students dropping out of the course may receive a tuition refund based upon the refund policy outlined in this catalog and the enrollment agreement. If dropping out, a request for refund must be in writing. A refund is not available if the student completed 50% or more of the program. The last day of class attended will be considered the date of cancellation, whether or not a cancellation notice is given by the student to this institution. Students have 90 days to request a refund in writing or readmit into another

program, however, the full tuition for re-admittance into the course would be required. If there is no contact from the student in writing after 90 days, no refund is available.

REQUIREMENTSFOR SATISFACTORY COMPLETION

A Certificate of Completion will be issued to each student for our certification programs if all of the course requirements are completed:

- Attendance of all classroom and demonstration hours or satisfactory makeup of missed hours.
- Payment in full for the program.
- Completion of the Student Clinic Program, if applicable.
- Satisfactory scores (70% or greater) on all applicable written and/or practical examinations.

STUDENT ACHIEVEMENT STANDARDS-REQUIREMENTSFOR CERTIFICATIONPROGRAMS(TO RECEIVE CERTIFICATE/GRADUATE)

Certificate hours may include lecture, hands-on demonstrations of massage/bodywork techniques, student clinics, and homework. A student must complete all training and/or class hours in order to receive a completion certificate within 3 months of the last day of class:

- Attendance completed for all classroom and demonstration hours or satisfactory makeup of missed hours.
- Missed classes or course material may be made up by the student attending a later course when the classes they missed are recycling through the next class session, if seating is available, at a rate of \$10.00/hour, after student have used their 20 free make up hours.
- Full payment has been received for program:

 Tuition must be paid in full. All outstanding balances, including late fees, must be paid in full before the student is eligible to graduate.
- Successful completion of designated number of one-hour massages for the student clinic program: Assigned student clinic and practical hours must be completed.
- Satisfactory scores (70% or greater) on all applicable written and/or practical examinations: All examinations must be complete with a passing grade of 70% or better.

Upon completion of the massage course, passing the exams, completion of student clinic hours and completion of any pertaining homework, the student will then be eligible to graduate and receive their certificate once their balance is paid in full.

REQUIREMENTSFOR NON-CERTIFICATION PROGRAMS(TO RECEIVE CERTIFICATE)

Hours may include lecture, hands-on demonstrations of massage/bodywork techniques and homework. A student must complete all training and/or class hours in order to receive a completion certificate within 4 weeks of the last day of class:

- Attendance completed for all classroom and demonstration hours or satisfactory makeup of missed hours.
- Full payment has been received.
- Outstanding balances must be paid in full before the class begins.
- Missed classes or course material may be made up by the student attending a later course when the classes they missed are recycling through the next class session, if seating is available, at a rate of \$10.00/hour.

Upon completion of the course, passing any required tests, completion of any student clinic hours and completion of any pertaining homework, the student will then be permitted to receive their certificate once their balance is paid in full.

NOTICE CONCERNINGTRANSFERABILITYOFCREDITSAND CREDENTIALSEARNEDATOUR INSTITUTION

The transferability of credits you earn at Fair Oaks Massage Institute is at the complete discretion of the Institution to which you may seek to transfer. Acceptance of the certificate you earn at the Fair Oaks Massage Institute is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your course work at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Fair Oaks Massage Institute to determine if your certificate will transfer.

TRANSFER OFCREDITS

The Fair Oaks Massage Institute does not accept transfer credits from any other institution.

ARTICULATION AGREEMENT

The Fair Oaks Massage Institute does not have any articulation agreement with any other institution.

STUDENT TUITIONRECOVERY FUND DISCLOSURE

The State of California established the Student Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of you tuition.

You are not eligible for protection from the STRF and you are not required to pay the STTRF assessment, if you are not a California resident, or are not enrolled in a residency program.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Postsecondary Education, 2535Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or enrolled in a residency program, paid the STRF assessment, and suffered an economic loss as a result of any of the following:

- 1. The Institution, location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
- 2. You were enrolled at an institution or a location of the institution within the 120 days before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued, if the Bureau determined there was a significant decline in the quality or value of that educational program during that time period.

- 3. You were enrolled at an institution or a location of the institution more than 120 days before closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
- 4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
- 5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
- 6. You have been rewarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the reward form the institution.

In the event of an institutional closure, to qualify for STRF reimbursement, you must file a STRF application with the Bureau within two (2) years of receiving notice of the closure of the institution. If you do not receive notice, you have four (4) years from the date of the closure to file a STRF application.

For STRF reimbursement based on discontinuation of a program, refund award ordered by the Bureau, failure to pay or reimburse loan proceeds, or an award ordered by an arbitrator or court based on violation of the Act, you must file a STRF application within two (2) years of the award order, failure to pay or reimburse loan proceeds or program closure.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

UNFAIRBUSINESSPRACTICE

California state law states that:

(a.) It is an unfair business practice for a person to do any of the following:

- 1. To hold himself or herself out or to use the title of "certified massage therapist," or any other term, such as "licensed," "certified," or "CMP," in any manner whatsoever that implies or suggest that the person is certified as a massage therapist or massage practitioner, unless that person currently holds an active and valid certificate issued by the council pursuant to this chapter.
- 2. To falsely state or advertise or put out any signor card or other device, or to falsely represent to the public through any print or electronic media, that he or she or any other individual is licensed, certified, or registered by a governmental agency as a massage therapist or massage practitioner. (b.)In addition to any other available remedies, engaging in any of the prohibited behaviors described in subdivision (a.) constitutes unfair competition under section 17200.

STATECERTIFICATION

The California Massage Therapy Council ("CAMTC") was created to implement a statewide certification process with clear standards of preparation and education.

AB1147, the bill to continue CAMTC, has been signed by the Governor and will become law, effective January 1, 2015. AB1147 changes the educational requirements for certification. Applications for certifications as Certified Massage Practitioner ("CMP") will not be accepted on or after January1, 2015. As of January1, 2015, applicants for certification as a Certified Massage Therapist("CMT") must have 500 hours of education from approved schools and have passed a CAMTC approved exam.

Certified Massage Therapist(CMT) – Students are required to complete at least 500 hours of massage education and training at CAMTC approved massage therapy school(S), which shall not be online or distance learning. Of those 500 hours, a minimum of 100 of those hours must be anatomy and Physiology, contraindications, health and hygiene, and business and ethics.

Passage of a CAMTC approved exam. CAMTC has approved the following exam:

• The Massage and Bodywork Licensing Exam (MBLEx)— offered by the Federation of State Massage Therapy Boards (FSMTB).

BODY WORKINSURANCE

All students need to have Body Work (Malpractice) Insurance in order to start student clinic massages. BUSINESSLICENSE

Our students are eligible to apply for business licenses by contacting the city/county for which they are planning to work in. The requirements vary depending upon the county that the student is intending to work; so, inquiring to the specific area of where the student is looking to work is imperative.

FINANCIAL ASSISTANCE

The Fair Oaks Massage Institute is not currently approved to offer financial assistance through Title IV funding.

LOAN ENROLLMENT AGREEMENT REQUIREMENTS

CERTIFICATION AND EXAM RATES

Depending upon the therapist's professional path, a business license may not be required if the therapist is not planning to be self-employed, but instead they will need to become state certified if they plan to be an employee. The costs shown below are based on rates as of today and are all subject to change.

California State Certification through California Massage Therapy Council (CAMTC)— The cost is \$150.00 for the initial application, which lasts for two years. The renewal cost is \$150.00 and good for two years. This will also require live scan fingerprinting at an additional \$70-80. To apply, you must have completed 500 hours of onsite training at an approved school and have a passing score on the MBLEx. The MBLEx cost is \$195. See below.

MBLEx

The MBLEx (Massage & Bodywork Licensing Examination) is governed by the Federation of State Massage Therapy Boards FSMTB). The MBLEx is the sole licensing exam for the Massage Profession. It is designed to provide a standard examination for students of Massage for entry-level professional scope of practice in gaining licensure. The FSMTB was established in 2005 with the intent to build a support system for the Member Boards. Their goals from the beginning were to work towards cooperation in implementing regulations and procedures for the requirements to establish safe and effective Massage Therapy and Bodywork practices. To be qualified to take the MBLEx you must apply directly with the FSMTB. The fee required to take the exam is \$195 due with the submittal of your MBLEx application. If you apply through your state licensing board or agency you do not need to fill out and send the application to FSMTB, the board or agency will complete that process for you.

BUSINESS LICENSES/PERMITS

The cost and requirements are different from city to county and can range from \$10/Year to over \$165/3 years. Typically abusiness license renewal requires a minimum of 12 hours of continuing education per year.

MASSAGE INSURANCE

Massage Therapist Insurance through Associated Bodywork & Massage Professionals (ABMP)or American Massage Therapy Association (AMTA) ranges in cost from \$89 - \$235, annually.

SALARIES

Hourly wages can range from \$15.00/hour and can go well over \$90.00/hour depending upon the therapist's expertise and location of business. Hourly rates also vary according to whether or not the therapist is self- employed.

While Acupuncture can produce dramatic and powerful effects, there is no substitute for the power and healing abilities of hands on work. In "pushing and grasping" Tui Na uses a variety of different pressures from supple lighter movements to stronger more assertive movements not dissimilar to "deep tissue" massage. Tui Na is widely practiced throughout the Asian world and is becoming popular in the West due to its remarkable, even transformative results. Tui Na focuses its work along the Meridian lines ("energy rivers") and often ends up being effective for chronic spinal issues, joint issues and "old injuries". Developed and practiced over thousands of years, Tui Na uses the remarkable energies of the human and guided by the human mind/heart. The "goal" of Tui Na is to allow and encourage the body's innate wisdom and healing energies, thus bringing circulation, health and balance back to body, mind and spirit.

Facial Contouring 12 Hours

Using an acupressure facelift with points, facial cupping and essential oils encourages lymphatic drainage of the face and neck to create a contouring effect. This treatment is deeply relaxing and toning for the neck and face.

Flower Essences 6 hours

In this introductory class, learn the subtle healing power of flower essences. Flower essences are the blossoms of plants prepared from a sun infusion in a bowl of water, then further diluted, potentized, and then preserved with brandy, there is no scent. These preparations embody the distinct imprint, or energetic pattern of each flower species. In holistic healing flower essence therapy is categorized under vibrational medicine. Ill health (physical imbalances and dis-eases) results when we are in imbalance or when we lose our awareness, are disassociated from others, or disconnected from our life purpose. The living forces of nature collected from the blooms of our flowering plants, prepared, and placed in liquid stock. and dosage bottles are used in healing our physical, etheric, astral, and spiritual bodies.

Incorporating stones can extend a body workers lifespan, and they are perfect to warm and smooth your client's achy muscles.

Lomi Lomi Style Hawaiian Massage 12 Hours

Lomi lomi is an ancient Hawaiian concept of working with the *mana* (life force) of the body, mind, and soul of an individual. To obtain the level of immediate and long-term healing necessary, the practitioner uses a multitude of techniques. Their ability to communicate deep "into the bones" via the muscles and soft tissues is important because it is at this level that all memory is stored from past traumas, injuries, or emotional links. As in many indigenous cultures, the bones are the most important and protected part of the physical structure, and the energetics of the individual. This is a massage technique that was passed down from family members and elders consisting of tuning into the clients body to promote healing and a sense of well-being using a lot of long, flowing forearm techniques.

Lymphatic Drainage12Hours
