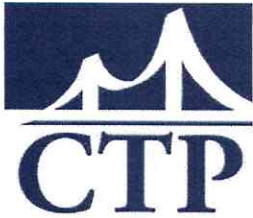

STUDENT'S RIGHT TO CANCEL

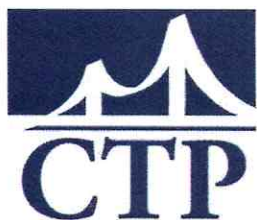
