# Program Overview

## Ayurvedic Wellness Practitioner (AWP) - 1000 Hour Certification Program

The Ayurvedic Wellness Practitioner (AWP) program is based on the second goal of Ayurveda— *Aaturasya Vikara Prashamanam* (Disease management). At this level, the emphasis is on gaining a deeper understanding of the disease process and management techniques at its various stages. Students will gain a deeper understanding of Ayurvedic concepts and techniques. **Upon successful completion of the AWP Course you will be awarded an Ayurvedic Wellness Practitioner Certificate.**

### General Format

- 1 Year – 1,000 Total Hours
- 10 Weekend Intensives – In-Class or Live Streamed\*
- 50 Weekly Virtual Classes – Live Streamed\*
- Online Recorded Lectures, Projects & Independent Review\*\*
- Clinical Internship – In-Class

\*Weekend Intensives & Weekly Virtual Classes are all live streamed and recorded for later viewing.

\*\*Internet connection required.

KAA accepts a limited number of students for in-class attendance in Milpitas, CA: up to 30.

### Prerequisites

The prerequisites for admission to the AWP program are:

- Completion of the Ayurvedic Wellness Counselor (AWC) or an equivalent program. AWC graduates can enter the AWP program directly. Students who have completed a program equivalent to the AWC from other institutions will be required to undergo an interview process to determine their competency in Ayurvedic principles and practices.
- It is important for Ayurvedic students of professional programs to have adequate knowledge of Anatomy and Physiology (A&P). The equivalent of 6 college level Anatomy & Physiology credits are required. It's not required to complete the A&P course prior to enrollment in this course; it can be taken simultaneously as a corequisite, as long as it is completed for certification. If you need to satisfy the A&P corequisite, we offer a partner course you can take entirely online. Students are required to provide proof of A&P course completion to receive this certification. ## Scope of Practice

With this certificate, students gain the skills and knowledge to assess the Ayurvedic constitution and imbalances in a client and suggest food, lifestyle changes and recommend Ayurvedic herbs, spices and Ayurvedic herbal supplements based on the Samprapti/imbalances. However, the practice of these may vary from state to state. Please check the regulations with the state in which you practice.

### **Ayurvedic Practitioners can:**

- Analyze Body Constitution
- Do history taking
- Assess the imbalances of Agni, Dosha, and Strotases based on the Ayurvedic Principles
- Suggest food and lifestyle changes based on the Ayurvedic Constitution (Prakriti) and various imbalances in the mind/body systems (Vikriti)
- Suggest Ayurvedic herbs, spices and Ayurvedic herbal supplements based on the Ayurvedic Constitution (Prakriti) and various imbalances in the mind/body systems (Vikriti)
- Suggest Ayurvedic bodywork techniques based on the Ayurvedic Constitution (Prakriti) and various imbalances in the mind/body systems (Vikriti)
- Explain about Ayurvedic concepts (related to Prakriti, Vikriti, qualities etc)
- Explain the connection between Body and Mind and how diet and lifestyle, meditation, Pranayama, Ayurvedic herbs, Ayurvedic bodywork techniques and Yoga can help manage many physical, mental and emotional problems
- Offer talks/write articles on various concepts on Ayurveda
- Offer simple Ayurvedic bodywork techniques based on the Ayurvedic Constitution (Prakriti) and various imbalances in the mind/body systems (Vikriti)
- Offer cooking classes giving simple cooking tips

### **Ayurvedic Practitioners cannot:**

- Diagnose diseases medically
- Treat diseases medically
- Prescribe medical treatments or medicines
- Perform Panchakarma (unless allowed in your scope of practice under other licensing)

## Course Description & Objectives

The Ayurvedic Wellness Practitioner certification program covers both theoretical and practical training, including is a blend of online learning, in-class hands-on training experience, clinical encounters and independent assignments. Classroom sessions consist of 10 in-class & live streamed weekend intensive modules, 50 live streamed weekly evening sessions, 200 hours of clinical internship with multiple format options, supplemented by online recorded lectures on our elearning system and assignments.

This AWP course is a blend of Online Learning, In-Class Practical Training experience and Clinical Encounters to ensure proper theoretical and practical/hands-on training.

### *Learning Materials & Resources*

- **Course manuals:** print versions and PDFs.
- **Elearning:** learn anytime, anywhere, at your own convenience on your own computer. Our AWP certification program content is made available to students online via our elearning system powered by TalentLMS. Elearning provides access to course information, live class recordings, assignments, online recorded lectures, course manuals, class slides, study guides and tests.

→ **Mentoring:** each student is provided a mentor for the program who will be available to answer questions via message within our elearning system. The mentor will also work with the student on designated portions of the Independent Assignments.

## Curriculum

### KAA 201 | Advanced Anatomy, Physiology & Basic Principles (*Dosha Dhatu Mala Vigyan*)

Includes an in-depth discussion of the *Doshas*, *Subdoshas*, *Dhatu*s, *Malas*, and *Agni*. Greater emphasis is placed on the *Srotas*, *Kalas* and *Marmas*. This course also includes a deep exploration of the basic principles directly from the scriptures such as the *Soothrasthana* of *Ashtanga Hridayam*.

### KAA 202 | Pathophysiology & Ayurvedic Diagnostic Methods (*Advanced Nidan & Rogi Pariksha*)

Includes a detailed exploration of the five stages of disease identification: *Nidan*, *Purvaroop*, *Roopa*, *Upashaya*, and *Samprapti*. This course also looks at the six stages of the disease process: *Sanchaya*, *Prakopa*, *Prasara*, *Sthanasamshraya*, *Vyakti* and *Bheda*. Students will gain an understanding of the signs of *Dhatu* and *Srota Dushti*. Students will delve deeply into threefold client examination: *Darshana*, *Sparshana*, and *Prashana*, as well as the eight-fold clinical evaluation: Pulse, Tongue, Voice, Physical Stature, Vision, Skin, Urine, and Bowel.

### KAA 203 | Advanced Herbology & Ayurvedic Pharmaceutics (*Dravya Guna & Bhaishajya Kalpana*)

Expands upon the principles of Ayurvedic herbal energetics, actions, uses and preparations with over thirty additional herbs. Other topics include the preparation of popular Ayurvedic formulations and their clinical application (pills, powders, oils, ghees, jams, etc.), times of administration and *Anupanas*. Other topics include measurements and dosage of Ayurvedic herbs and formulations.

### KAA 204 | Advanced Bodywork, Detoxification & Rasayana (*Panchakarma & Rasayana*)

Advanced Bodywork, Detoxification and *Rasayana* is a hands-on course. A detailed theory of Panchakarma will be covered, including the *Poorvakarma* (Preparation), *Pradhanakarma* (Main Procedure) and *Paschatkarma* (Post-Procedural Convalescence). The preparatory procedures including, various types of *Snehana* & *Swedana* therapies including *Abhyanga*, *Chooranasweda*, *Patrapotala Sweda*, *Njavarakizhi*, *Pizhichil*, *Kateevasthy*, *Nethratharpanam*, *Lepam*, *Pichu*, etc. This course also includes the five-fold Ayurvedic Detoxification procedures such as *Vamana*, *Virechana*, *Anuvasana*, *Niroohavasthy* and *Nasya*. The post Panchakarma convalescence like specific food and lifestyle modification is also a part of this course. This course also covers various aspects of *Rasayana* – the anti-ageing modalities of Ayurveda.

### KAA 205 | Kayachikitsa I: Management of Digestive System & Metabolic Disorders

Includes the Ayurvedic etiology, pathogenesis, symptoms, signs, detailed herbal treatments and dietary and lifestyle changes for several digestive and metabolic disorders such as Stomatitis, GERD, Hyperacidity, Ulcers, Diarrhea, IBS, Hepatitis, Fatty Liver, Ulcerative Colitis, Gallbladder Stones, Diabetes, Obesity, High Cholesterol, Anemia and Thyroid problems.

## KAA 206 | Kayachikitsa II: Management of Nervous System & Musculoskeletal Disorders

Includes the Ayurvedic etiology, pathogenesis, symptoms, signs, detailed herbal treatments and dietary and lifestyle changes for several nervous system and musculoskeletal disorders such as Multiple Sclerosis, Hemiplegia, Parkinson's Disease, Motor Neuron Disease, Rheumatoid Arthritis, Osteo-arthritis, Gout, Osteoporosis, Sciatica, Fibromyalgia, Muscular Dystrophy, Low back Pain, Spondylitis, Avascular Necrosis. This course also includes fracture management and bandages.

## KAA 207 | Kayachikitsa III: Management of Respiratory System & Cardiovascular System Disorders

Includes the Ayurvedic etiology, pathogenesis, symptoms, signs, detailed herbal treatments and dietary and lifestyle changes for several respiratory, circulatory and cardiac disorders such as Allergic Rhinitis, Asthma, Cough, COPD, Sleep Apnea, Hypertension, Coronary Artery Disease, DVT, Migraine and Varicose Veins.

## KAA 208 | Kayachikitsa IV: Management of Skin, Special Senses & Mental Disorders

Includes the Ayurvedic etiology, pathogenesis, symptoms, signs, detailed herbal treatments and dietary and lifestyle changes for several skin disorders, diseases of sense organs and mental disorders such as Eczema, Psoriasis, Acne, Rosacea, Herpes, Atopic Dermatitis, Cataract, Macular Degeneration, Stye, Myopia, Otitis, Meniere's Disease, Nasal Polyp, Anxiety, Depression, Insomnia, Schizophrenia, ADHD, Alzheimer's Disease, Autism, Addiction and Dementia.

## KAA 209 | Kayachikitsa V: Management of Reproductive & Excretory System Disorders, Gynecology & Pediatrics

Includes the Ayurvedic etiology, pathogenesis, symptoms, signs, detailed herbal treatments and dietary and lifestyle changes for several female and male reproductive system disorders such as Amenorrhea, Menorrhagia, Dysmenorrhea, PMS, Menopausal syndrome, Endometriosis, PCOD, Yeast Infection, Erectile Dysfunction, Prostate Enlargement, Impotency, Urinary Stones, UTI, Hemorrhoids, Anal Fissures, Fistula-in-Ano, Infertility, Ante-Natal Care and Post-Natal Care. This course also covers a general outline of child care and management of pediatric conditions.

## KAA 210 | Clinical In-Class Internship (80 Hours)

40 hours of internship is included in the 10 sessions of the 2 day monthly in-class learning experience. Another 40 hours of internship with one-on-one consultation is included as a clinical internship project. Students will evaluate clients in the following areas: Potential treatments, dietary and lifestyle recommendations, Ayurvedic herbal formula recommendations, daily routines and seasonal changes.

## Program Format & Hours

### *Student Orientation - 2 hours*

Students will be required to attend a live streamed **2-hour orientation** prior to the class start date. It is recorded for later viewing.

## *Special Projects – 80 Hours*

### **Community Health Education Assignment (30 Hours)**

Students will prepare a total of two (2) presentations for a group in the community. They may organize this presentation themselves and invite the public or arrange to deliver this presentation at an office, school or other place of business. Each presentation should run two hours in length and be delivered on a topic of interest to the group. This topic may be related to their Research Project or Paper but may not substitute for time spent completing the research paper or project and vice versa. The student may also select to do their research paper or project on the outcome and experience of their presentations.

Approximately 13 hours of preparation should go into each presentation's preparation and planning, for a total of 26 hours of planning and 4 hours (2 hour each for both presentations) of uninterrupted delivery (i.e. the student is the main presenter and speaker).

The student must notify Kerala Ayurveda of each of their presentations at least two weeks (14 days) ahead of time.

### **Research Paper/Research Project (50 Hours)**

Research Paper or Project, as follows:

1. A comprehensive **Research Paper**, 15 to 20 pages in length, on a topic of interest to you that is first approved by the Academic Director.
2. A detailed **Research Project** on a topic and format approved by the AWP Mentor.

## Mentor Program

Students have access to an Ayurvedic doctor (BAMS) mentor who can be contacted via the elearning system to review and grade assignments, and are also available to assist with questions during studies.

## Tests & Grading

- Each month there will be a test on the material taught.
- Tests are multiple choice. Each test is worth 5% of the total grade. Minimum passing grade is 70%.
- Students must complete 9 out of 9 tests before they are eligible for graduation.
- All testing is conducted online through our elearning system and grades are immediately available in the student online account. Project/assignment grades are posted within 10 days of submission.
- A student who does not achieve the minimum passing grade of 70% for graduation may retake the tests up to five times. The highest score will be recorded.

## Completion Requirements

- The student paid the full tuition for the program.
- The student submitted documentation of completing equivalent of 6 credits of college level Anatomy & Physiology course.
- The student passed all tests with a minimum grade of 70%.
- The student completed and passed all assignments (graded as pass/fail).
- The student completed the 200 hour Clinical Internship.
- This program meets the NAMA (National Ayurvedic Medical Association) requirement to register at the Ayurvedic Health Counselor category of professional membership. Contact hours is the time spent in classroom instruction (including live streaming class time) and time spent with rogis (clients). The total available contact hours in this program are 515. We require minimum 400 contact hours of live class attendance to graduate, though we recommend all available contact hours of live class attendance to support your competency and material comprehension. We encourage students who miss live classes to attend the following class the next time it is offered (in approximately six months), to provide the opportunity for faculty interaction.

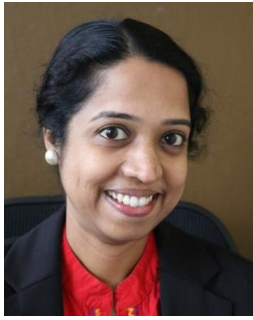

## Refund Policy

### *State of California*

The registration and manual fee is nonrefundable. The student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. There will be no refund if the student decides to withdraw after 60% of the classes (attendance of the 7<sup>th</sup> class) or online modules (accessed 7<sup>th</sup> online module).

Each In-Class Intensives covers the content of one online modules. Refund Requests will be processed based on In-Class Intensives and online modules accessed (whichever is greater).

A written notice from the students, about the cancellation will be required. A telephone call about cancellation or absenteeism for the classes will not be considered as true cancellation. In such cases, student will not receive the refund for that period. The refund will be processed within 30 days from the day KAA receives the official written notice of cancellation from the student. The refund check will be mailed to the official address of the student. If original payment is by credit card the refund will be processed on the credit card.

Eligible refunds will not include the applicable interest during the enrollment period.

In case the student decides to withdraw during the program, before the 60% of the classes are over, the following will be the refund calculation:

#### **Refund Calculation**

- Step 1 Deduct \$350 (registration/manual fee) from the total tuition paid
- Step 2 Divide the total tuition paid by 10 (number of modules) = 'tuition per module'
- Step 3 Multiply number of classes attended or modules accessed in elearning by 'tuition per module'
- Step 4 Subtract the amount in step 3 from the amount in step 1. This is the refund amount.

**Example:** if the student decides to withdraw after completing 4 In-Class Intensives or live streaming and if he/she has paid the full tuition, the refund will be as follows:

**Refunds** will be issued within 30 days of the date of student notification, or date of school determination (withdrawn due to absences or other criteria as specified in the school catalog), or in the case of a student not returning from an authorized Leave of Absence (LOA), within 30 days of the date the student was scheduled to return from the LOA and did not return.

## State of Washington

**Five-Day Cancellation:** An applicant who provides written notice of cancellation within five days (excluding Saturday, Sunday and federal and state holidays) of signing an enrollment agreement is entitled to a refund of all tuition paid. No later than 30 days after receiving the notice of cancellation, the school shall provide a 100% refund of tuition and fees paid.

**Other Cancellations:** An applicant requesting cancellation more than five days after signing an enrollment agreement and making an initial payment, but prior to entering the school, is entitled to a refund of all monies paid (*minus the registration fee of \$100*).

**Rejection:** An applicant rejected by the school is entitled to a refund of all monies paid.

### Refund Policy Defined - WA

1. The school must refund all money paid if the applicant is not accepted. This includes instances where a starting class is canceled by the school. The school must refund all money paid if the applicant cancels within five business days (excluding Sundays and holidays) after the day the contract is signed or an initial payment is made, as long as the applicant has not begun training.
2. The school may retain an established registration fee equal to ten percent of the total tuition cost, or \$100, whichever is less, if the applicant cancels after the fifth business day after signing the contract or making an initial payment. A "registration fee" is any fee charged by a school to process student applications and establish a student record system.

4. When calculating refunds, the official date of a student's termination is the last day of recorded attendance:
  - a. When the school receives notice of the student's intention to discontinue the training program; or,
  - b. When the student is terminated for a violation of a published school policy which provides for termination; or,
  - c. When a student, without notice, fails to attend 2 consecutive In-Class Intensives or, fails to access online modules for ninety calendar days.
5. All refunds must be paid within thirty calendar days of receiving a completed and signed Kerala Ayurveda official refund request form and the student's official termination date.
6. Eligible refunds will not include the applicable interest during the enrollment period.

## Distance Learning

No later than 30 days after receiving the notice of cancellation, the school shall provide a 100% refund of tuition and fees paid.

1. The school may retain an established registration fee equal to fifteen percent of the total tuition cost, or \$150, whichever is less, if the applicant cancels after the fifth business day after signing the contract or making an initial payment. ## Attendance Policy

This program meets the NAMA (National Ayurvedic Medical Association) requirement to register as the Ayurvedic Practitioner category of professional membership, and the minimum contact hours required is 400 hours of live class attendance to graduate. Contact hours is the time spent in classroom instruction (including live streaming class time) The total available contact hours in this program are 475. KAA recommends attending all of these hours to support your competency and material comprehension, and encourages students who miss live classes to attend the following class the next time it is offered (in approximately six months) to provide the opportunity for faculty interaction.





## Make-up and Retake Policy

If student is absent from an in-class or live broadcast session, he/she may make it up at any KAA training location or via live broadcast, free of charge. If a student wishes to retake an in-class session, he/she may do so for a fee of \$100 per weekend session. ## Conduct

At KAA, programs are directed toward professional training. The students shall show respect to others and observe correct standards of conduct. The Honor System embodies values of personal integrity, honesty, and trust.

Fundamental to the Honor System is the Honor Code of Responsibility, and it is upon its principles that the Academy has based the Standards of Conduct.

### Honor Code of Responsibility

- Each member is responsible for maintaining a high level of civility, integrity, honesty, and trust within the community.
- Each student is responsible for presenting work of her/his own creation, and refraining from representing as her/his own work that which is not hers/his.
- Conduct in keeping with the attendance policies.

Nothing in the policy prevents the student from contacting the Washington Workforce Board at 360-709-4600 at any time with a concern or complaint.

## Termination Policy

1. If the course is terminated after the student begins classes, the Academy may retain a percentage of the total tuition as described in the table below.
2. The official date of termination of a student shall be the last date of recorded attendance when withdrawal occurs in any of the following manners:
  - a. When the student is terminated for a violation of a published Academy policy which provides for termination; or,
  - b. When a student, without notice, either fails to attend classes or check out course videos for thirty (30) calendar days.
3. A student will be determined to be withdrawn from the institution if the student has not attended any class for three consecutive class weekends. He/she will be notified by telephone after two missed weekends and he/she will be drafted after the third weekend.
4. For a student who is on authorized Leave of Absence, the withdrawal date is the date the student was scheduled to return from Leave and failed to do so.

## Suspension and Dismissal Policy

There are disciplinary guidelines to provide an environment to learn and grow independently, which give students rights and responsibilities.

- Any behavior disruptive to other students or the smooth running of the class will not be allowed.
- Students will have to pay the tuition on time.
- Students have to maintain a passing grade of 70%.

At first incidence, warning will be given. At the second incidence, the student will be suspended for the entire weekend. Student will be readmitted after suspended weekend. If the behavior persists, the

student will be dismissed from the program. When the conduct of the student threatens the other student's safety, KA reserves the right to dismiss a student immediately.

## Leave of Absence

Students can take a leave of absence for up to one (1) year with written permission. School may be contacted at +1 (888) 275-9103 or by mail at 691 S. Milpitas Blvd Suite 206 Milpitas, CA 95035. The student may resume classes the following year at the level where he/she took leave. Unless prior arrangements are made with the school about the payment, student is obligated to pay the tuition as per plan.

## Financial Aid

Kerala Ayurveda Academy does not offer state or federal financial aid to students. If a student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student has received federal student financial aid funds, the student is entitled to a refund of the moneys not paid from federal student financial aid program funds.

If a student is eligible for a loan guaranteed by the federal or state government and the student defaults on the loan, both of the following may occur:

- The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
- The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid.

**"Notice** - Any holder of this consumer credit contract is subject to all claims and defenses that the debtor could assert against the seller of the goods or services obtained pursuant hereto or with the proceeds hereof, recovery hereunder by the debtor shall not exceed amounts paid by the debtor hereunder."

"Kerala Ayurveda Academy does not have a pending petition in bankruptcy, is not operating as a debtor in possession, has not filed a petition within the preceding five years, and has not had a petition in bankruptcy filed against it within the preceding five years that resulted in reorganization under Chapter 11 of the United States Bankruptcy Code (11U.S.C. Sec. 1101 et seq.)."

## Student Tuition Recovery Fund (STRF) fee (non-refundable) – *State of California*

"Effective January 1, 2015, the Student Tuition Recovery Fund (STRF) assessment rate will be zero (\$0) per \$1,000. Therefore, all institutions required to collect STRF assessments must stop collecting STRF assessments from students."

"You must pay the state-imposed assessment for the Student Tuition Recovery Fund (STRF) if all of the following applies to you:

1. You are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition either by cash, guaranteed student loans, or personal loans, and
2. Your total charges are not paid by any third-party payer such as an employer, government program or other payer unless you have a separate agreement to repay the third party.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if either of the following applies:

1. You are not a California resident, or are not enrolled in a residency program, or
2. Your total charges are paid by a third party, such as an employer, government program or other payer, and you have no separate agreement to repay the third party."

"The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

"It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.”

# FAQ

## Frequently Asked Questions

- 1. How much does the program cost?** The tuition for the AWP Course is \$6,800.00 (*not including registration or management fee*). Required Internships are an additional cost. (See Tuition & Fees for details.)
- 2. Do I need a college degree or a prior license/certification to study Ayurveda at the Practitioner level?**
  - A college degree is not required, nor are prior licenses or certifications in any field other than Ayurveda. KAA welcomes students from all educational backgrounds, with degrees, licenses or certifications in any field.
  - A Level I Ayurvedic Wellness Counselor Certification or equivalent is required.
- 3. I'm not a health care professional; can I still earn a certificate and practice Ayurvedic medicine?** The primary prerequisite for the AWC program is a passion for Ayurveda. KAA welcomes students with a bachelor's degree in any field. The minimum admission requirement is a high school diploma and, Basic Anatomy and Physiology. If you have not taken Anatomy and Physiology, you can finish the requirement within six (6) months of your start date. Kerala Ayurveda also offers an Anatomy & Physiology course. Inquire with Student Services for more information.
- 4. Is it legal to practice Ayurveda in all fifty states?** A bill has been passed in ten states (California, Nevada, Minnesota, Oklahoma, Idaho, Louisiana, Rhode Island, Arizona, Colorado, and New Mexico) allowing the residents of those states to approach the non-licensed healing practitioners with informed consent.
- 5. Does each state regulate the practice of Ayurvedic sciences? No.**
  - Ayurvedic practitioners are not licensed in the United States, and its practice is not regulated by state or federal agencies. Standards of competency are set by individual schools that have received state approval. Ayurvedic practitioners in the United States are advised on how to practice legally within a limited scope of practice so they are not viewed as practicing medicine without a license.
  - We might say that Ayurveda's current status in the U.S. is analogous to the Chinese medical profession during its early years in the 1970s. While each state does not regulate the practice of Ayurvedic medicine itself, some aspects of Ayurvedic practice may fall within the scope of professions that are regulated. Students and graduates of the academy should be careful not to allow their practice to overlap one of those regulated professions unless they are licensed in that particular profession. Please contact your local state representative for more information about regulations in your area.
- 6. Can I practice Ayurveda outside of the state where I receive my certification?**
  - Yes, Ayurveda is currently practiced all over the United States.
  - While none of the U.S. states currently have Ayurvedic practitioners or physicians as primary care physicians, many of these well-trained professionals utilize their education and skills in combination with other health care related credentials.
  - Yoga Instructors, Massage Therapists, Registered Nurses, Nutritionists/Dietitians, Acupuncturists, Chiropractors, Medical Doctors and other health care professionals are recognizing and utilizing the benefits of educational training in Ayurveda.
  - NAMA is currently working on developing educational standards, scope of practice, and related materials to support future licensing initiatives throughout the US.

- Many Academy graduates use their Ayurvedic education to enhance pre-existing professional careers.
- 7. Is there an Ayurvedic association which links other practitioners and students together?** Yes, there is the National Ayurvedic Medical Association (NAMA). Many states have their own state associations, such as the California Association of Ayurvedic Medicine (CAAM).
- 8. Is there an alumni association? Can I contact previous students?** Yes, we can provide you with the contact information of several students for you to talk to. KAA is soon to announce a supportive network of alumni services and information.
- 9. How many of your graduates practice Ayurvedic medicine?**
- All of our graduates are able to practice Ayurveda in their everyday lives for personal health. An understanding of Ayurvedic principles enriches the quality of life in all aspects, not just physical well-being. The study of Ayurveda is truly a healing transformation during which students find a new level of emotional, mental and spiritual wellness. Additionally, graduates often change career paths or discover novel ways to apply their new Ayurvedic knowledge to their existing profession.
- There are many ways our students utilize their Ayurvedic education. Some of our students launch a practice as Ayurvedic Counselors or Practitioners.
- Many of our graduates incorporate Ayurvedic knowledge in their current practice as healers, such as physicians, nurses, yoga teachers and massage therapists. Ayurveda complements all other healing modalities.
- Some of our graduates launch Ayurvedic product lines or combine Ayurveda with their existing business.
- 10. Are there tests? I feel anxious about taking tests.** Please try not feel anxious about the tests. The testing is done online and the student is given five (5) attempts at taking the test. This highest score is recorded. The tests are for you (and us) to know what you have learned and what you didn't so we can keep you up to speed. We want to make sure our students understand all the Ayurvedic concepts clearly. Ayurveda is about human health, so a clear understanding is vital.
- 11. I will be traveling from out of town to attend classes, is there housing assistance available?** KAA does not have dormitories. There are a few hotels near the campuses where students can book a room for the weekend. The range of cost is approx. \$75-\$125. In the past, some students have made good friends with classmates and stayed with them on those weekends. KAA has no responsibility to assist a student in finding housing.
- 12. When can I visit the school? Do you have open houses or visitor's events?** We allow our prospective students to sit in with the current class, so that they get a feel of the classroom setting and the topic. With a prior appointment, students are welcome to visit the academy and talk to the Academy Administrator. We are here to assist our students in any way we can.
- 13. What student services are provided?** Student mentoring is supported throughout the entire term of the program. On occasion, KAA posts job openings as they become available on group emails to students and alumni. KAA will do its best to help graduates to get into practice or a related career but there are no specific student services for career planning or job placement.
- 14. Do you offer further Ayurvedic Studies?** Our level III Ayurvedic Doctor (AD) program is available for level II AWP graduates who wish to further their study at the highest level of certification available in the U.S.
