If students are issued books or equipment and cancel their agreement for a program of instruction, the students are required to return the books or equipment within 30 days of the enrollment agreement being cancelled. A student who does not return the books or equipment, will be assessed a Computer and Sales Tax Fee. The total will not exceed \$395.00.
