STUDENT'S RIGHT TO CANCEL

The student has the right to withdraw from the program of instruction or cancel the enrollment agreement at any time and obtain a refund according to the following refund policy. Definitions

STUDENT'S RIGHT TO CANCEL

The student has the right to withdraw from the program of instruction or cancel the enrollment agreement at any time and obtain a refund according to the following refund policy.
