## **STUDENT’S RIGHT TO CANCEL**

The student has the right to cancel and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. The amount retained for the registration fee is zero dollars (\$0.00).

### Refund Information:
