Students Right To Cancel

The student has a right to cancel this enrollment agreement and obtain a refund. You may cancel this enrollment agreement and receive a refund by providing a written notice to the School Director at MTS TRAINING ACADEMY; 140 Yolano Drive, Vallejo, CA 94589. Students may cancel enrollment on the first day of class or the seventh day after enrollment; whichever is later. The effective dates are _____ or _____.

- A. An applicant not accepted by the School is entitled to a refund of all monies paid in advance.

- B. If a student cancels enrollment and requests a refund in writing on the first day of class or the seventh day after enrollment; whichever is later; the cost of tuition; less any applicable registration fees will be refunded within 30 days via school check. This policy applies regardless of whether or not the student has actually started training.

and determine the appropriate refund if applicable. Refunds are processed and disbursed from our accounting office within 30 days of processing via company check. Refunds are mailed to last address on file for student.

In addition, the student may withdraw from a course after instruction has started and receive a pro rata refund for the unused portion of the tuition and other refundable charges if the student has completed 60% or less of the instruction. **For example**, if the student completes only 20 hours of an 80-hour course and paid \$3600.00 tuition, the student would receive a refund of \$2700.00.
