### **STUDENT'S RIGHT TO CANCEL**

The student has the right to cancel the enrollment agreement for a program of instruction, without any penalty or obligation and obtain a refund of charges paid through attendance at the first class session (first day of classes), or the seventh day after enrollment (seven days from date when enrollment agreement was signed), whichever is later. After the end of the cancellation period, you also have the right to stop school at any time; and you have the right to receive a pro rata refund if you have completed 60 percent or less of the scheduled hours in your program through the last day of attendance.

**Cancellation:** The notice of cancellation shall be in writing and submitted directly to the Financial Aid Office.
