CANCELLATION POLICY

WITHDRAWAL OR TERMINATION AFTER START OF CLASS:

TUITION REFUNDS/MODIFICATION TO PAYMENT AGREEMENTS

Students have the option to pay in cash for the entire period of enrollment or agree to be financially obligated for the same period of enrollment by entering into a recurring payment agreement (to take advantage of long term pricing). The Period of Financial Obligation is the period for which the student is legally obligated to pay for the enrollment period to which it relates. The Period of Financial Obligation always equals the enrollment period and cannot exceed 12 months. Refunds or modifications to the recurring payment agreement may only be done as follows:

1. Tuition: Used weeks of tuition will be prorated according to the scaled price list and charged back to the student when any refund or modification to the recurring payment agreement is calculated.

Waived application fees will not be charged back to the student.

3. For students, whose last date of attendance occurs after the first four weeks but before or at the mid-point of their period of financial obligation, TALK will retain a prorated amount of tuition. For students whose last date of attendance occurs after the mid-point of their period of financial obligation, TALK will retain all of the charges for that period.
4. Subsequent Periods of Financial Obligation or Enrollment periods: For students who have completed the first period of financial obligation or extended their enrollment at the institution but whose last date of attendance occurs before or at the mid-point of any subsequent period of financial obligation, the institution may retain a prorated amount of tuition for that period. For students whose last date of attendance occurs after the mid-point of any subsequent period of financial obligation, the institution may retain all of the tuition for that period.

REFUND PAYMENT PROCEDURE

1. If an applicant never attends class or cancels prior to the course start date, all refunds due will be made within 45 days of the course start date or the date of cancellation, whichever is earlier;
2. For an enrolled student, the refund due will be calculated using the last date of attendance (LDA) and be paid within 45 days from the date of determination (DOD).

Date of Determination (DOD): The date: (1) the student gives notice of withdrawal to the institution, (2) the institution administratively withdraws the student; or (3) the date the institution terminates the student for cause.
