**Definitions**

**STUDENT’S RIGHT TO CANCEL**

The **student has the right to cancel** the enrollment agreement and obtain a refund of charges paid through attendance at the first class session (**first day of classes**), or the seventh day after enrollment (**seven days from date when enrollment agreement was signed: \_\_\_\_\_**), whichever is later.

**CANCELLATION:** The notice of cancellation shall be in writing and submitted directly to the Financial Aid Office, and that a withdrawal may be effectuated by the student’s written notice or by the student’s conduct, including, but not necessarily limited to, a student’s lack of attendance.

**CANCELLATION**

In accordance with the state of California, an institution shall refund 100% of the amount paid for institutional charge if notice of cancellation is made through attendance at the first class session, or the seventh class day after enrollment, whichever is later. Cancellation occurs when the student gives written notice of cancellation to the school at the address specified in the agreement. If the notice of cancellation is mailed, postage prepaid and properly addressed, then the notice of cancellation is effective on the date of the postmark, if the postmark falls within the cancellation period.
