**Objective:** This course is an online working studio class that is intended to teach students how to combine images and text skillfully. Through demonstrations and hands-on work, students will learn to solve visual problems using Adobe Photoshop, Illustrator, and InDesign.

Assignments and other projects will be assigned periodically to help support and supplement material covered in class lessons. There are six 48-hour modules in this course. Assignments and other projects will be assigned periodically to help support and supplement material covered in class lessons.

**Course/Program: COMPUTER SERVICES TECHNICIAN (English/Spanish)**

**Objective:** This program has been designed to prepare students in the field of computer repair, focusing on identification, installation, assembling, configuration, function, and computer operation. It involves the study of personal computer hardware and operating systems. This class is presented with both lecture and lab portions. Students are expected to attend all classes since hands-on lab-based work is essential. **Course/Program: ESL 3 ADVANCED LEVEL (English as a Second Language)**

**Objective:** ESL 3 Advance level start of the intermediate course. Students will learn more complex words, expressions, and grammar. With the basis of basic knowledge, they will be able to speak English using the comparison of simple past vs. present perfect and future tense. With the mixture of the grammar and expressions learned from the former level, this step introduces infinitives and gerunds. These are so widely used in all positions of the sentence, this level is significant for understanding the meaning of infinitives and gerunds, how to use them with the expressions that we've learned before. Also, this level introduces conditional sentences using if clauses.

Listening/Speaking: Can satisfy basic survival needs and very routine social demands. Understands simple learned phrases easily and some new simple phrases containing familiar vocabulary, spoken slowly with frequent repetition.

Reading/Writing: Can read and interpret simple material on familiar topics. Able to read and understand simple directions, schedules, signs, maps, and menus. Can fill out forms requiring necessary personal information and write short, simple notes and messages based on familiar situations.

The workbook is assigned after each module. Student progress is evaluated at the end of each month. To complete this course and receive a diploma, students must complete the workbook homework assignment and receive a grade of "C" or better. Students are expected to attend all classes since classroom participation communication is essential in the classroom.

## ADMISSION REQUIREMENTS AND PROCEDURES

### Administrative Examinations

All prospective students must possess a high school diploma or equivalent. If a student does not have a high school diploma or equivalent, they must take an **Ability-to-Benefit exam** before enrolling. Students admitted to a certificate program, shall possess a high school diploma or its equivalent, otherwise successfully take and pass the relevant examination, **Ability to Benefit Test, as required by section 94904 of the Educational Code.** An institution is required, prior to executing an enrollment agreement with a student, to have the student take and pass an independently administered examination. Our institution uses the CELSA; Combined English Language Skills Assessment Test. The minimal passing score is 97.

An admissions test will also be given to prospective students, by ABC Technical College, who want to take an online course. This will determine if they are fit for online education. The student will be asked different questions regarding their ability to use a computer.

### CELSA Admission Test

The College uses the Combined English Language Skills Assessment (CELSA) Form1 and Form2 which is published by Association of Classroom Teacher Testers (ACTT). The passing score on form 1 is 37 correct and the passing score on form 2 is 34. These equate to scaled scores of 97. This test will be administered by an independent agency. The school's admissions personnel will provide applicants with additional information as to how to arrange for the test. The students must take and pass the test prior to admissions. If you do not pass the exam, retesting is available after 15 days waiting period and the independent test agency will explain and provide you with the retesting procedures.

## **ACADEMIC POLICIES**

### **Maximum Time to Complete Program**

Students must finish their coursework in a timely basis and within the specified time given to end a program. If a student does not finish on a timely basis and wishes to continue, the student may submit a request to do so in writing. The determination of whether to grant the student's request to extend their program will be made at the school's discretion.

### **Grading system**

ABC Technical College uses a letter grading system. If a student receives a non-passing grade on an assignment, quiz, test or module, the student may be able to retake it. This is solely based on the discretion of the instructor. It is the responsibility of the student to request a retake. The progress and quality of a student's work are measured using a system of letter grades and grade percentages as shown below. Grades are based on the quality of work performed by the student.

### **Satisfactory Academic Progress**

ABC Technical College's instructors will advise students of their academic progress at the end of each module and recommend make-up work, quizzes, tests, and modules as necessary.

### **Attendance Requirements**

Students are highly encouraged to attend all class sessions. If a class is missed, it is the student's sole responsibility to obtain missed coursework.

### **Leave of Absence**

Any student who requests a leave of absence must submit in advance to the school Director a written request, supported by third-party documentation that is acceptable to the school Director. The student's written request must be dated and signed by the student and must specify the dates of the requested leave of absence and the reason for the vacation. The determination of whether to grant the students asked for a leave of absence will be made at the school's discretion and will be final and binding on the student. The student is responsible for contacting the appropriate faculty member(s) to arrange to make up the coursework missed by the student as a result of any granted leave of absence.

### **Graduation Requirements**

Students must complete the requirements classroom hours, quizzes, tests, and homework assignments, as applicable of a class or course to receive certificate. The grading standards are on a "A-F" grading policy whereby a grade point average (GPA) can be calculated. Students must receive a minimum of 70% on all tests or quizzes to pass the class. To be eligible for graduation a student must earn an overall grade point average of a "C" and above also fulfill the attendance policies.

### **Distance Education**

ABC Technical College offers distance education for specific programs to students anywhere in the United States who cannot physically attend any of our schools. We use methods such as GoToMeeting, Team Viewer and Google Classroom for visual and oral instruction. If you are enrolled in a distance education program where the instruction is not offered in real time, ABC College will transmit the first lesson and any materials to any student within 7 days after the school accepts the student for admission. Coursework and projects may be turned in online. Feedback, evaluations, and grades are provided on-line or via-phone to students or emails, up to but no more than three business days after the coursework was turned in.

**The approximate number of days that will elapse between the institution's receipt of student lessons, projects, or dissertations and the institution's mailing of its response or evaluation is 7 days.**

### **Distance Education Disclaimer**

As part of the online training program, ABC Technical College utilizes the services of Team Viewer and GoToMeeting as the primary application for sharing screens between instructor and student during class time. With this application, the instructor may request access to the student's computer screen, and the student may grant permission by clicking "confirm" in the Requesting Form for screen sharing to occur. ABC Technical College also uses and installs Team Viewer into each student's computer.

As long as Team Viewer is enabled on the student's computer, the instructor may access the student's computer unannounced. The request to access Team Viewer is *verbal*. These programs are to be used only during class and when providing technical support to the student.

It is the student's sole responsibility to uninstall these programs at the end of your course. Once uninstalled, ABC Technical College will no longer have access to the student's computer.

### **Program Changes**

ABC Technical College reserves the right to make any program or curriculum changes at any time. However, we will work with students who wish to continue instruction with our school in other programs if the original desired program is no longer available. We will make every effort to provide such changes in advance to our students to allow them to make accommodations for differentiated instruction.

### **Language of Instruction**

Classes are conducted in both English and Spanish. For the specific language of instruction for each program, please refer to the schedule of classes.

## **FINANCIAL INFORMATION**

### **Financial Aid/Vouchers/Student Tuition Recovery Fund**

Students who wish to enroll in any of our courses must present a voucher issued by their issuing insurance company as proof of financial responsibility. Upon verification, ABC Technical College will decide at its discretion the admittance of such student into a program.

We also accept students who wish to enroll in any of our programs have an insurance issued voucher, and wish to pay the tuition themselves using cash, guaranteed student loans, or personal loans. **ABC Technical College does not participate in federal and state financial aid programs.**

If a student obtains a loan to pay for an educational program, the student will have the responsibility the repay the full amount of the loan plus interest, less the amount of any refund. If the student has received federal student financial aid funds, the student is entitled to a refund of the money not paid from federal financial aid funds.

### **Student Tuition Recovery Fund Disclosures (STRF)**

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition. You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

The Student Tuition Recovery Fund (STRF) assessment rate has changed from zero (\$0) per one thousand dollars (\$1000) of institutional charges to fifty cents (\$.50) per one thousand dollars (\$1000) of institutional charges. Effective February 8, 2021, all institutions will be required to collect STRF assessments.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, **1747 North Market Blvd. Ste. 225, Sacramento, CA 95834, [www.bppe.ca.gov](http://www.bppe.ca.gov), toll-free telephone number (888) 370-7589 or by fax (916) 263-1897.**

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 days period before the closure of the institution or location of the institution or were enrolled in an educational program within the 120 days period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.

6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollecting may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

### **Cancellation and Withdrawal Policies**

The student's right to cancel the enrollment agreement and withdraw from ABC Technical College is subject to the following terms and conditions:

#### **Cancellation and withdrawal must be in writing.**

**Students are considered enrolled until written notice is received by the school.** No other form of cancellation notice will be accepted. Dropping out of a course/program will not be considered as a form of enrollment cancellation or early training termination until written notice is received.

The student has the right to cancel the agreement and receive a refund before the first lesson has been taught and before materials are shipped.

Cancellation is effective on the date written notice is received by ABC Technical College. A student has the right to cancel the enrollment agreement and obtain a refund through attendance at the first-class session or the seventh day after enrollment, whichever is later, minus non-refundable charges, if written notice of cancellation or withdrawal is provided to the school.

If the school sent the first lesson and materials before an effective cancellation notice was received, the school should make a refund within 45 days after receipt of student's unused materials by the school, if returnable. Cancellation shall occur only when you give notice of cancellation or withdrawal to the school by mail or hand delivery. Written notice of cancellation or withdrawal sent by mail must be mailed to 11100 Valley Blvd. Ste #300., El Monte, CA 91731, and is active on the date is written notice is sent. You should keep a record of the date, time and place of mailing of the notice of cancellation or withdrawal.

You will be provided with one of the school's "Notice of Cancellation" form which you may use to cancel your enrollment from the school. However, the written notice of cancellation need not take any particular form; however, expressed in writing, is effective if it's signed and dated, and it indicates that you no longer desire to be bound by the enrollment agreement or attend class.

Students are obligated to pay only for educational services rendered, including fees associated with those services and non-refundable charges. A student may withdraw from a course after instruction has started and received a prorated refund. If you decide to withdraw from a program/course which has already started and the period allotted for cancellation has expired, in order to receive a refund minus non-refundable charges and the cancellation fee, you will be charged for the following: tuition charges depending on the number of training hours already provided by the School, cost of non-returnable equipment/software, other non-refundable charges, and any other applicable fees.

A student's prorated refund will be calculated by taking the total the student has paid, less the sum of non-refundable fees plus the cost of any services provided plus the documented cost of equipment plus the product of the rate of instruction multiplied by the number of hours the student attended. The rate of instruction will be the quotient of dividing the total tuition contracted by the total number of clock hours contracted.

## Refund Policy

**NOTICE:** If any fees were paid thru a third party such as an insurance company, the refund would be forwarded to such third party. If the student has paid with cash, guaranteed student loans, or personal loans, the refund will be forwarded to the student.

All refunds will be forwarded within 30 days, but no more than 45 days, from the date the school receives your cancellation notice. We will forward you and your insurance company any documents and agreements provided by you during your enrollment.

To receive a full refund of the money paid, minus any non-refundable charges and a cancellation fee, the cancellation notice must be in writing and received within the period mentioned above in the cancellation/withdrawal policy section. The form must be signed and dated.

If the student is eligible to pay the Student Tuition Recovery Fund fee, the total amount of \$3,521.00 is rounded to \$3,000.00 multiplied by .0, which equals to \$0, an amount that will be added to the total amount due. This charge is collected at the time of registration, if applicable to the student, and it is a non-refundable charge. Therefore, the total amount owed to the school will be:

The above example is a guideline to help the Student and the School determine the amount owed to the School and the amount of the refund returnable to the Insurance Company, under the terms and conditions provided in this agreement.

**NOTE:** If the school has transmitted the student the balance of the material as the student has requested, the school will provide the other educational services it agreed to provide, such as responses to student inquiries, student, and faculty interaction, and evaluation and comment on lessons submitted by the student, but it will not be obligated to pay any refund after all of the lessons and material are transmitted.

## **STUDENT CODE OF CONDUCT**

### **On-Line Course Conduct**

It is essential that students are respectful towards their instructor and classmates. Student's behavior must not interfere with nor disrupt class activities. Students are expected to conduct themselves in a professional and business-like manner. Therefore, students must adhere to the following rules:

1. Students should log-in on time and remain in class until dismissed by the instructor
2. Students should help maintain a quiet and orderly class environment by keeping their microphone **muted** when not in use.
3. Laptop, headset, mouse, and other equipment should be appropriately maintained for class use only and not be used by anyone else other than the student.
4. Disruptive and disrespectful behavior toward the instructor or other students will not be tolerated and may be legitimate grounds for dismissal from class.

### **Anti-harassment Policy**

ABC Technical College is committed to providing a learning environment free of unlawful harassment and will take all reasonable steps to prevent such from occurring. ## **Probation Policy**

Students are encouraged to complete the programs within the allotted time to graduate. However, if a student falls behind in the coursework, we offer academic assistance as specified in the Student Services section of this catalog. When a student is unable to complete a module or a program, the student is placed under academic probation and given an opportunity to make-up the coursework and re-take missed or failed tests at a later time or whenever these are offered again (subject to availability).

The number of times a student is allowed to re-take tests, a module, or a program, as well as the time allowed for this, is at the discretion of the instructor and the school's President. Our goal is that every student graduate from the assigned program.

A student may also be placed under probation for engaging in prohibited conduct. At the discretion of the school's President, a student's probation will be revoked once the issue has been resolved.

## **Grounds for Disciplinary Action**

ABC Technical College reserves the right, in the exercise of their judgment, to dismiss a student on any of the following grounds, including, but not limited to:

1. Failure to pay tuition
2. Engaging in discriminatory or abusive behavior
3. Reckless or disorderly conduct that negatively affects the classroom setting

Disciplinary action may include but is not limited to, a verbal or written warning, probation, suspension, or dismissal. The order in which they are applied and what type of disciplinary action is taken is at the discretion of the school's President.

## **STUDENT SERVICES**

### **Academic Assistance**

ABC Technical College offers academic assistance based on staff availability and is subject to change without prior notice. We offer Technical Support and Basic Introductory Classes to students.

- **Technical Support is available Monday-Friday between 8:30 am -5:30 pm**
- **The Basic Introductory Classes are taught as follow:**
  - 9:00 a.m. – 10:00 a.m. & 5:00 p.m. – 6 p.m. (English)
  - 9:00 a.m. – 10:00 a.m. & 5:00 p.m. – 6 p.m. (Spanish)

The Basic Introductory Classes are designed to prepare students with little or no prior computer knowledge before beginning their course.

### **Placement Assistance**

ABC Technical College is not permitted by law to make a guarantee of placement. However, ABC School emphasizes placement efforts for each qualified graduate complete the course with diploma. Job placement assistance is not provided to students who enroll in single modules or sections of any program. Prior to graduation students will meet with placement department for assistance with the following:

- Resume Preparation
- Job Seeking Skills Counseling
- Job Leads online and Magazines
- Job Interviews.

### **Students with Disabilities**

At ABC Technical College, we are committed to providing reasonable accommodations for students with disabilities. Students seeking academic accommodations due to a disability should request at the time of enrollment, or to the program instructor before or during the 1<sup>st</sup> week of class attendance.

To further assist students who are unable to physically attend classes at our school, we also offer to record class sessions, which they can review at home. Most of our programs can be taught live via-internet, and students can receive instant feedback.

We will make every effort to deliver the instruction to students with disabilities. However, we cannot guarantee that every case will have the desired outcome regarding expected accommodations.

### **Housing Assistance**

ABC Technical College does not have dormitory facilities available to students, that are under our control. The school doesn't assist students in finding housing. However, our school is located in a nearby residential area, which may allow a student to easily find housing if desired. Apartments near our school may be leased or rented at prices ranging from \$1200 to \$1800 for a one-bedroom unit. The student is solely responsible for their housing arrangements, as well as their security and safety.

### **Resolution of Disputes**

ABC Technical College is dedicated on providing a quality education to its students and maintaining an environment that is conducive to learning. However, if a student has a grievance against the college, the college has a complaint resolution procedure as follows:

**Step 1.** Student begins by discussing the issue with the instructor verbally. If the complaint is not resolved within 5 business days:

**Step 2.** Student can submit a Student Request Form to the Student Services Coordinator. If no resolution is reached within 10 business days:

Student Request Forms are available for students to put their requests in writing. The Student Services Coordinator ensures that the request is submitted to the Director of Education for action. If the student has a concern, the Student Services Coordinator will make the necessary arrangements for the student to meet and discuss his/her concern with the instructor and the Student Services Coordinator together. If no resolution is then reached, the Student Services Coordinator arranges for the student to meet with the Director of Education. Any student, who after having exercised the student complaint procedures and having made every attempt possible to find a resolution to the issue, yet remains unsatisfied, has the right to present their grievance to:

### **Family Educational Rights and Privacy Act (FERPA)**

ABC Technical College maintains the privacy of student education records and allows students the right to inspect their education records consistent with the requirements of the Family Educational Rights and Privacy Act of 1974 (FERPA). Faculty and staff who request access to student academic records to execute their normal duties must first review the information found on the website mentioned above for FERPA and complete the tutorial before access is granted.

Spouses and other family members/relatives who wish to gain access to information from the education records of their spouse/family member/relative who is a student in any of our schools, will not be provided the information unless the student has granted access by completing the appropriate release form, authorizing the school to release specific information from their education records to approved individuals.

### **Retention of Student Records**

ABC Technical College keeps students' records for no less than five years at its main location, 11100 Valley Blvd Suite #300., El Monte, CA 91731. ABC College will maintain student record in a locked fireproof file cabinet on the school's premises for each student, whether the student completes the educational service, for a period ending five years after the date of the student's graduation, withdrawal, or termination. Transcripts will be retained indefinitely.

ABC Technical College shall maintain, for each student granted a diploma by the institution, permanent records of all of the following:

- 1 The diploma granted and the date on which it was granted.
- 2 The courses on which the certificate was based.
- 3 The grades earned by the student in each of those courses.
- 4 Copies of all documents signed by the student, including contracts, instruments of indebtedness.
- 5 The copy of the language proficiency test given to the student before admission. The test used will be combined English Language Skills Assessment (Celsa).
- 6 Records of the dates of enrollment and, if applicable, withdrawal, leaves of absence, and graduation.

ABC Technical College will maintain an exemplar of all notices and disclosures provided to students and a record of the time within which each notice and disclosure was provided. The institution shall maintain records of student attendance on a roster and as part of each student's education record. As required by law, ABC Technical College will maintain all student records in locked fireproof file cabinets as required by the California Education Code for at least five years at the institution's primary administrative location at 11100 Valley Blvd Suite #300., El Monte, CA 91731.

## **HEALTH AND SAFETY CONSIDERATIONS**

### **Substance Abuse Policy**

### **Housekeeping**

### **Workplace Security Policy**
