STUDENT'S RIGHT TO CANCEL

1. The student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or before the end of the 2nd week of instruction. (_____)
2. If the school has given you any equipment, you shall return it within **seven (7) days** following the date of this notice of cancellation, or if after the cancellation period, your last date of attendance. If you fail to return this equipment in the same condition received within the **seven (7) day** period, the school may retain that portion of payment paid by you, and deduct the cost from any refund that may be due to you.
