### **Definitions**

### **STUDENT'S RIGHT TO CANCEL**

You have the right to cancel the enrollment agreement for this course of instruction, including books, materials and related goods or supplies, and obtain a refund. The institution, for all students, without penalty or obligation, shall refund 100 percent of the amount paid for institutional charges, less reasonable application and registration fees not to exceed two hundred and fifty dollars (\$250) if the notice of cancellation is made prior to or on the first day of instruction or by the seventh day after the date of enrollment, whichever is later.
