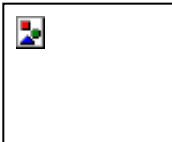

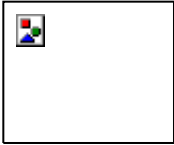

### **STUDENT'S RIGHT TO CANCEL**
