- “Salary” is as reported by graduate or graduate’s employer.

STUDENT’S RIGHT TO CANCEL

You have the right to cancel the enrollment agreement, and obtain a refund of charges paid through attendance at the first class session ___/___/___ (date), or the seventh day after enrollment, whichever is later. Cancellation occurs when you give written notice of cancellation at the institution’s address. You can do this by mail, in person, or by fax. The notice, if mailed is effective by postmark date. This notice need not take any particular form; it needs only to state that you wish to cancel this agreement. If you cancel this agreement, California Science and Technology University will refund any money that you paid, less any deductions for equipment not returned in new condition within 45 day after receipt of the notice.
