### **STUDENT'S RIGHT TO CANCEL**

#### *Cancellation & Withdrawal Policy*

STUDENT'S RIGHT TO CANCEL. The student has the right to cancel the agreement for educational services and obtain a refund of charges paid through attendance at the first class' session, or the seventh day after enrollment, whichever is later. If the agreement is cancelled, the School will refund any money that was paid within 30 days after notice is received. Cancellation occurs when written notice of cancellation is given to the School at the address specified on the Agreement. The Notice of Cancellation, if mailed, is effective when deposited in the mail, properly addressed, with postage prepaid. If the student is rejected for training, or if a course is cancelled, the student will receive a full refund. If the student withdraws, all tuition, fees and other charges shall be refunded on a pro rata basis, less a registration/administrative fee of \$100 and STRF Fee.

If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds. Once purchased, books and supplies become the property of the student and no refund is made. The student has the right to withdraw from the School at any time. #### *Refund Policy*

If equipment was received and returned in good condition within 30 days following the date of withdrawal, the School shall refund the amount paid for the equipment. If equipment was received and the student failed to return it in good condition within 30 days following the date of withdrawal, the School may retain the documented cost of the equipment. The student is liable for the amount, if any, where the pro rata or documented cost of the equipment exceeds the refund amount. If the student has paid more than they owe, a refund will be issued within 30 days of withdrawal. If the amount owed is more than that which was paid, arrangements must be made to pay the difference. If equipment was received and returned in good condition within 30 days following the date of withdrawal, the School shall refund the amount paid for the equipment. If equipment was received and the student failed to return it in good condition within 30 days following the date of withdrawal, the School may retain the documented cost of the equipment. The student is liable for the amount, if any, where the pro rata or documented cost of the equipment exceeds the refund amount. If the student has paid more than they owe, a refund will be issued within 30 days of withdrawal. If the amount owed is more than that which was paid, arrangements must be made to pay the difference. If the school cancels or discontinues a course or education program, the school will make a full refund of all charges. The school will also refund money collected for sending to a third party on the student's behalf such as license or application fees.
