STUDENT'S RIGHT TO CANCEL

For applicants who cancel enrollment or students who withdraw from enrollment a fair and equitable settlement will apply. The following policy will apply to all terminations for any reason, by either party, including student decision, course or program cancellation, or Institution closure. This institution is in compliance with the California State institutional refund policy.

Official cancellation or withdrawal shall occur on the earlier of the dates that:

- 1. An applicant is not accepted by the institution. The applicant shall be entitled to a refund of all monies paid less than the non-refundable application fee (\$100).
- 2. "RIGHT TO CANCEL" A student (or in the case of a student under legal age, his/her parent or guardian) gives a written Notice of Cancellation electronically or in person through attendance at the first-class session, or the seventh calendar day after enrollment, whichever is later. In this case all monies collected by the institution shall be refunded, regardless of whether the student has actually started classes less non-refundable application fee (\$100). If the student has received federal student financial aids funds, the student is entitled to a refund of monies not paid from federal aid program funds.
- 3. "RIGHT TO CANCEL" A student cancels his/ her enrollment after seven (7) calendar days of signing the contract but prior to starting classes. In these cases, he/ she shall be entitled to a refund of all monies paid to the institution less the non-refundable application fee in the amount of \$100. If the student has received federal student financial aids funds, the student is entitled to a refund of money not paid from federal aid program funds.

STUDENT'S RIGHT TO CANCEL
