Definitions

- "Number of Students Who Began the Program" means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- "Students Available for Graduation" is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.

- "On-time Completion Rate" is the number of on-time graduates divided by the number of students available for graduation.

STUDENT'S RIGHT TO CANCEL

The student has the right to withdraw from the program of instruction or cancel the enrollment agreement at any time and obtain a refund according to the following refund policy.
