### **STUDENT'S RIGHT TO CANCEL**

You have the right to cancel this Agreement for educational service, any equipment or other goods and services if notice of cancellation is made through attendance at the first class session, or the seventh day after enrollment, whichever is later. §94920(b) Cancellation occurs when you give written notice of cancellation at the school address shown on the front page of this Agreement. You can do this by mail, email, FAX, or telegram. The notice of cancellation, if mailed, is effective when deposited in the mail, properly addressed with postage prepaid. This notice need not take any particular form; it needs only to state you wish to cancel the Agreement. You will be given a notice of cancellation form on the first day of class, but you can use any written notice that you wish. If you cancel this Agreement, School will refund any money that you paid, less an application/registration fee not to exceed \$250, within 45 days after your notice is received. If the Student is rejected for training or if a course is canceled, the student will receive a refund of all monies paid. You have the right to withdraw from the school at any time. If you withdraw from the course of instruction after the cancellation period outlined in paragraph 1, the school will remit a refund less an application/registration fee not to exceed \$250 within 45 days following your withdrawal. You are obligated to pay only for educational services rendered until you have completed 60% of the course or enrollment period. After 60% completion, there is no refund.
