STUDENT'S RIGHT TO CANCEL

- 1. You are obligated to pay only for educational services rendered and unreturned equipment up to 60% of the course or period of enrollment. After you complete 60% of the course or period of enrollment, there is no refund. The refund shall be the amount you paid for instruction multiplied by a fraction, the numerator of which is the number of hours of instruction which you have not received, but for which you have paid, the denominator of which is the total number of hours of instruction for which you have paid. Due to sanitation concerns, makeup kit costs cannot be refunded unless the student cancels his/her enrollment prior to being issued his/her materials on the first day of class. If the amount you have paid is more than the amount that you paid, then you will have to make arrangements to pay it.
- 4. For the purpose of determining the amount you owe, you shall be deemed to have withdrawn from the course when any of the following occurs: (a) you notify the School of your withdrawal or the actual date of withdrawal; (b) School terminates your enrollment; (c) you fail to attend classes for a three-week period; (d) you fail to return from a leave of absence. In this case, the date of withdrawal shall be deemed to be the last date of recorded attendance.
- 5. If any portion of your tuition was paid from loan proceeds, any refund due will be sent to the lender or applicable agency. Any remaining refund amount will first be used to repay any student financial assistance programs from which you received benefits, to the extent of benefits received. Any remaining amount will be paid to the student's financer.
