Definitions:

- "Number of Students Who Began Program" means the number of students who began the program who are scheduled to complete the program within the reporting calendar year, and includes all the students who remained enrolled after cancellation period.
- "Students available for graduation" is the number of students who began the program
 minus the number of students who have died, been incarcerated, or been called to active
 military duty.
- "Number of On Time Graduates" is the number of students who completed the program within 100% of the program length.
- "On Time Completion Rate" is the number of Graduates divided by the number of students Available for Graduation
- "150% Graduates" is the number of students who completed within 150% of the program length (includes on time graduates).
- "150% Completion Rate" is the number of students who completed the program in the reported calendar year within 150% of the published program length including on time graduates, divided by the number of Students Available for Graduation.
- "Graduates Available for Employment" means the number of graduates minus the number of graduates unavailable for employment.
- "Graduates unavailable for employment" means graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- "Graduates Employed in the Field" means graduates who report that they are gainfully employed in a single position for which the institution represents the program prepares its graduates within six months after a student completes the applicable educational program. For occupations for which the state requires passing an examination, the period of employment must begin within six months of the announcement of the examination results for the first examination available after a student completes an applicable educational program.
- **Placement Rate Employed in the Field**" is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.
- **Number of Graduates taking Exam**" is the number of graduates who took the first available exam in the reported calendar year.
- "First Available Exam Date" is the date for the first available exam after the student completed the program
- "Passage Rate" is calculated by dividing the number of students who passed the exam by the number of graduates who took the reported licensing exam.
- Number Who Passed First Available Exam Taken is the number of students who took and
 passed the licensing exam in the reported calendar year on the first attempt
- **Salary** is as reported by the student. Not all graduates report salary. A list of the employers of the Graduates Employed in the Field can be obtained from the MHATCP administrator if the information was reported either from the graduate or from their employer.
- **No Salary information Reported**" is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.



STUDENT'S RIGHT TO CANCEL

You have the right to cancel your agreement for a program of instruction, without any penalty or obligations, through attendance at the first-class session or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period, you also have the right to receive a refund only for the remaining portion of the program, which you will not attend. You have the right to receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance.
