STUDENT'S RIGHT TO CANCEL

Cancel: You have the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. Airstreams shall refund 100 percent of the amount paid for institutional charges, less a \$100.00 application (if applicable), if notice of cancellation is made through attendance at the first class session, or the seventh day after enrollment day after enrollment, whichever is later. Withdrawal: The withdrawal period is in effect after the cancellation period.
