STUDENT'S RIGHT TO CANCEL

You have the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session or the seventh day after enrollment, whichever is later.

You have the right to cancel the enrollment agreement you sign for a course of instruction and obtain a refund of charges paid less the non-refundable registration fee (not to exceed \$250.00). Cancellation shall occur when you give written notice of cancellation at the address of the school 115 N. Sutter St., Suite 3, Stockton, CA 95202. You can do this by mail, hand delivery, or email. The written notice of cancellation, if sent by mail, is effective from the post mark date. The written notice of cancellation need not take any particular form, and, however expressed, it is effective if it shows that you no longer wish to be bound by your enrollment agreement.

If the school has provided you any equipment, including books or other materials, you shall return it to the school within 10 days following the date of your notice of cancellation.
