15. "Salary" is as reported by graduate or graduate's employer.
16. "No Salary Information Reported" is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.

STUDENT'S RIGHT TO CANCEL

UI complies with the requirements of the CEC §94820, CEC §94822, CEC §94823, and CEC §94824. The student has the right to cancel this enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. §94911(e)(1)

Distance Learning: UI's distance learning educational programs are asynchronous and not offered in real time. The student shall have the right to cancel the enrollment agreement and receive a full refund before the first lesson and materials are received. The cancellation is effective on the date the **written email** notice of the cancellation is sent. For distance learning students, only **written email** notice of the cancellation shall be accepted. UI shall make refund pursuant to section 71750 of the Regulations. If the institution sent the first lesson and materials before effective cancellation notice was received, the institution shall make a refund within 30 days after the student's return of the materials.
