CANCELLATION

In accordance with the state of California, an institution shall refund 100% of the amount paid for institutional charge if notice of cancellation is made through attendance at the first class session, or the seventh class day after enrollment, whichever is later. Cancellation occurs when the student gives written notice of cancellation to the school at the address specified in the agreement.
