STUDENT'S RIGHT TO CANCEL

For applicants who cancel enrollment or students who withdraw from enrollment a fair and equitable settlement will apply. The following policy will apply to all terminations for any reason, by either party, including student decision, course or program cancellation, or Institution closure. Official cancellation or withdrawal shall occur on the earlier of the dates that:
