STUDENT'S RIGHT TO CANCEL

10(1) Notice of Cancellation must be in writing and signed and dated by the student or legal guardian.

Withdrawal from the Program may be effectuated by the student's or guardian's written notice or by student's conduct, including but not limited to, a student's attendance.
