## **STUDENT'S RIGHTS TO CANCEL**

**1.** You may cancel your contract for school, without any penalty or obligation before the first lesson and material received, or on the seventh day following your first-class session as described in the Notice of Cancellation form that will be given to you at the first class you go to. A different cancellation policy applies for home study or correspondence courses. Read the Notice of Cancellation form for an explanation of your cancellation rights and responsibilities.
