STUDENT'S RIGHT TO CANCEL

CANCELLATION, WITHDRAWAL and REFUND POLICY

Student has the right to cancel or withdraw from course program and obtain a pro-rated refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later.

Refund policy: \$250.00 registration fee is non-refundable and cost for books (if applicable) the \$130.00 is non-refundable.

Students who have completed 60% or less of the period of attendance shall be issued a prorated refund as follows: Students who cancel prior to attending class time will be issued a full tuition refund less non-refundable registration and book fee.

Students who attend 60% or more of class time and will not receive a refund.

Notice of cancellation must be in writing. Withdrawal may be effectuated by the student's written notice or by the student's conduct, including, but not necessarily limited to, a student's lack of attendance.

If student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.
