STUDENT'S RIGHT TO CANCEL

Students wishing to cancel or discontinue their participation in Montes HealthCare College may be entitled to a refund of certain monies paid to their enrolled program. If a student fails to submit a Notice of Cancellation and chooses not to continue attending regularly scheduled class sessions, the student is considered to still be enrolled in his or her respective program up to 14 calendar days after the date of last attendance. In these cases where no communication from the student is received, the effective date of cancellation is 14 calendar days after the date of last attendance.

Students have a right to cancel and receive a full refund of all amounts paid, excluding up to \$250 of the Registration Fee, if the Notice of Cancellation is submitted through attendance at the first-class session, or the seventh (7) day after enrollment, whichever is later.

Students who submit a Notice of Cancellation where the effective date of cancellation indicates that the term of enrollment is 60% or less of the published program term may be entitled to a pro rata refund of the amount paid. The amount of any refund will be based on the total amount of student payments compared to the sum of the Deposit Fee, STRF Fee, Physical / Digital Items Fee, Other Institutional Charges, and the Attendance Fee.

The Attendance Fee is calculated by taking the total cost of the program, divided by the number of days in the program, multiplied by the number of days the student attended, or was scheduled to attend, up to and including the effective date of cancellation. All amounts paid by the student in excess of what is owed based on this pro rata calculation, will be refunded.
