### **STUDENT'S RIGHT TO CANCEL**

You have the right to cancel this enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later, consistent with the requirements of Article 13, section 94919. The institution for all students, without penalty or obligation, refunds 100 percent of the amount paid for institutional charges, less a reasonable deposit or application fee of fifty dollars (\$50), if the notice of cancellation is made prior to or the first class session, or the seventh day after enrollment, whichever is later. After the end of the cancellation period, you also have the right to stop school at any time, and you have the right to receive a pro rata refund if you have completed 60% or less of the instruction.

The written notice of cancellation need not take any particular form and however expressed; it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.

If the Enrollment Agreement is cancelled, the school will refund the student any money he/she paid, less the General Fees, within 45 days after the notice of cancellation is received.
