### **CANCELLATION OF ENROLLMENT & STUDENT'S RIGHT TO CANCEL**

The Colburn Conservatory of Music is accredited by the National Association of Schools of Music (NASM) and observes NASM policies regarding the commitment to enroll. The state of California requires that a student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first-class session, or the seventh day after enrollment, whichever is later.

The Colburn school's cancellation policy extends the student's right to cancel the enrollment agreement and obtain a refund of charges up through Friday of the second week of class.

- Cancellation before the Friday in the second week of classes: The school will refund 100 percent of the amount paid for institutional charges, less a reasonable deposit or application fee not to exceed two hundred fifty dollars (\$250). (includes a complete refund of comprehensive fee and parking amounts paid to date.)
