**STUDENT'S RIGHT TO CANCEL**

The student shall have the right to cancel the agreement and receive a full refund pursuant to section 71750 through attendance at the first class session, or the seventh day after enrollment, whichever is later, and before the first lesson and materials are received. Cancellation is effective on the date written notice of cancellation is sent by email to [gemi@nourishthebrain.com](mailto:gemi@nourishthebrain.com). The institution shall make the refund as per the calculation consistent with the California Code of Regulations.
