## History

Healing Hands School of Holistic Health began on February 7, 1992 when we, Neha and Paula Curtiss taught the first day of our first Circulatory Massage class. At that time we carried Healing Hands School around in a station wagon; the business office was at our kitchen table.

While working as massage therapists, we knew we had something more to offer. Our vision: to teach therapeutic bodywork so that the massage student not only learns the techniques but is inspired by the art and craft of the work. We understood that the student must be able to feel the work; we saw then, and now, the need for the beginner to be both the therapist and the client. We looked to our many teachers who had so generously given of themselves; we looked to the traditions of Western Science and to the disciplines of Eastern philosophy in addressing the question: "How can we teach hands-on massage skills while encouraging deep respect for the physical body and compassion for each other." With faith that, given a positive environment, most individuals will rise to meet given expectations, we embarked on our mutual dream.

Since that first day of Healing Hands School, over 8,000 students have taken the 100-hour Circulatory Massage Training. We now know a variable that we had not anticipated: we've encountered students who not only rose to given expectations, but completely blew the mold away. We have seen the student/therapist demonstrate deep compassion so often that our original vision is continually renewed.

Healing Hands School has been blessed beyond our wildest dreams with a steady flow of dedicated Healers. Several students continued with the community of Healing Hands by becoming part of our staff, while others move out into their communities to bring our vision of healing to those in need.

The Healing Hands School provides equipment to appropriately support the objectives of the programs. Audio-visual equipment is used to support the "hands-on" training in the fields of Massage Therapy and Holistic Health, and reinforces the concepts learned and practiced. There are massage tables, massage chairs, overhead projectors, white boards, Wi-Fi, and training models.

**Entry Level Skills Of Practitioners & Therapists**

- A thorough understanding of the muscular system of the body.
- A basic understanding of pathologies of the human body, when and where to refer if needed, including understanding of indications and contraindications for massage therapy.
- The ability to perform Circulatory Massage techniques appropriately and effectively.
- Practice appropriate draping techniques, and client confidentiality.
- Have a fundamental understanding of medical terminology.
- Be proficient in the use of proper body mechanics needed for professional massage practice.
- Be able to maintain client records.
- Have a general understanding of business procedures.
- Have a solid understanding of customer service.

**Additional entry-level requirements for Holistic Health Practitioners include:**

- Have fundamental understanding of adjunct Holistic Health modalities.
- Have advanced ability to customize bodywork sessions to meet the specific needs of clients.
- Have fundamental understanding of advanced manipulation techniques.

**The Field of Massage Therapist**

Massage Therapists practice in a variety of settings, such as private offices or massage therapy clinics, Chiropractors' or Doctors' offices, Holistic Health clinics, health clubs and fitness centers, spas, nursing homes and hospitals, with sports teams, and sports medicine facilities. Some Massage Therapists have portable equipment and work at their clients' offices or homes. Most recently, Massage Therapists have appeared in some rather innovative settings, such as storefronts, shopping malls, and airports.

Massage Therapists generally work as salaried or commissioned employees, or independent contractors. Their earnings vary widely, depending on variables such as the area of the country, type of practice, skills and experiences. Licensure requirements may include the passing of an exam, either written or hands-on, a physical examination and criminal background check. The Massage Therapist Program provided at Healing Hands satisfies the minimum requirements to take a standardized exam: 'MBLEX' proctored by the Federation of State Massage Therapy Board or [www.fsmtb.org](http://www.fsmtb.org).

## Massage Therapist Program

### Massage Therapist Program Description and Objectives:

You begin our Massage Therapist Program with the Circulatory Massage course. Other requirements include our 100 hour Anatomy for Body-workers course, 50 hours of Clinical Practicum for the Massage Therapist, 50 hours of Professional Practices plus an additional 300 hours of training, which you select from the elective courses that are part of the Massage Therapist Program. Some cities/ counties in California do not allow Massage Therapists to be self-employed. This program is intended for adults who wish to enter the field of Massage Therapy. The program prepares the graduate with the skills, knowledge and work habits needed to obtain an entry-level position in Massage Therapy.

The courses in this program include lecture, laboratory experience in Anatomy, Physiology, demonstration, and hands-on practice of various massage strokes and techniques. The program prepares the student for real-world application of the skills learned in the classroom. Students also complete 50 hours of Clinical Practicum for the Massage Therapist which is a clinic/externship to gain experience working with the public prior to graduation.

### At the Conclusion of the Massage Therapist Program

The student will be able to:

- Demonstrate an understanding of the professional conduct required to be a Massage Therapist.
- Perform proper draping techniques.
- Demonstrate an understanding of universal precautions.
- Demonstrate a thorough understanding of body mechanics.

- Be competent in the hands-on skills related to each Circulatory Massage technique learned.
- Demonstrate an understanding of, and be able to assess, contraindications to massage.
- Demonstrate an understanding of the theories and philosophy of massage.
- Have an understanding of the physiological benefits of massage.
- Successfully demonstrate competency and understanding of the required skills when participating in clinic or other externship opportunities. Such competencies include adhering professional standards and ethics, conscientious client assessment, practical application techniques and appropriate self-care.
- Explore their personal career goals as they relate to developing their career as a Holistic Health Practitioner; with a focus on opening their own practice, if desired.

### **The Field of Holistic Health Practitioner**

The Holistic Health Practitioner may elect to work in any one of a variety of settings as a Massage Therapist or, once licensed, one may own and operate their own massage establishment.

In some parts of California, laws require 1,000 hours of training to practice as a Holistic Health Practitioner. In addition, testing requirements may include the passing either the Board Certification Exam for Therapeutic Massage and Bodywork (BCETMB) or the Massage & Bodywork Licensing Examination (MBLEx). Additional licensure requirements may include the passing of a physical exam and criminal background check. You may obtain complete information on licensure requirements by contacting the massage therapy authority for the city and county where you intend to work. In California students would check with the *California Massage Therapy Council* or CAMTC, found on-line at [www.CAMTC.org](http://www.CAMTC.org).

The Holistic Health Practitioner Program, provided at Healing Hands, satisfies the minimum requirements to take the Board Certification Exam. As a trained Holistic Health Practitioner, you will join other health professionals in the movement to increase the health and well-being of those in your community.

Holistic Health Practitioner graduates should have all the skills and knowledge required to be a Massage Therapist, as well as a fundamental understanding of complementary Holistic Health modalities and advanced manipulation techniques.

**.....III. Admissions.....****Admission Procedures**

Applicants must adhere to the following procedure in order to be considered for admission.

- Complete and submit the Application for Admission.
- Applicants must receive an Annual School Catalog prior to enrollment, either in print or by email.
- Applicants will be screened and his/her credentials will be evaluated prior to being accepted or rejected to the program.
- Applicants for the Massage Therapist and Holistic Health Programs must meet with a Healing Hands School representative.
- Those interviewing in person will be given a tour of the Healing Hands School facility; those not interviewing in person will tour the facility during Orientation.
- Decisions of acceptance or denial are made only by the School Directors.
- Applicants are notified of acceptance or denial to the schools programs, once applicant has completed the admissions requirements.
- Upon acceptance, the applicant must complete the enrollment process as follows:
  - a. Student must read and understand the contents of this Catalog.
  - b. The applicant must have all financial arrangements completed, and agreed to as stated on the Enrollment Agreement.
  - c. Any prospective student participating in distance education will be provided the Distance Education Self-Questionnaire to assist with determining readiness to participate in coursework at a distance.
- Institutional Eligibility: the institution admits as regular students only persons who-
  - Have a High School diploma; and/or
  - Have the recognized equivalent of a high school diploma; and/or
  - Are beyond the age of compulsory school attendance in California

The following documents must be satisfactorily completed and submitted prior to commencement:

- Applicant must complete an “Application for Admission”.
- Applicant must sign “Enrollment Agreement and provide a \$250 refundable “on-time deposit”.
- Applicant must pay the fees as agreed to on the front page of the “Enrollment Agreement”.
- Applicant must provide a copy of his/her high school diploma that reflects high school graduation, or documentation of equivalency to High school, and be beyond the age of compulsory attendance in California.
  - International transcripts must be evaluated to determine High School equivalency.
  - In the case that the applicant is Homeschooled and under the compulsory age limit, applicant must have a parent or guardian present at the time of enrollment to

sign enrollment agreement. Applicant will be asked to provide High School equivalency such as GED or California High School Proficiency Exam (CHSPE) in addition to parental permission.

- In the case of emancipation, applicant needs High School diploma or the equivalent to enroll and provide proof of emancipation if under the compulsory age limit.
- If the institution has reason to believe that the High School diploma provided is not valid, or was not obtained from an entity that provides secondary school education, Healing Hands School may:
  - a. Require transcripts in addition to diploma.
  - b. Require transcript/diploma to be certified to be at least the equivalent of a U.S. high school diploma by a agency that is a member of the National Association of Credential Evaluation Services (NACES) or Association of International Credential Evaluators (AICE) prior to enrollment.
- Applicants are encouraged to provide a copy of their high school transcript in addition or in place of High School diploma.
- Applicant must complete and provide the distance education questionnaire if participating in distance education coursework.

### **General Requirements**

Healing Hands enrolls only students who can reasonably be expected to benefit from the instruction we provide. Applicants must provide the appropriate credentials and demonstrate the potential needed to indicate a reasonable probability of successfully completing the program offered at Healing Hands. Healing Hands has established the following Admissions Requirements, upon which it evaluates all applicants for admission to the school.

To qualify for admission to the Healing Hands School of Holistic Health, an applicant must meet the following requirements:

- Applicants to the Massage Therapist or Holistic Health Practitioner programs must be beyond the compulsory school age limit in California. Students may take any individual course a-la-carte regardless of age, however, all students must be able to physically and emotionally give and receive massage.
- Applicants must be residing in California and within commuting distance to a campus location. Residency is verified by student address.
- Applicants must be high school graduates or have a recognized equivalent to high school diploma. All applicants must provide a copy of his/her high school diploma or General Equivalency Diploma (GED) or recognized equivalent to demonstrate satisfaction of this requirement. In addition, applicants are encouraged to provide a copy of his/her high school transcript.
  - b. High school documentation from a country other than the United States must be translated and certified to be at least the equivalent of a U.S. high school diploma by a agency that is a member of the National Association of Credential Evaluation Services (NACES) or Association of International Credential Evaluators (AICE) prior to enrollment.\
  - c. In the case that the applicant is Homeschooled and under the compulsory age limit, applicant must have a parent or guardian present at the time of enrollment to

sign enrollment agreement. Applicant will be asked to provide High School equivalency such as GED or California High School Proficiency Exam (CHSPE) in addition to parental permission.

- d. In the case of emancipation, applicant needs High School diploma or the equivalent to enroll and provide proof of emancipation if under the compulsory age limit.
- e. If the institution has reason to believe that the High School diploma provided is not valid, or was not obtained from an entity that provides secondary school education, Healing Hands School may:
  - a. Require transcripts in addition to diploma.
  - b. Require transcript/diploma to be certified to be at least the equivalent of a U.S. high school diploma by a agency that is a member of the National Association of Credential Evaluation Services (NACES) or Association of International Credential Evaluators (AICE) prior to enrollment.
- Applicant must complete the distance education self- questionnaire if participating in distance education coursework.
- English language proficiency must be equivalent to the 8th grade level and up with a High School Diploma or Test of English as a Foreign Language.
- Applicants who do not have a high school diploma or its equivalent, cannot be enrolled in the Massage Therapist Program or Holistic Health Practitioner Program, however, such applicants may enroll in an individual course, i.e. Circulatory Massage, etc. Information about GED testing is available from the Admissions office staff.
- Applicants are advised that an individual must be at least 18 years old to qualify for licensure in those cities/counties in which licensure is available, or for California Massage Therapy Council Certification.
- Due to the nature of the training, all applicants must be in good health, and be capable of effectively meeting the physical demands of performing therapeutic massage applications. Applicants must also be able to receive massage.
- Applicants must satisfactorily complete all admissions requirements, including submitting an accurate and complete Application for Admission. Applicants, who fail to provide accurate information, may not be considered for admission.
- Prior to signing the Enrollment Agreement and being accepted in the program, each applicant must have received a school Annual Catalog containing the school rules and policies.
- Each applicant must read and sign the Enrollment Agreement, which outlines the details and obligations of the student and Healing Hands School and acknowledges the Applicant's understanding of the contents of the Healing Hands School's Catalog.
- A former student, who did not complete the program of study and/or has been terminated or withdrawn from the program, is required to reapply for admission. The readmission policy is included in this Catalog. A readmitted student is governed by the Catalog current at the time of the readmission.
- The applicant must display a genuine desire to become part of a learning atmosphere with the ability and aptitude to succeed in the classroom.
- An applicant must provide proof that he/she is 18 years or older, or beyond the age of compulsory education in the State of California. Applicants under the age of 18 are advised that licensure requirements in some cities and counties, for some programs we offer require that the individual be 18 years old or older.
- Applicants are advised that the massage therapist and holistic health practitioner programs are regulated occupations in many cities and counties. Licensure in some cities

and counties require a criminal background check, and convictions could prevent the student from being licensed/certified. We encourage you to contact the School Director before you enroll to discuss any concerns you may have regarding this licensure requirement.

- a. In addition, the California Massage Therapy Council (CAMTC) certifies qualified massage professionals; certification is voluntary, however, it may be required by some employers and/or in some cities or other jurisdictions in which you wish to work. Graduates applying to CAMTC will be required to submit to a fingerprint investigation and respond to specific questions including convictions other than minor traffic violations, formal complaints lodged against the graduate of an alleged sexual misconduct, lawsuits filed against the graduate, and any administrative citation or government complaints filed against the graduate. If the applicant has any concerns that he/she will not be able to successfully seek CAMTC certification, he/she is encouraged to discuss this with the Healing Hands Director, as it may hinder successful employment after graduation. The transferability of credits you earn at Healing Hands School is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in your educational program (Holistic Health Practitioner or Massage Therapist Program) is also at the complete discretion of the institution to which you may seek to transfer. If the clock hours or

### Please Note

Student (and Co-buyer, if applicable) understands that payments are to be made to the School, or assignee. If this Agreement be assigned, Student (and Co-buyer, if applicable) will be bound by all of its terms and conditions. Students who miss two payments as scheduled on the Enrollment Agreement are subject to notification and given ten (10) days to bring the account current or face termination from Healing Hands School of Holistic Health. Students are assessed a fee of \$35.00 for all returned checks. Students are assessed a fee of \$50.00 for late payments. The Agreement is not binding until accepted by the School.

The schedule of total charges for a period of attendance and the estimated schedule of total charges for the entire educational program are the same.

Visa services are provided at no additional cost. Healing hands School of Holistic health will vouch for students' status.

### Student Tuition Recovery Fund fee

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of you tuition. You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 1747 North Market, Suite 225, Sacramento, CA 95834, (916) 574-8900 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.

2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

### **Additional Fees that Maybe Incurred:**

1. The Registration fee, also known as the On-time deposit, of \$250.00 is refundable pending the students on-time graduation by the Scheduled Completion Date. The on-time deposit will be used to cover any additional fees that may be incurred over the course of my program. If no additional fees are incurred, the student will be refunded this payment after the successful on time completion of all HHP program requirements. If a student terminates the program at any time before completion, the \$250 deposit is non-refundable.
2. Registration for classes is due in writing by the registration dates listed in the class schedule. Subject to availability, students may register for a class after registration date or walk into a class by paying a \$50 registration fee.
3. A \$50 registration fee will be assessed for classes registered for but not attended unless we are notified in writing by registration date of the class that the student will be unable to attend.

4. If an individual class is unsuccessfully completed, or failed, the student will pay for all class hours of enrollment up to the official drop date at a rate of \$15.00 per hour plus a \$50 Registration Fee.
5. All course work must be completed within three months of the end date of said class, or by the Scheduled Completion date of the program, whichever comes first.
6. If withdrawal or dismissal should occur before completion of the program, student will incur a withdrawal penalty of \$4.50 per hour of enrollment.
7. Non-payment of monthly tuition for over 90 days will result in the student being dropped from the program.
8. If it becomes necessary for an account to be processed by a collection agency, there will be an additional 40% charge added to all monies owed.

### **Federal Student Aid**

The Healing Hands School of Holistic Health participates in Title IV Student Financial Aid programs including Pell Grants and Direct Loan programs. The School also accommodates students by providing options for payment plans. Healing Hands School of Holistic Health is eligible to participate in Federal Department of Education Title IV Programs. Information about these programs is available from the Financial Aid Department. Brochures and pamphlets regarding student loan programs include information on specific loan types and repayment conditions, the availability of federal and state grants and the requirements for loan eligibility. These materials may be obtained in the Financial Aid Department. Healing Hands has developed the following policy and procedures to guide students applying for financial aid.

- Students seeking financial aid must first complete the Application for Federal Student Aid (FAFSA) at [www.fafsa.gov](http://www.fafsa.gov). The School's Financial Aid Administrator will use this information to determine the student's eligibility and assists them in deciding what resources are best suited to their circumstances. Students must meet all eligibility requirements to qualify for Federal Student Aid. The Financial Aid Department may request additional documentation to support the student's request for financial assistance, including, for example, signed copies of federal income tax returns.
- For those students selected for verification, by the Department of Education by Heisei, the school will use the current Verification Guide issued by the Department of Education as the governing document. Any supporting documentation, required for verification, must be submitted to the Financial Aid Department by the required deadline. If the student fails to provide the documentation by the required deadline, the student will receive no further financial aid and must return to the Department of Education all Pell disbursements received prior to being selected for verification. Please see the Financial Aid Administrator for more information.
- Renewal of financial aid is not automatic. Recipients are required to reapply each year by the announced deadline.
- Students are encouraged to seek tuition assistance from other possible sources such as private agencies, community grants, etc.

All healing Hands School of Holistic Health students are notified that if a student obtains a loan to pay for an educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund, and that, if the student has received federal

student financial aid funds, the student is entitled to a refund of the moneys not paid from federal student financial aid program funds.

### How to Request a Dependency Override

Sometimes students have unusual circumstances that they feel should qualify them as an independent student even though they technically fall under the dependent student classification. If you feel that you have an unusual circumstance that may change your status from 'dependent' to 'independent', you may request our financial aid administrator for review your request.

We will review your request when you submit:

1. Proof of 17 years of age or older
2. A letter by you summarizing your unusual circumstance identifying that you longer live with either of both parents, that you receive not financial assistance from either or both parents, and that you have no emotional or parental guidance from either or both parents.
3. A second letter by an independent 3<sup>rd</sup> Party documenting the unusual circumstance.  
Example of 3<sup>rd</sup> Party are, social workers, clergy, teachers, guidance counselors, doctors or others who are familiar with the student's situation. Police reports documenting domestic violence and abuse, drug abuse.
4. You may also include letters from friends or family members such as an Aunt / Uncle, or the people you are living with. These letters must be notarized.
5. Unusual circumstances include: involuntary dissolution of the family, parental homelessness or unable to provide home, parental mental illness/drug abuse, parental abandonment, parental incarceration, domestic violence/abuse, parental whereabouts unknown.

### Types of Financial Aid

Healing Hands School of Holistic health is a federally recognized and certified school, enabling students who qualify to take advantage of the following government subsidized financial aid programs:

### Federal Student Aid; FAFSA

The Healing Hands School of Holistic Health is eligible to participate in Federal Department of Education Title IV Student Financial Aid Programs. Brochures regarding student loan programs, specific loan types, repayment conditions and the requirements for loan eligibility may be obtained in the Financial Aid Department. ### Cal Grant:

When to apply by?

FAFSA/ DREAM Act must be applied or by March 2<sup>nd</sup> of the award year prior to the start of the school year.

Students may be eligible for a Cal Grant award by first applying for FAFSA/DREAM act by March 2<sup>nd</sup>. Then student's login through the California Student Aid Commission (CSAC) at: <https://mygrantinfo.csac.ca.gov/>. Students go through the Webgrants for Students portal. Student

must have completed either a FAFSA or a DREAM Act application, that application is then sent to CSAC. Grants administered by CSAC are based on a students' Family contribution and need.

Eligibility for the Cal Grant is also subject to students full-time, three quarter time, or half-time enrollment at the time that Healing Hands School does a Census for each quarter.

Healing Hands School will administer a Census six weeks after each quarter begins.

Ex: Summer quarter begins July 1<sup>st</sup>, Census will be administered August 12<sup>th</sup>

Fall quarter begins October 1<sup>st</sup>, Census will be administered November 12<sup>th</sup>

Winter begins January 2<sup>nd</sup>, Census will be administered February 13th<sup>th</sup>

Spring begins April 1<sup>st</sup>, Census will be administered May 13<sup>th</sup>

Full time, three quarter time, or half time is determined by the amount of hours or credits a student takes per quarter. 20 clock hours = 1 credit unit. To be considered full time, a student must take 260 hours, or 12 credits in one quarter. Anything different will change the amount of grant a student is eligible for.

Ex: 200 hours in a quarter = 10 units = 3/4 time

In this example a student would then be eligible for ¾ of the grant available for that quarter.

The Cal grant is split into 4 separate quarters. This means that whatever the total amount a student is eligible for gets split into 4 separate quarters, with the same amount available in each quarter. A student will use 133% of eligibility each year, or 33% per quarter. The max amount of funding for a lifetime is based on 400%

EX: \$2,000 cal grant: \$500 available in each summer, fall, winter, and spring quarter.

EX: Student applies for FAFSA/DREAM by March 2<sup>nd</sup>, 2024 to be eligible for the Cal grant starting July 1<sup>st</sup>, 2024 – June 30, 2025.

Students who miss this deadline may still apply to be considered for the competitive award cycle. There is no guarantee that someone can be awarded during the competitive cycle as funds are extremely limited.

### **Veterans Benefits including Title IX Post 9/11 GI Bill ® Chapters 30, 31, 33**

GI Bill® is a registered trademark of the U.S. Department of Veterans Affairs (VA). More information about education benefits offered by VA is available at the official U.S. government website at <http://www.benefits.va.gov/gibill>.

Healing Hands is approved by the Bureau for Private Post-secondary Education, under SAA, to process Veterans Benefits including Title IX and Post 9/11 GI Bill®, Chapters 30, 33. Eligibility for Post 9/11 GI Bill® Veteran Benefits requires that you have served at least 90 days on active duty after September 10, 2001. You are also eligible if you were honorably discharged for disability resulting from service after serving 30 consecutive days following September 10, 2010.

As a part of this bill, qualifying members receive a tuition and fee payment that is paid to your school, a monthly housing allowance and a books and supplies stipend. To enroll at Healing Hands School, you must provide a Certificate of Eligibility that explains the amount of tuition and aid you will receive from the Post 9/11 GI Bill®. In accordance with Title 38 US Code 3679 subsection (e), this school adopts the following additional provisions for any students using U.S. Department of Veterans Affairs (VA) Post 9/11 G.I. Bill® (Ch. 31) or Vocational Rehabilitation and Employment (Ch. 31) benefits, while payment to the institution is pending from the VA.

This school will not:

- Prevent the students enrollment;
- Assess a late penalty fee to;
- Require student secure alternative or additional funding;
- Deny their access to any resources (access to classes, libraries, or other institutional facilities) available to other students who have satisfied their tuition and fee bills to the institution.

**Transfer of credits to the School**

Students who wish to apply for advance standing in their program must submit official transcripts to Healing Hands for review prior to beginning their training. The Program Director will evaluate previous education and training that may be applicable to an educational program offered at Healing Hands in writing.

Massage school or program transferred hours must come from a California Massage Therapy Council (CAMTC) Approved School list. To view the schools Approved by CAMTC, go to: <https://www.camtc.org/schools/>. When applying for CAMTC Certification, transcripts must be sent from the school that the student is transferring from AND from Healing Hands School.

Credit may be given if the education and/or training were completed at another institution accredited by an agency recognized by the United States Department of Education (USDE) or the Council for Higher Education Accreditation (CHEA), including military training, as well as programs approved by the Bureau for Private Postsecondary Education where courses and clock hour values are comparable to those offered at Healing Hands and a grade of 'C' or 70 percent or better was attained.

Students who petition for transfer credit must provide Healing Hands with an official transcript that includes the courses the student wishes to transfer. In addition, students may be required to demonstrate competency in requested transfer training courses. The Director or Program Director will prepare a written report to document the evaluation of the courses for which the student is petitioning for transfer credit; the report will list the documentation, (including the transcript of the courses the student is seeking to transfer) in the student file that was used in evaluating the transfer credit request and final determination. The maximum number of hours the student is allowed to transfer to a Healing Hands School of Holistic Health program is 50% of the total program hours. Transfer course hours will be the equivalent to those for which the student is receiving credit. Transfer hours are counted as both attempted and successfully completed.

Acceptance of credits earned at another institution that is not located in the United States or its territories will be evaluated by an agency which attests to the qualitative and quantitative equivalency of the foreign education and the specific course or courses for which transfer credit is to be awarded. It is the student's responsibility to use the credential evaluation services of an agency that has published standards for membership, affiliations to international higher education associations, and are frequently linked to and used by federal agencies, state agencies, educational institutions and employers (e.g., NACES and AICE).

Transfer hours affect a students' tuition. Any transfer hours that have been accepted by Healing Hands School will receive \$14 off each transferred hour.

**Example:**

If a student transfer in 100 hours into a program, tuition will be deducted \$1,400 and be recorded as a Credit Balance.

This course combines Ayurvedic: The Vishesh, Ayurvedic: Abhyanga, and Ayurvedic: Udvartana into one course. "Ayurveda" which means "Science of Life" in Sanskrit, is an ancient self-care healing system developed over 5,000 years ago. It is considered the "mother of all healing". This course is an introduction to Ayurvedic principles and practices. It includes an overall view of Ayurvedic healing and Panchakarma including hands-on instruction of three different bodywork modalities based on the Ayurvedic

constitutional types or Doshas: Abhyanga, Vishesh and Udvartana massages. Students will become familiar with the three Doshas (distinct combinations of physical, mental and emotional characteristics : Vata, Pitta and Kapha ), three qualities of mind ( Sattva, Rajas and Tamas ), and three qualities of energy ( Prana, Tejas and Ojas ). In addition, they will learn hands-on the "marmas" (pressure points ), Shirodhara ( "thread of oil on the forehead" ) and Indian Head Massage. In this class students will learn the basics of Craniosacral Therapy (CST); which is a gentle, non-invasive hands-on technique that can be used to address not only the structure and fascia of the body, but also affects every system and function in the human body. History of the development of CST, research studies for evidenced based practice for a variety of conditions and basic knowledge and understanding of CST I anatomy, including the: bones of the skull, cranial membranes, intracranial membranes, Dural tube, CS fluid and rhythm will be presented. Practices to develop and deepen the practitioners' awareness, perception and subtle listening skills enhancing their ability to "listen" to the body from 'Neutral'. Techniques learned will include: CS Rhythm palpation, Still Point induction; Diaphragm Releases for the fascia of the Sacral Complex; Respiratory Diaphragm, Thoracic Outlet; Hyoid Bone, and Cranial Base. Gentle assessment and movement of the Cranial bones, Dural Tube and the holding Sacred Space will be explored.

This work requires client participation, and special emphasis is given to the mind-body connection. Students are taught effective communication skills to facilitate the emotional awareness associated with this kind of deep bodywork. Benefit of Deep Tissue include dramatic improvement in their client's posture, flexibility, range of motion, and energy level, while at the same time providing relief from tension, aches, pains and stiffness.

Lomi Ka'ala Hoku or Lomi Lomi massage, is an energetic healing modality based on the ancient Hawaiian concept of working with the life force of an individual to promote health and well-being. Lomi Ka'ala Hoku translates to "Massage Journey to the Stars" which reflects the intention of this massage, which is to calm the mind in order to heal the body. In this course students learn how to give the traditional, full-body Lomi Lomi massage as well as advanced strokes. They also practice releasing all prejudice and ego so they can come from a place of total acceptance of their client's uniqueness, and where they are in their life's journey. The energy work behind this style of bodywork comes from ancient Hawaiian teachings of personal empowerment, and was taught in the Hawaiian Temple for generations. Known as "Temple bodywork" Lomi Lomi is the most common form of "Hawaiian Massage" being done outside

Students will learn the tracks and stations of the meridians as well as their relation to TCM meridians and their interactions with each other via fascial walls and inside/outside front to back balance.

### **NeuroMuscular Therapy**

Neuromuscular Therapy is a precise examination of the body's soft tissues with an emphasis on thorough treatment until results are achieved. In this course, we assess injuries and determine effective treatments. We outline the normal mechanics and relationships of the structures for a baseline. The assessment process takes us

through exploring the relationship of various clinical conditions to musculoskeletal pain symptoms. Treatment involves performing techniques of mobilization, soft-tissue mobilization, friction massage, and myofascial release.

This course examines the normal mechanics of all major joints in the body and their interrelationship to soft tissue structures. We explore the following pathologies and present corrective treatment measures for various soft tissue sprains and strains, to include-thoracic outlet syndrome, rotator cuff tears, glenohumeral instabilities, impingement syndrome, frozen shoulder, carpal tunnel syndrome, tennis and golfer's elbow, and others. We will also examine Ischemia, Trigger Points, Nerve Compression/Entrapment, Postural Distortion, Biomechanical Dysfunction, Biochemical Dysfunction.

### **Passive Joint Movement**

This class introduces the student to the subtle but powerful use of rocking, oscillations and mobilizations pioneered by Milton Trager, M.D. through his Psycho-Physical Integration techniques, picking up along the way the osteopathic joint manipulations, and facilitation protocols designed to reset the proprioceptive system to a more deeply parasympathetic self-regulating and thus self-healing state. This is effected on one level by providing a novel sensation or "feeling" of through-ness, resonance and rebound of the connective tissue, a reset of the Gamma Gain levels of the joint and tissue receptors providing the recipient with a new and deep sense of ease, lightness and pleasure, and on another deeply profound level, through what Trager called "hook-up", the linking of the nervous systems of the client and practitioner (in this Trager borrowed from the

ancient Ayurvedic tradition ) Since modeling is an important communication tool, exercise to improve the practitioner's sensation sensitivity will be provided and practiced along with detailed hands-on session protocols.

In this course students will be given guidelines for positioning the pregnant client, and learn how to address contraindicated areas. Through lecture, demonstration and lots of hands-on practice, the student will gain the knowledge to facilitate a completely safe and deeply therapeutic pregnancy massage.

Professional Practices will include benefits and contraindications of massage, ethics, boundaries and laws, compassionate but firm communication skills. Business practices will include: Career development, simple budgeting and financing skills, business operations, records and security. This course includes clinical terminology for a review of Anatomy, Kinesiology and Pathology. The ABMP Exam Coach is required. Treatments are given on a mat with the client fully clothed and without the use of oil. In this course students learn about the energy channels (meridians) that flow through the body and examine how the body's organs correlate to the Five Elements. Through demonstration and guided, hands-on practice they will learn how to access “Acu-points” along these meridians and practice applying finger pressure, palm pressure, stretches, and other Massage techniques balance the “life-force energy” or (Chi) these meridians carry. This ancient massage modality was developed in Thailand and influenced by traditional medicine systems of India, China and Southeast Asia. Thai Massage works on both the physical and energetic systems of the body. It is performed on a floor-mat with the client wearing loose, comfortable clothing that allows for full movement.

In this course, students are introduced to the basic flow of Traditional Thai Massage, and will study Thai Massage Theory (which operates on the premise that our body is permeated with "lom" (air) that travels throughout the body along 72,000 pathways or energy lines called "sen". Through lecture, demonstration and guided hands-on practice, students will learn the locations of the body's 10 major "sen" lines and how to touch points along these energy lines to clear blockages and affect the entire body. With Thai massage, you learn a flow of movements that gently guide the client through a sequence of yoga-like motions. Combining rhythmic rocking and progressively deeper stretches, both client and therapist move into a state of meditative relaxation. Benefits include enhanced flexibility, a balanced and increased energy, better posture, and a lasting feeling of wellbeing. In this class, we will focus on repetitive use injuries that are common to the general populous. We will learn about pain patterns generated by habitually contracted muscle fibers called trigger points that are very specific in nature and cause myofascial pain and dysfunction. We will be successful in identifying and initiating the healing release of trigger points on ourselves, our partners and clients thus solving the pain problem. Common pain issues that we will address include: - Headache, Neck, Temporomandibular Dysfunction (TMJ), Ear Issues - Carpal Tunnel, Tennis Elbow, Golfer's Elbow, Upper Arm , Thoracic Outlet Syndrome - Frozen Shoulder, Upper Back, Chest and Side - Mid and Low Back, Buttock, Diaphragm,

Abdominal, Hip Flexor - Lateral Hip and Thigh, Anterior Hip and Groin - Lateral/Anterior/Medial Knee, Hamstring and Posterior Knee - Shin Splints, Ankle, Achilles Tendonitis, Plantar Fasciitis, Morton's Foot Syndrome.

### Tui Na: Acupressure Massage

Tui Na, is a massage modality based on Traditional Chinese Medicine. It involves stimulation of acupressure points to directly affect the flow and balance of "chi", (life energy) through "meridians" or channels in the body. In this course students learn manipulation techniques to move chi through ill and injured areas of the body where blockages tend to occur. They will practice specific treatments to address chronic pain, common illnesses, and disorders of the spine and joints, such as, Sciatica and rotator cuff problems. Through demonstration and hands-on practice students will master both oscillating techniques to increase energy, as well as the traditional presses and pulls characteristic of Tui Na.

### **Family Educational Rights and Privacy Act of 1974 As Amended**

The Family Educational Rights and Privacy Act (FERPA) affords students certain rights with respect to their educational records. These rights include:

- The right to inspect and review the student's education records within 45 days of the day the school receives the request for access.
  - a. Students should submit to the Director or other appropriate official, a written request that identifies the record(s) the student wishes to inspect.

Additional information regarding the hearing procedures will be provided to the student when notified of the right to a hearing.

### **Housing**

The Healing Hands School does not have on-campus housing nor does it assist students in finding housing.

There is housing for rent within 5 miles of each location of Healing Hands School of Holistic Health. Average cost of rental is \$1,800.

### **Transcripts**

Current or former students may request one free copy of their official transcript by submitting a written request to Healing Hands School with the name and address where the transcript is to be mailed. A fee of \$ 5.00 will be charged for additional copies and must be paid in advance before the transcript request is processed. Transcripts sent directly to the student will be marked to indicate that they are 'unofficial' copies.

In order to receive an Official Academic Transcript from Healing Hands School, the student must have satisfied all financial commitments to the school and to the U.S. Department of Education. Official academic transcripts will be withheld for failure to pay tuition, for default on an education debt or failure to repay an education grant overpayment, exception for cases involving bankruptcy.

Activities may include but are not limited to: providing volunteer massage therapy at sports events such as marathons, triathlons, etc; providing volunteer massage therapy at skilled nursing facilities and/or on-site locations; class field trips to local areas of interest in massage therapy such as job fairs or employment facilities; field trips to areas of local herbal/floral habitats; class parties to recognize achievements, graduation and events. We encourage participation in school events. Students and staff often record and post photos on social media. Therefore, it is the responsibility of the student to keep themselves out of photos if they choose to. The school does not take responsibility if a student's likeness or image appears on social media, websites or any online platform.

## **Transfer of credits to the School**

Students who wish to apply for advance standing in their program must submit official transcripts to Healing Hands for review prior to beginning their training. The Program Director will evaluate previous education and training that may be applicable to an educational program offered at Healing Hands.

Massage school transferred hours must come from a California Massage Therapy Council (CAMTC) Approved School list. To view the schools Approved by CAMTC, go to:

<https://www.camtc.org/schools/>. When applying for CAMTC Certification, transcripts must be sent from the school that the student is transferring from AND from Healing Hands School.

Credit may be given if the education and/or training were completed at another institution accredited by an agency recognized by the United States Department of Education (USDE) or the Council for Higher Education Accreditation (CHEA), including military training, as well as programs approved by the Bureau for Private Postsecondary Education where courses and clock hour values are comparable to those offered at Healing Hands and a grade of 'C' or 70 percent or better was attained.

Students who petition for transfer credit must provide Healing Hands with an official transcript that includes the courses the student wishes to transfer. In addition, students may be required to

demonstrate competency in requested transfer training courses. The Director or Program Director will prepare a written report to document the evaluation of the courses for which the student is petitioning for transfer credit; the report will list the documentation, (including the transcript of the courses the student is seeking to transfer) in the student file that was used in evaluating the transfer credit request and final determination. The maximum number of hours the student is allowed to transfer to a Healing Hands School of Holistic Health program is 50% of the total program hours. Transfer course hours will be the equivalent to those for which the student is receiving credit. Transfer hours are counted as both attempted and successfully completed.

Acceptance of credits earned at another institution that is not located in the United States or its territories will be evaluated by an agency which attests to the qualitative and quantitative equivalency of the foreign education and the specific course or courses for which transfer credit is to be awarded. It is the student's responsibility to use the credential evaluation services of an agency that has published standards for membership, affiliations to international higher education associations, and are frequently linked to and used by federal agencies, state agencies, educational institutions and employers (e.g., NACES and AICE).

### **Voter Registration**

In California you may register to vote by completing the online voter registration and then mailing it to the pre-printed address on the form. You may also register to vote whenever you apply for or renew your driver's license or state-issued ID card. Voter registration forms are also available in the Financial Aid Office.

### **Notice from the California Massage Therapy Council**

The California Massage Therapy Council [CAMTC] Publication of Law related to unfair business practices as related to massage: (1) Pursuant to California Business and Professions Code section 4611, It is an unfair business practice for a person to do any of the following: (a) To hold himself or herself out or to use the title of "certified massage therapist" or "certified massage practitioner," or any other term, such as "licensed," "certified," "CMT," or "CMP," in any manner whatsoever that implies or suggests that the person is certified as a massage therapist or massage practitioner, unless that person currently holds an active and valid certificate issued by the California Massage Therapy Council. (b) To falsely state or advertise or put out any sign or card or other device, or to falsely represent to the public through any print or electronic media, that he or she or any other individual is licensed, certified, or registered by a governmental agency as a massage therapist or massage practitioner.

Attendance and/or graduation from a California Massage Therapy council approved school does not guarantee certification by CAMTC. Applicants for certification shall meet all requirements as listed in California Business and Professions Code sections 4600 et. Seq. **.....X. Graduation.....****Certificate Awarded upon Graduation**

When all requirements for graduation are successfully completed, and all financial obligations have been met, graduates from programs offered at Healing Hands School will be awarded a "Certificate" from the School.

**Requirements for Graduation**

The student will qualify to graduate when he/she meets the program requirements as listed in this Catalog. Graduates will receive a Certificate if the following requirements have been met:

- All required courses in the student's program have been satisfactorily completed, including required tests, assignments, etc., and all program requirements have been satisfactorily fulfilled.
- A minimum grade of 80% or higher has been earned in each course.
- Student has satisfied all financial commitments to the school and to the U.S. Department of Education.

**Note 1:** Official academic transcripts will be withheld for failure to pay tuition, for default on an education debt or failure to repay an education grant overpayment, exception for cases involving bankruptcy. In such cases, students may request a single unofficial copy of the academic transcript (course printout). The printout will be labeled as "UNOFFICIAL" and will note that unpaid financial obligations are still owed to the school.

**Note 2:** If a student's account is sent to collections for non-payment, the student will not be eligible to receive a Certificate or transcript from Healing Hands School of Holistic Health, and the student will be responsible for all collection costs and attorney's fees.

- All required course hours have been completed within the maximum time frame allowed: 150% of the normal program length in clock hours and weeks of instruction.
- Student has attended at least 90% of the total hours in the program. Students receiving funding through Federal Financial Aid must complete 90% of hours.

**Transcripts**

Current or former students may request one free copy of their official transcript by submitting a written request to Healing Hands School with the name and address where the transcript is to be mailed. A fee of \$ 5.00 will be charged for additional copies and must be paid in advance before the transcript request is processed. Transcripts sent directly to the student will be marked to indicate that they are 'unofficial' copies.

In order to receive an Official Academic Transcript from Healing Hands School, the student must have satisfied all financial commitments to the school and to the U.S. Department of Education. Official academic transcripts will be withheld for failure to pay tuition, for default on an education debt or failure to repay an education grant overpayment, exception for cases involving bankruptcy. In such cases, students may request a single unofficial copy of the academic transcript (course printout). The printout will be labeled as "UNOFFICIAL" and will note that unpaid financial obligations are still owed to the school.

**Attendance Policy**

Students enrolled in the Holistic Health Practitioner elective courses can miss twenty five [25%] class time. Class time that is missed beyond 25% will result in a 'Fail'. Students in the Massage Therapist program may miss twenty percent [20%] of non-elective course. Class time that is missed beyond 20% in a non-elective course must be made up, and can not exceed an additional 20%. If a student misses more than 40% of a non-elective course, they fail the course.

**Purpose of Policy**

- To establish acceptable standards of attendance and punctuality for all students attending the School.
- To encourage students to pre-schedule absences in order to maintain adequate operations and disruptions within the classroom.
- To enable the student to complete the hours in the training program and meet the program objectives.

**Full Time and Part Time Course Attendance**

**Attendance and Tardiness Standards**

All students are expected to adhere to the following standards for attendance and tardiness.

- Students are expected to attend classes and learning experiences as scheduled.
- Students should call Healing Hands School at least 30 minutes before class to report an absence.
- If a student has been absent for more than 2 consecutive days in the course, the student will be placed on attendance probation and will be monitored. If absences continue, the student will be withdrawn and the final grade will be 'Fail' is permanently reflected on the transcript.
- Students enrolled in the Circulatory Massage course in their program can miss ten hours of class time. They must be in attendance for 90 percent of class time.
- Students enrolled in Clinical Practicum for the Massage Therapists are required to complete 100% of the time.
- Students enrolled in Massage Therapy are allowed to miss twenty percent [20%] of non-elective course. Class time that is missed beyond 20% in a non-elective course must be made up, and cannot exceed an additional 20%. If a student misses more than 40% of a non-elective course, they fail the course.
- Students enrolled in the Holistic Health Practitioner elective courses can miss twenty five [25%] class time. Class time that is missed beyond 25% will result in a 'Fail'.

## XI. SCHOOL POLICIES

- Please note: Students receiving funding through Federal financial Aid are allowed to miss only 10% of class time per course.
- The withdrawal date is the last date of academic attendance (LDA) as determined by the institution from its attendance records. If the student does not provide notification to the institution, the Date of Determination (DOD) is the date the institution becomes aware that the student ceased attendance. Except in unusual instances, the date of the institution's determination that a student withdrew should be no later than 14 days after the student's last day of attendance from the institution's attendance records.
- Tardiness is defined as any time a student is not at his/her seat and ready to study as scheduled. Students are expected to be ready to commence and end school on schedule; accordingly, arriving late or leaving early in connection with starting, ending, meal and break times is tardiness. Incidents of tardiness, which exceed Healing Hands School's standards, will result in a warning.
- Please refer to the Satisfactory Academic Progress Policy for more information). A 'W' Withdrawal is only in the case when a student has been approved for a Leave of Absence or is withdrawing from school and has not exceeded the attendance policy limit in the courses in which he/she is currently enrolled. In such cases, a "W" Withdrawal will be posted to the student's transcript for each course he/she withdraws from.
- If an individual course is unsuccessfully completed, the student will pay for all class hours of enrollment up to the official drop date at the program rate, at time of enrollment, plus a \$50 registration fee. This will be reflected as a Failed Course fee on the students financial statement

### **Distance Education Attendance Policy**

Students taking classes in an online format are expected to attend each session. Attendance is defined as participating in an academic activity within the online classroom, which includes posting in a graded discussion forum or submitting a written assignment. Experience has shown that good grades are strongly correlated with attendance, practice and participation. Students who do not participate in class are often surprised at how quickly and thoroughly they get behind. Lack of participation does not qualify the student for a refund.

Students are responsible for following the published policy on deadlines for drop and withdrawal. Students who do not attend at least once in any seven consecutive day period shall be issued an attendance warning. Students who do not attend at least once in any 14 consecutive day period may be dropped from the course and administratively withdrawn from the school retroactive to the last date of recorded attendance. Students who attend on the first day following 14 consecutive days of non-attendance will not be dropped from their course or administratively withdrawn.

Students must be officially enrolled in order to attend class and receive a grade. The school shall not post grades for students who are not enrolled.

Required courses, Anatomy for Bodyworkers and Professional Practices, will be offered as Distance Education or in-person for any student who would like to choose which format to attend in.

### **Student Authentication for Distance Education**

Student Authentication is mandated by the federal government and assures academic integrity. Student authentication allows for the use of unique student identification and passwords to ensure compliance and requires that, "...institutions of higher education offering distance education

programs have a process by which the institution of higher education establishes that a student registered for a distance education course is the same student that participates in, completes, and receives credit for the course.”

(The Higher Education Opportunity Act, 2008).

Healing Hands Distance Education therefore requires the current minimal standard for authentication: all distance education course work must be accomplished through a secure course management system with unique usernames and passwords each time a student engages in online coursework. Prospective students are asked to complete a self-questionnaire to determine if they have the necessary equipment to do distance education:

### **Response Times for Distance Education**

Healing Hands supports the timely completion of student evaluations of learning outcomes by qualified faculty, which are appropriate for use with the distance education methods used and evaluated by qualified faculty.

Healing Hands will employ a sufficient number of faculty to assure that (A) the institution's response to, or evaluation of, each student lesson is returned to the student within 10 days after the lesson is received by the institution; and (B) the institution's response to, or evaluation of, each student project or assignment is returned to the student within the time disclosed below.

The recommended instructor response time to student inquiries is to respond within 24 hours during business days, and 48 hours for non-business days. If the instructor cannot provide a detailed response to the inquiry within these time frames, it is recommended that the instructor inform the student regarding when a more detailed response will be provided.

Healing Hands shall maintain a record of the dates on which lessons, projects, and reports were received and responses were returned to each student.

### **Classroom Tardiness/Early Departure Rules**

- Students may not enter or exit class except during break without express permission from the instructor.
- If a student is more than 5 minutes late, the student will be counted absent for 15 minutes, 16 minutes late counts as 30 minutes, 31 minutes late counts as 45 minutes, etc.
- Students who arrive late for an exam, may be admitted at the instructor's discretion.

### **Course Work Make-up Policy**

Students may make up class time and/or course work in the following Director approved options:

- Students may attend a scheduled 'Practice Session'. Practice sessions are held as needed throughout the quarter, cost \$14.00 per hour, are instructor supervised. Student must attend full hours of the Practice session; i.e., student cannot attend part of a practice session.  
Example: If a student needs three hours of attendance and the practice session is scheduled for four hours, the student must pay for and attend all four hours. The Instructor will supervise make-up of missed lessons.
- Students may attend a class from a different session of the course they have missed. In order to make-up time of course work in a different class, students must pay \$14.00 per hour, must attend the full day of class, and must have permission from Director and Instructor.

### **Leave Of Absence (LOA) Policy**

Students may file a written petition requesting a leave of absence due to extenuating circumstances, which include but are not limited to the following reasons: medical, financial, or personal. Students who are on SAP Warning will not be permitted to take a Leave of Absence. Readmission will be on a space available basis and will fall under guidelines for readmission.

A Leave of Absence may be for a period of no more than one quarter (90 days). One Leave of Absence may be granted during the program of study. If the student does not return from the scheduled Leave of Absence on the scheduled return date, the student will automatically be withdrawn from attendance at the Healing Hands School and will be notified in writing of this action.

The student will officially withdraw from all courses the student is enrolled in at the time the student takes an approved Leave of Absence; a grade of 'W' Withdrawal will be posted to the student's transcript for these courses. Hours attempted in all courses in which a 'W' Withdrawal is received are counted in the determination of the Student's Satisfactory Academic Progress (SAP); refer to the SAP Policy in this catalog for more information.

A student, who is receiving financial aid, who is on an approved Leave of Absence retains 'in-school' status for purposes of Title IV loans. However, the student should be aware that if he or she does not return from a Leave of Absence, some or all of the grace period of the loan could have been used up, as the withdrawal date is the student's last day of actual attendance.

### **Dress and Appearance**

Students should utilize good judgment in determining their dress and appearance. Neatness and cleanliness are necessary at all times. Dress in clothing that allows free movement. The Director will advise the student of inappropriate dress or appearance.

### **Conduct Guidelines**

The Conduct Guidelines are designed to protect the interests of the Healing Hands School, its students, clients, models faculty and staff. All students at the School are expected to conduct themselves in a professional manner suitable to the employment fields they intend to enter. Students must act in a manner that is non-disruptive and is conducive to their learning and the learning of others.

The Healing Hands School reserves the right to suspend or dismiss any student whose conduct, in the opinion of the Administration, is disruptive or in any way interferes with the learning process of other students. The School further reserves the right to terminate the enrollment of any student not abiding by the policies and regulations in this Catalog or as set forth in writing by the School.

## XI. SCHOOL POLICIES

The Healing Hands School of Holistic Health expects a high level of maturity in the classroom of each student in the academic pursuit of his/her professional goals to become a massage therapist.

### Personal Conduct

Students are expected to demonstrate:

1. A desire to learn and develop his/her professional skills, demonstrated by being prepared for each class, having consistent attendance at class, and showing positive classroom participation that contributes to personal and professional growth of themselves as well as the other students. Disruptive behavior that impedes the staff or students from utilizing class time constructively will not be tolerated.
2. A courteous, respectful and nonjudgmental attitude towards staff and other students.
3. An ability to contribute and participate in creating a supportive environment for staff and students.
4. A willingness to receive constructive feedback.
5. The desire to take responsibility for their own values, attitudes, interpersonal relationships and academic performance.

Students are expected to show reasonable care for the facility. A student damaging the facility or equipment due to negligence will be financially responsible for repairs.

### Unacceptable Conduct

Since there are a wide variety of unpredictable and individual situations, the following is a list of examples of unacceptable conduct at Healing Hands School. This list is not meant to be all-inclusive:

- Insubordination.
- Willful abuse of the clinical site's building, equipment or other property.
- Smoking in unauthorized areas.
- Excessive absenteeism or tardiness.
- Absence without proper notification or adequate explanation.
- Leaving assigned work without permission.
- Violation of the clinical safety rules.
- Engaging in horseplay.
- Failure to report an accident involving a client, visitor, student or self.
- Theft, regardless of value.
- Dishonesty in dealing with the School.
- Reporting to the School under the influence of alcohol, drug or other illegal substance.
- Possessing or using alcohol while at the School or clinical site.
- Use, sale, solicitation, unauthorized possession of, or being under the influence of illegal drugs, including narcotics and/or controlled substances on School premises.
- Falsification of information on the "Application for Admission" or other records.
- Discourteous treatment or abusiveness toward fellow students, instructors, clients, visitor or guest of the School or Clinic.
- Unauthorized possession of firearms, explosives, knives or other lethal weapons on School or clinical site property.
- Indecent conduct on School premises.
- Conviction of any crime which renders a student unsuitable for employment.
- Gambling on School property.
- Violation of the no-solicitation rule.
- Failure to conform to dress and appearance standards.
- Failure to notify the School when absent from either clinical or theory.

- Removal of School, clinical site's equipment for personal use without approval.
- Violation of the School's sexual harassment policy. Sexual advances, repeated innuendos, or sexual activity on school premises or any massage therapy setting regardless of location.
- Refusal to cooperate in an investigation of suspected wrongdoing when cooperation is requested and the request is a reasonable one.
- Misusing the availability of, or the access to confidential information.
- Defiance of classroom protocol.

### **Actions Resulting in Immediate Termination**

The following are examples of actions which constitute reason for termination from Healing Hands School:

1. Endangering life, safety or health of others.
2. Deliberate damage to client, other students, School or clinical materials and/or property.
3. Falsifying, altering, removing, destroying or the unauthorized disclosure of confidential records or information pertaining to a client or clinical site.
4. Falsifying personal or clinical records.
5. Unauthorized possession of School property.
6. Failure to maintain satisfactory academic progress as outline in the Standards of Satisfactory Academic Progress.
7. Unauthorized possession, use, or being under the influence of liquor, narcotics, hypnotics, hallucinogens or other chemical agents while on the premises of the School.
8. Unauthorized possession of any firearms or weapons (pistol, revolver, rifle, shotgun, ammunition, explosives, incendiary devices, knife, etc. on School premises, including the parking areas.
9. Conviction of a criminal offense committed on School property.
10. Willful or repeated violation of School or clinical site's policies and procedures.
11. Willful disregard of the School's welfare; interference with operations or relationships with patients or associates.
12. Unauthorized disposition of School or clinical site's assets or equipment.
13. Failure to comply with the Attendance Policy.
14. Sexual Harassment.
15. Harassment that is nonsexual.
16. Fighting or use of foul language.
17. Violation of any conditions as set forth in the Enrollment Agreement.
18. Willful disregard of the School's welfare; interference with operations or relationships with students, staff or clients.

### **Disciplinary Action and Dismissal for Misconduct**

It is the policy of the Healing Hands School of Holistic Health to engage in the process of monitoring student conduct. This effort is designed to provide continuous, consistent and supportive services that are intended to inform and guide the student in all aspects of their educational experience. The Conduct Policies are uniformly administered based on the degree of seriousness and nature of the misconduct. In all cases, the Director will participate in the review and decision making process of all incidents of unacceptable conduct, and will take the appropriate action.

- Based on the severity of the misconduct, the student may not receive a written warning.
- If, a written warning is given, and the student's behavior is not corrected (misconduct is repeated), the student will be terminated.

- Refer to the Termination/Dismissal Appeal Policy for information on how to appeal a decision of termination or dismissal.

### **Online Student Code of Conduct**

Freedom of speech and expression is valued not only throughout the society but also, and particularly, in the academic setting. Equally valued is the respect given to college computer systems and information technology. To that end, online students shall adhere to the following online code of conduct:

- Access Healing Hands courses only for lawful purposes.
- Respect the privacy of other members of the class and other students.
- Respect the integrity of the Healing Hands computer systems.
- Respect the diversity of opinions among the instructor and members of the class and respond to them in a courteous manner.
- Maintain academic integrity by preventing unauthorized use of username and password.
- Maintain an environment free of harassment, stalking, threats, abuse, insults, or humiliation to the instructor and members of the class. This includes, but is not limited to demeaning written or oral comments of an ethnic, religious, sexist (or sexual orientation), or racist nature; and the unwanted sexual advances or intimidations by email, or on discussion boards and other postings in course shells.
- Abide by all rules and regulations published by the school and agree to be subject to disciplinary actions as described in the General Catalog.

Disciplinary action may include probation, suspension, or dismissal from the school. Students suspected of committing any violation of the school policy are afforded due process before disciplinary action is imposed. However, in appropriate circumstances students may be suspended prior to a hearing.

When a violation has occurred, an incident report, including all pertinent data related to the alleged act must be submitted in writing to the Director. This report should include description of the action and names of all parties involved including witnesses. Upon receipt of the report, the Director will determine if a policy has been violated. If there is sufficient information, the Director will contact the student and initiate an investigation. The student will have the opportunity to provide any documentation to the committee to support or refute the report.

### **Healing Hands Computer Use Policy**

The Healing Hands School's computer use policy states: "Healing Hands considers violations of the computer use policy to be a disciplinary offense. Violators of the policy shall be dealt with to the fullest extent of the student code of conduct, institutional policy, or (if applicable), criminal law and prosecution. Intentional attempts to impede, restrict, corrupt or in any other way disrupt the efficient operation of the Institution's network computer system shall be construed as a blatant and intentional attempt to breach the integrity and security of the campus computer system, and shall be subject to the fullest extent of disciplinary policy and/or law."

### **Course and Schedule Change Policy**

Students are permitted to make schedule changes (add/drop) a course on or by the Registration dates listed in the class schedule prior to the course in which they are scheduled to attend. If the student does not attend and does not make an official course schedule change by the first day of the

course, the student is subject to all conditions of the Attendance Policy, and will be dropped and will receive a 'Withdrawal' grade if he/she fails to attend as required.

### **Copyright Infringement Policy**

Healing Hands has established Copyright Infringement policies. See the following 'Copyright Infringement Policy'.

### **Copyright Infringement Policies and Sanctions**

Healing Hands School wants to protect you and our information resources. It is a violation of federal law and Healing Hands School policy to share and/or distribute copyrighted materials without permission of the copyright holder. Violators may be subject to civil and criminal prosecution under federal law, as well as personal sanctions specified in school policy.

Photocopies or reproductions of copyrighted material from the school library is not to be used for any purpose other than private study, scholarship, or research. If the user makes a request for, or later uses, a photocopy or reproduction for the purposes in excess of "fair use", that user may be liable for copyright infringement. The institution reserves the right to deny a copying order from any staff or faculty member, if, in its judgement, fulfillment of the order would involve a violation of copyright law.

Administrative computers provide scanners to faculty and staff. These scanners could be used to copy a book, journal, or other printed material. Scanning copyrighted material may also be a violation of the copyright law if done in excess of accepted "fair use."

File sharing software is most commonly used to download music and movies from the internet. Many do not realize that this software may turn your personal computer into a server, or upload site, even if that was not your intent. Many worms, viruses and other malicious code get transferred during peer-to-peer file transfers. When violations are discovered, they contact the network owner and/or the internet service provider and demand that the offending device be disconnected from the network. To protect the user and Healing Hands School from further responsibility under federal copyright law or school policy, the school IT specialist will disable network access for any machine for which a complaint of copyright infringement has been received.

### **Summary of Civil and Criminal Penalties for Violation of Federal Copyright Laws**

Copyright infringement is the act of exercising without permission or legal authority, one or more of the exclusive rights granted to the copyright owner under section 106 of the Copyright Act (Title 17 of the United States Code). These rights include the right to reproduce or distribute a copyrighted work. In the file sharing context, downloading or uploading substantial parts of a copyrighted work without authority constitutes an infringement.

Penalties for copyright infringement include civil and criminal penalties. In general, anyone found liable for civil copyright infringement may be ordered to pay either actual damages or "statutory" damages affixed at not less than \$750 and not more than \$30,000 per work infringed. For "willful" infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys' fees. For details, see Title 17, United States Code, Sections 504, 505.

## XI. SCHOOL POLICIES

Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense. For more information, please see the website of the U.S. Copyright Office at ([www.copyright.gov](http://www.copyright.gov)).

### **Grading Policies**

The Healing Hands School instructor has the final authority for determining the student's grade for a course. Grades may not be changed by anyone other than the instructor. The scholastic progress of the student is reported at the end of each course and grades are recorded on the student's permanent record (transcript).

### **Grading Scale**

The Healing Hands School's grading scale is as follows:

100 – 80% .... Pass

79 – 0% .... Fail

W ..... Withdrawal (a course from which a student withdrew)

I ..... Incomplete (a course in which a student received an 'Incomplete' – refer to Incomplete Policy)

TC..... Transfer Credit

(Refer to the 'Incomplete' Grades and 'Course Repeats, Withdrawals, and Failed Courses' under the Satisfactory Academic Progress Policy for more information). A 'W' Withdrawal is permitted only in the case when a student has been approved for a Leave of Absence or is withdrawing from school and has not exceeded the attendance policy limit in the courses in which he/she is currently enrolled. In such cases, a 'W' Withdrawal will be posted to the student's transcript for each course he/she withdraws from.

### **Exams**

Students are tested at the conclusion of each course to ascertain the required acquisition of knowledge/skills. Students may be tested based on observed performance of skills, or a written exam may be given. Consult the specific course syllabus for details. All grades are recorded and reviewed with students.

### **Make-up Policy**

Students are permitted to make up exams and course work. A student may also repeat a course of study. To make up exams, students must make arrangements to do so with the instructor. Students are required to contact the instructor and make arrangements on the first day he/she returns to Healing Hands School. To make up class time refer to 'Course Work Make-up Policy' in this Catalog under 'Attendance'.

### **Grievance Policy**

As directors, Paula and Neha Curtiss encourage open, honest communication among staff, teachers and students. It is the policy of the Healing Hands School of Holistic Health to have a procedure and operational plan for handling complaints. The purpose of the Complaint Procedure is to provide a prompt and equitable process of resolving complaints by students, faculty, staff and public.

From time to time, differences in interpretation of school policies will arise among students, faculty, staff or the public. When such differences arise, usually a miscommunication or misunderstanding is

a major contributing factor. For this reason, we urge individuals with complaints to communicate them to the appropriate school representative immediately.

## **Grievance Procedures**

A student, faculty member, staff member or public may informally lodge a complaint by communicating orally or in writing to any instructor, administrator, admissions personnel or staff member as indicated in this policy. (The student is defined as an individual who is currently enrolled in an educational program at the Healing Hands School of Holistic Health). If the complaint is not resolved the student has the option to follow the Formal Complaint Procedure as described below. Note that the student's participation in the complaint procedure and the disposition of a student's complaint shall not limit or waive any of the student's rights or remedies.

### **Informal Complaint Procedure for Students**

Students with grievances should first meet with their Course Instructor. If the complaint is not related to the educational program, the instructor will advise the student to contact the appropriate Healing Hands School administrator. Or, if, after meeting with the instructor, the student believes that the concern has not been satisfactorily resolved, the student should then follow the Formal Complaint Procedure as described below.

### **Formal Complaint Procedure**

This formal complaint procedure is for students, faculty, staff and the public:

- If a student, faculty or staff member, or public still has concerns, he/she is directed to follow the Formal Complaint Procedure by:
  - a. Preparing a written statement of complaint, that is signed, dated, and includes a clear and concise statement of the facts including pertinent dates.
  - b. Submitting the written statement of complaint to the Director within 10 days of the incident.
  - c. The Director may require the complainant to meet with School's representatives to discuss the grievance.
- The Director will review the written grievance, and will notify the student, faculty or staff member or public member, in writing, of the decision within 10 days of receiving the written complaint.
- Whether or not the problem or complaint has been resolved by the School to the complainant's satisfaction, he/she may contact the Bureau for Private Postsecondary Education. The address is provided above.

### **Student Complaint Records and Log**

The School will maintain records and documentation related to complaints from students, faculty or staff, including a 'COMPLAINT LOG'.

## **Health, Safety & Controlled Substance Policies**

### **Health, Safety and Security**

The Healing Hands School of Holistic Health makes every effort to provide a secure and safe learning environment. The classrooms and campuses comply with all requirements of federal, state and local safety codes. A Safety Plan is in effect at the Healing Hands School. Please seek assistance from the Director if you wish to report a hazard or accident. All students and others are directed to immediately notify a school employee of any crimes that are witnessed, or that the student has been made aware of. Statistics regarding crimes on campus may be obtained through the Director.

Students must take responsibility for their own security and safety. Consideration of the security and safety of others is also expected. The Healing Hands School is not responsible for personal belongings, which are lost, stolen or damaged on campus or during an off-campus activity.

Students must notify a Healing Hands School employee of an injury or illness either experienced or witnessed. In addition, students are to advise a faculty member or other School employee, if they have seen or are aware of any compromises in security matters.

In case of an emergency, students are directed to immediately notify a School employee. Employees have been instructed in how to obtain the services of the appropriate professional help in the most expedient manner.

### **Sexual Harassment Policy**

The Healing Hands School of Holistic Health is committed to providing an environment that is free from sexual harassment and from the fear that it may occur. Sexual harassment will not be allowed and is against state and federal law; it constitutes any unwelcome sexual approach that may intimidate an individual or create a hostile environment.

Any complaint of sexual harassment will be taken seriously and promptly and fairly investigated, and appropriate action taken if warranted. Corrective action may involve probation or termination, depending upon the seriousness of the offense. All complaints of sexual harassment are to be taken immediately to the Director of the School. Refer to the Safety Plan for additional information on Sexual Harassment.

### **Crime Awareness and Campus Security**

Healing Hands School makes available to all current and prospective students and employees, upon request, the School policies and procedures for maintaining campus security.

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act or Clery Act is a federal statute codified at 20 U.S.C. Section 1092(f). The Clery Act requires higher education institutions that participate in federal financial aid programs to keep and disclose information about crime on and near their respective campuses. Disclosures about crime statistics and summaries of security policies are made in an Annual Security Report (ASR) by October 1st of each year. Faculty, staff, and all enrolled students are emailed a notification providing the website for this report, [www.healinghandsschool.com](http://www.healinghandsschool.com), under "School Documents & Reporting". Copies of this report may also be obtained from the Director of Institutional Compliance by calling (760) 746-9364. Information about specific crimes and emergencies is made publicly available on an ongoing basis throughout the year.

## **Infectious Conditions Policy**

The Healing Hands School strongly advises anyone with an infectious condition to consult with the School Director and a physician for the purpose of clarifying. The personal risk(s) and risk to the School community, prior to coming on campus.

The school utilizes a 'Symptoms Stay Home' policy. Symptoms of illness are taken seriously. If you have any symptom of illness, stay home. From home, consult with a health profession to diagnose the cause of symptom. Please contact the school's administration to determine date of return to class.

## **Personal Hygiene Standards**

Students are expected to take care, both in the classroom and when working with clients, to maintain the highest standards of personal hygiene, including, but not limited to, clean hair and body, appropriate clothing and avoidance of offensive odors and perfumes. Students are encouraged to wear clothing that allows for freedom of movement. Beyond these considerations, judgment of what is proper classroom demeanor rests with the instructor and Director.

## **Required Study Time and Outside Preparation**

Outside study and preparation, apart from regular classroom work, is required to successfully complete the required course assignments. Outside preparation requirements will vary by course. Students are informed of outside preparation assignments by the instructors, and course syllabi include a summary of these assignments. Students are responsible for reading any study materials issued by their instructors, and for preparing for assignments as directed.

The Healing Hands School of Holistic Health has adopted the following academic standards for all programs, and these standards are applied to ALL students, full-time and part-time. This Satisfactory Academic Progress Policy is effective July 1, 2019 and applies to all students effective July 1, 2020.

## **Satisfactory Academic Progress (SAP)**

### **Measurements and Standards**

A student's academic progress will be measured at the following SAP Evaluation Points:

- At the  $\frac{1}{2}$  point of the student's program based on Expected graduation of the  $\frac{1}{2}$  of the total clock hours and weeks of instruction in the program. Example: If the student is in a 600 Clock Hour Program that is 40 weeks of instruction in length the SAP Evaluation point would be at the time the student is scheduled to complete 300 clock hours and 20 weeks of instruction.
- At the end of the program or at the end of 150% of the total program clock hours and weeks of instruction, whichever comes first. Students may not exceed 150% of the total program clock hours and weeks of instruction.
- Students are evaluated at the end of each payment period; there are two payment periods for Healing Hands students, consequently, each payment period approximates  $\frac{1}{2}$  the length of the program in clock hours and weeks.
- All hours attempted, including those taken during the summer, are included in SAP evaluations at the end of each payment period.

**In order to maintain satisfactory progress, students must meet the following SAP standards:**

### **Holistic Health Practitioner Program:**

## XI. SCHOOL POLICIES

- Successful completion of the clock hours and weeks of instruction is achieved when the student earns a passing grade of 80% in each individual course attempted and attends 75% of each elective course hours, and attends 80% in each non-elective course hours.
- For students receiving financial aid, successful completion of clock hours and weeks of instruction is achieved when the student earns a passing grade of 80% in each individual course attempted and attends 90% of the course hours in each individual course attempted.

### **Massage Therapist Program:**

- Successful completion of the clock hours and weeks of instruction is achieved when the student earns a passing grade of 80% in each individual course attempted and attends 80% of the course hours in each individual course attempted.
- For students receiving financial aid, successful completion of clock hours and weeks of instruction is achieved when the student earns a passing grade of 80% in each individual course attempted and attends 90% of the course hours in each individual course attempted.

### **Students' academic progress will be measured as follows:**

Healing Hands School of Holistic Health measures its programs based on clock hours and weeks of instruction; therefore, a student is not allowed to attempt more than 150 percent of the number of clock hours and weeks of instruction in their program. The maximum timeframe a student is allowed to complete the program is 150 percent of the total number of clock hours and total weeks of instruction in the program; this policy applies to all students, full-time and part-time.

The requirements for rate of progress are to ensure that students are progressing at a pace at which they will complete their program within the maximum allowable time frame. All courses attempted are given a pass or fail grade (qualitative measure), except for courses from which a student is in good attendance standing and official withdraws due to an approved Leave of Absence" or due to a withdrawal from school, which are given a 'W Withdrawal'; if the student has exceeded the attendance policy at the time they request a Leave of Absence, the student will receive 'Fail' in all courses in which they are currently enrolled.

All grades received and hours attempted will be included in assessing student progress against the maximum allowable time frame through the last day of attendance. A 'W' Withdrawal Grade, granted to students who take an approved Leave of Absence or withdraw from school and have not exceeded the attendance policy are not counted in the qualitative measurement (grades), but all hours attempted for Withdrawal courses and all other courses the student attempted are counted in the quantitative measurement (total hours attempted).

In addition, the cumulative number of clock hours attempted in the program includes transfer hours accepted, clock hours for courses from which a student has withdrawn and hours for every repeated course. Transfer course hours will be the equivalent to those for which the student is receiving credit. Transfer hours are counted as both attempted and successfully completed.

The rate of progress toward completion is calculated by dividing the cumulative number of clock hours the student has successfully completed in the program by the cumulative number of clock hours attempted by the student in the program. The cumulative number of clock hours attempted in the program includes transfer hours, hours for courses from which the student was given a 'W' Withdrawal, repeated course hours and all hours attempted.

Students are to be aware that a failed single course in the program may only be repeated one time. If a student fails a single course a second time, it will result in the student's dismissal.

## **Attendance and SAP**

Students who are dropped from classes for failure to attend, according to the attendance policy, will receive a grade of 'F' 'Fail', which is permanently reflected on the transcript. Refer to the attendance policy in this catalog for more information. Refer to 'Course Repeats, Withdrawals and Failed Courses' above for information on the impact on SAP.

## **Appealing A SAP Evaluation**

Should a student disagree with the application of these satisfactory progress standards, or with a determination related to academic progress, he/she must submit an appeal in writing to the School Director. The Director will respond within five (5) business days. The Director may meet with the student to discuss the appeal. The Director's decision is final, and may not be further appealed. Also, refer to the Grievance Procedure in this Catalog.

## **Course Repeats, Withdrawals, Failed Courses and SAP**

Students who wish to repeat a course that have already achieved a passing grade must receive permission from the Director. Any courses that are repeated will count towards all SAP requirements the same as any other course.

Students must retake any course in which a final course grade of 'W' (Withdrawal), or, 'Fail' (Not Passing) is earned if the course is a program requirement. Note: The student must retake the entire course and must pay for the hours of enrollment as an incomplete class fee in the initial course. Students are allowed to retake a course only one time; a second course failure will result in immediate dismissal from the program. All final course grades in which a student has earned a 'Fail' (Not Passing) will reduce the student's overall percentage of successfully completed courses in the program and thereby negatively affect his/her satisfactory academic progress.

The course hours, of courses in which the student has earned a 'W' or 'Fail', are counted in the determination of the percentage of successfully completed cumulative course hours of the total course hours attempted in the program. Therefore, a grade of 'W' or 'Fail' will reduce the student's overall percentage of successfully completed course hours of the cumulative course hours attempted in the program, and thereby negatively affect his/her satisfactory academic progress. The student is required to successfully complete 70% of cumulative course hours attempted and weeks of instruction in the program at each SAP Evaluation Point in order to maintain satisfactory academic progress.

## **Incomplete Grades and SAP**

Students may be granted an 'Incomplete' grade for reasons that are deemed extremely serious. Students receiving a grade of Incomplete ("I") will be allowed 3 months after the end of the course, in which to complete the required work and submit it to the instructor of the course in which the grade was earned. The student will be allowed to continue attending while completing the required coursework of an 'Incomplete' grade. If, at the end of 3 months, the student has not completed the coursework, a final grade of 'Fail' will be recorded. An 'Incomplete' Grade does not affect the student's satisfactory academic progress, provided the student satisfactorily completes the coursework within the stated 'Incomplete Period' until the end of 3 months. All hours attempted in the course in which the student received an Incomplete are counted in the determination of SAP; if the student does not successfully complete the required course work within the time allowed, the 'I' Incomplete grade will be replaced with a final grade of 'Fail' in the course and the entire course must be repeated. All final course grades in which a student has earned a 'Fail' (Not Passing) will reduce

the student's overall percentage of successfully completed courses in the program and thereby negatively affect his/her satisfactory academic progress.

### **SAP and Leave of Absence**

Students may be granted a Leave of Absence, during the program of training, based on the conditions described in the Leave of Absence Policy in this Catalog. A Leave of Absence will ultimately extend the time it takes for a student to complete the program, and, based on when courses are offered it may result in the student's not returning to the program until the next enrollment period. The student will be withdrawn from the courses he/she is currently attending and a grade of 'W' will be posted to the transcript. Refer to 'Course Withdrawals' above for information regarding how a student's SAP is impacted based on a course withdrawal. Refer to the Leave of Absence Policy contained in this Catalog for more information on the LOA Policy.

### **Maximum Timeframe and SAP**

The student must complete all courses within 150% of the total clock hours and total weeks of instruction in the program.

### **SAP Warning**

When a student fails to meet the SAP Standards, at any SAP Evaluation Point, (except the final evaluation at 150% of the total clock hours and weeks of instruction) the student will be sent an SAP Warning. The SAP Warning is for a period of one payment period or (approximately ½ of the program) and cannot exceed 150% of the total clock hours and total weeks of instruction in the program. SAP Warning is defined as any student not meeting SAP Standards at any SAP Evaluation Point (exception: students will not be given an SAP warning for failure to meet SAP at the final SAP Evaluation Point or 150% of the total clock hours and total weeks of instruction in the program).

Students placed on SAP Warning are provided written notice via a Student Progress Report in an email. A student may not have more than one payment period of SAP Warning during their time in the program; students who do not fulfill the course requirements to be taken off the Warning will be withdrawn from the program.

A student who meets the terms of their academic plan will regain Satisfactory Academic Progress and removed from SAP Warning status.

Financial Aid Students who have received an SAP Warning may receive financial aid for one additional payment period, based on eligibility. At no time may an SAP Warning exceed the total clock hours or total weeks of instruction in the program.

A student may appeal a Satisfactory Academic Progress decisions by explaining why they failed to make SAP and explain what has changed in the student's situation that will allow them to meet SAP requirements at the next evaluation.

### **Actions Resulting in Termination / Dismissal**

**A student is subject to termination, if the student:**

1. Uses profanity.
2. Is defiant to administrators, instructors or staff.
3. Is unable to complete the coursework with a grade of 80% or higher after one course repeat.
4. Is abusing alcohol and/or drugs.

5. Is involved in sexual harassment of students, faculty or staff of Healing Hands School of Holistic Health.
6. Fails to comply with class requirements.
7. Falsifies his/her admission records or any school records or other documentation provided to Healing Hands School of Holistic Health.
8. Is found cheating.
9. Has inadequate attendance for graduation within the maximum time allowed. Refer to the satisfactory academic progress policy.
10. Classroom behavior is judged to be inappropriate according to the personal conduct policies of the Healing Hands School. Refer to "Personal Conduct" in this catalog.
11. Demonstrates behavior that is determined to be dangerous to him/herself or others while on Healing Hands School's premises.
12. Demonstrates physical, emotional, or verbal abuse and/or insubordination with a staff member and/or faculty member.
13. Demonstrates verbal, physical, and/or emotional abuse with another student.

### **Termination/Dismissal Protocol**

Upon witnessing and/or report of an unacceptable action by a student, the student will be notified as soon as possible of his/her termination. Administrators will assemble all paperwork to document the reason for termination/dismissal of the student and all paperwork applicable to withdrawal of the student from Healing Hands School.

### **Appealing Termination/Dismissal**

A student who wishes to appeal the decisions for dismissal may petition the Director in writing. The Director will review the student's request and will inform the student, in writing, of the decision.

### **Withdrawal and Readmission**

#### **Withdrawal from School**

A student who wishes to withdraw from the course of study at Healing Hands must do so in writing and must state the reasons for withdrawal and any consideration for future readmission. The student is required to participate in an exit interview with the Director or designee. The student will be notified of total tuition charges and any refund due. Refunds that are due will be paid to the student within 45 days of the date of withdrawal.

The student is required to clear all obligations in order to receive a withdrawal in good standing. Failure to comply with this policy means that the School may not honor any request for transcripts, letters of recommendation, request for information, and/or readmission.

#### **Readmission to School and Conditions for Reinstatement**

##### **Readmission to School and Conditions for Reinstatement**

A student, who has withdrawn from a program, and is interested in returning, may apply for readmission. Readmission is dependent upon fulfillment of all conditions set forth at time of withdrawal. Applications are reviewed and the student is informed in writing of readmission eligibility. Readmission will be on a space available basis. A student who has been terminated from a program for unsatisfactory academic progress and/ or violation of the attendance or conduct policy may apply for readmission after one academic year from the date of withdrawal.

The following conditions apply:

- Be current on all financial obligations to the school.
- Submit a letter of intent to enroll before the beginning of the new course. Failure to do this may result in a student not being admitted to the next scheduled course if the course is already full. However, current students are given priority, and therefore, there may not be an available seat for a student who wishes to be readmitted.
- If a student was terminated for failure to maintain satisfactory academic progress, the student must speak with the Director prior to re-admission. During this meeting, the student is expected to demonstrate how he/ she will benefit if reinstated. If the student is allowed to reinstate, he/she will be placed on academic probation for at least one quarter (90 days), and must maintain satisfactory academic progress as stated in the Standards of Satisfactory Academic Progress section above.
- The student must contact the School to obtain a new Student Contract (Enrollment Agreement). The student must discuss with the Director, any changes to curriculum, texts, fees and policies. All successfully completed courses (final course grade of 80%) will be transferred to the “new” enrollment and the student’s tuition will be adjusted.
- If the student is re-admitted within one (1) year from their official withdrawal date, and the school is using the same learning materials, a student may begin where they successfully (80% grade or better) left off in the academic coursework. Students may be required to repeat courses if the syllabus or course materials have significantly changed during the year. All grades previously earned will remain on the student transcript, and the maximum timeframe for program completion will be adjusted based on the remaining hours in the program to be completed.
- If different learning materials are being used than those the student was issued originally, the student will need to purchase those materials upon re-enrollment

### **Student’s Right to Cancel**

1. You have the right to cancel your agreement for a program of instruction, without any penalty or obligations through attendance at the first class session or the seventh calendar day after enrollment, whichever is later.
2. Cancellation may occur when the student provides a written notice of cancellation to the Campus Office that the student attends: Escondido Office, 344 East Valley Parkway, Escondido, CA 92025, or email to [contactus@hhs.edu](mailto:contactus@hhs.edu). Or Laguna Hills Office, 23022 La Cadena, Suite 205, Laguna Hills, CA 92653, or [contactlaguna@hhs.edu](mailto:contactlaguna@hhs.edu). This can be done by email, mail or by hand delivery.
3. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
4. The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement. If the Enrollment Agreement is cancelled within three business days of signing an Enrollment Agreement the school will refund the student all monies he/she paid.
5. If the Enrollment Agreement is cancelled after three business days of signing the Enrollment Agreement, the school will refund the student all monies he/she paid less an administrative cost of \$100.00.
6. Refunds are made 45 days from effective withdrawal date.

### **Service Member: Leave of Absence, Withdrawal and Readmission**

A service member who is called to duty maybe advised to take either a Leave of Absence or be withdrawn from the program with the automatic ability to be readmitted with the same status as when they left.

- If the call to duty is expected to last less than 180 days, the service member will be advised to take a Leave of Absence and to return to the program of study when they have completed their duties.

- If the call to duty is expected to last more than 180 days, the service member will be withdrawn from the program, with the ability to be readmitted at a later date beyond 180 days. Service members who are withdrawn, then return after completing the service will be readmitted with the same status as when they left: ei Current student.

These policies follow the Student Academic Progress for the program length of time.

### **Refund Policy: Withdrawal From The Program**

You may withdraw from the school at any time after the cancellation period (described above) and receive a pro-rata refund if you have completed 60 percent or less of the scheduled hours of the payment period in your program through the last hour of attendance. There are two payment periods for Healing Hands students, consequently, each payment period approximates  $\frac{1}{2}$  the length of the program in clock hours and weeks.

The refund will be less a on-time (graduation) deposit not to exceed \$250.00, and less any deduction for equipment not returned in good condition, within 45 days of withdrawal. The refund will be paid to the student (or third party payer) within 45 days of withdrawal. If the student has completed more than 60% of the payment period for which the student was charged, the tuition is considered earned and the student will receive no refund.

For the purpose of determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absences in excess of maximum set forth by the institution; and/or failure to meet financial obligations to the School.
- The student has failed to attend class for 14 consecutive days.
- The student fails to return from a Leave of Absence.

For the purpose of determining the amount of the refund, the date of the student's withdrawal shall be deemed the day of recorded attendance. The amount owed equals the hourly charge for the program (total institutional charge, minus non-refundable fees, divided by the total hours in the program), multiplied by the number of hours scheduled to attend, prior to withdrawal. For the purpose of determining when the refund must be paid, the student shall be deemed to have withdrawn at the end of 14 consecutive days. If the student has enrolled in more than 60% of the payment period for which the student was charged, the tuition is considered earned and the student will receive no refund.

If any portion of the tuition was paid from the proceeds of a loan or third party, the refund shall be sent to the lender, third party or, if appropriate, to the state or federal agency that guaranteed or reinsured the loan. Any amount of the refund in excess of the unpaid balance of the loan shall be first used to repay any student financial aid programs from which the student received benefits, in proportion to the amount of the benefits received, and any remaining amount shall be paid to the student.

### **Refund Distribution for Financial Aid Recipients**

Refunds on behalf of Financial Aid Recipients must be distributed in the following order:

- Federal Direct Unsubsidized Loans
- Federal Direct Subsidized Loans
- Federal PLUS Loans

- Federal Pell Grants
- Other SFA Programs
- Other federal, state, private, or HEISEI sources of aid
- The student

**The Difference between the Healing Hands Refund Policy and The Return to Title IV Policy:**

The Healing Hands Refund Policy determines the amount of the tuition and fees that the school has earned. The Return to Title IV determines the amount of financial aid that, the student, has "earned." Any unearned financial aid must be returned. Under policies established by the federal government, the responsibility to return the money is shared by the student and the school. This may result in increasing debt to the school. The Return of Title IV funds is applicable until over 60% of the total program hours has been completed by the student. Based on the calculation, it may be the case that the school will have earned tuition funds that were initially paid by the government but must be returned to the Federal Aid Programs. Therefore, the student may leave owing additional funds to the school even though the account would have been paid in full if the student had completed the program.

From the date of the student withdrawal, Healing Hands School of Holistic Health will return Title IV funds as soon as possible but no later than 45 days.

**When the student receives financial aid in excess of the aid that was earned by the student:**

- The School must return any unearned federal financial aid that was used to cover institutional costs within 45 days of the students withdrawal. The student will then be billed by the School for the returned funds. The student must repay this amount in full or contact the Business Office to establish a satisfactory payment arrangement. Unpaid debts will be turned over to the Attorney General.
- The student must return any remaining unearned federal financial aid not covered by the School. The School will notify the Federal Department of Education of the student's receipt of the unearned aid. Failure to return those funds within 45 days will result in the loss of eligibility of federal financial aid.

**Post-Withdrawal Disbursement for earned financial aid:**

- In the event that Title IV funds have been earned but have not yet been disbursed to the student upon withdrawal, from the date the funds have been received by the school:
  - grants will be disbursed within 45 days
  - loans will be disbursed within 30 days

This allows the student at least 14 days to respond. All post-withdrawal disbursements are applied to the student account first.

- If there is a credit after the application of disbursements to the student account, the credit balance will be disbursed within 14 days after the calculation of return to Title IV funds has been made.

.....XII. Drug and Alcohol Policy.....

**Standards of Conduct**

All students and employees are informed that the unlawful manufacture, distribution, dispersion, possession, or use of a controlled substance or alcohol within the premises of the school and at school sponsored events on or off campus is strictly prohibited. Students and employees violating this rule will be subject to disciplinary action up to and including immediate termination from the program or employment.

- Healing Hands School of Holistic Health is committed to protecting the safety, health, and well-being of its students, employees and all people who come into contact with its campuses, Recognizing that drug and alcohol abuse pose a direct and significant threat to this goal, Healing Hands School of Holistic Health is committed to ensuring a substance-free environment for all of its students and employees.
- Healing Hands School of Holistic Health therefore strictly prohibits the illicit use, possession, sale, conveyance, distribution, or manufacture of illegal drugs, intoxicants, or controlled substances in any amount or in any manner.
- In addition, Healing Hands School of Holistic Health strictly prohibits the abuse of alcohol or prescription drugs.
- Any violation of this policy will result in disciplinary action up to and including expulsion, termination of employment, and referral for prosecution.

Substances covered under this policy include alcohol, illegal drugs, inhalants, and prescription and over-the-counter drugs. An illegal drug is any substance that is illegal to use, possess, sell, or transfer. An inhalant is any substance that produces mind-altering effects when inhaled. A prescription drug is any substance prescribed for an individual by a licensed health care provider. You are under the influence if any substance impairs your behavior or your ability to work safely and productively; results in a physical or mental condition that creates a risk to your own safety, the safety of others, or company property; or is shown to be present in your body, by laboratory evidence, in more than an identifiable trace.

**Disciplinary Sanctions**

All students and employees are informed that the unlawful manufacture, distribution, dispersion, possession, or use of a controlled substance or alcohol within the premises of the school is strictly prohibited. Students and employees violating this rule will be subject to disciplinary action such as written warning, probation, fines, restitution, suspension, expulsion and termination of employment. A conviction involving the possession or sale of illegal drugs can result in a loss of student eligibility for federal financial aid.

No alcoholic beverages or illegal drugs will be permitted inside the Healing Hands School, in the School's parking lot or on School's grounds. Students known to be abusing alcohol or drugs or coming to class with their functioning impaired by alcohol or drug usage will be expelled from the school according to the Dismissal Protocol included in this Catalog. These students may re-enroll one time only after a period of one (1) year and treatment for their problem as well as a letter of recommendation for re-enrollment from their treatment counselor. A second violation of the alcohol and/or drug usage policy will result in expulsion with no re-enrollment possible.

## XII. DRUG AND ALCOHOL POLICY

In accordance with California law, persons under 21 years of age may not consume, purchase, or possess alcohol.

### **Legal Sanctions under State and Federal Law**

#### **California State Laws and Penalties**

A violation of California law for the use of alcohol by obviously intoxicated individuals will vary with the particular circumstances but may include imprisonment in the county jail and substantial fines and penalties. A DUI conviction may lead to a suspension or revocation of your driver's license, fine, jail time, and completion of a DUI program. Additionally, minors who are arrested for violations concerning the use of alcohol run the risk of having their driving privileges suspended or revoked until they are 18. A violation of the law involving an individual being under the influence of a combination of alcohol and other drugs (itself potentially deadly), may result in an increase in criminal sanctions and penalties.

- You must be 21 before you can buy or drink alcoholic beverages.
- Any person who furnishes, gives or sells any alcoholic beverage to someone under the age of 21 is guilty of a misdemeanor.
- Any person under the influence of alcohol in a public place and unable to exercise care for one's own safety or that of others is guilty of a misdemeanor.
- It is against the law for you to possess alcohol on any street, highway, or public place; or carry alcohol in a car; or be a passenger in a car carrying alcohol unless accompanied by a parent or legal guardian, *even if the container is sealed and in the trunk.*
- The court will order a one-year suspension of your driving privilege if you are between 13 and 21 years old and are convicted of a drug-related offense.
- It is a misdemeanor to ride a bicycle under the influence of alcohol, drugs or both.
- It is an infraction to possess an open container of an alcoholic beverage while in a motor vehicle.
- It is an infraction for an owner or driver of a motor vehicle to allow an open container of alcohol in the passenger area.

It is illegal to drive after consuming excessive amounts of alcohol in any form (including medications such as cough syrup), or taking any drug (including prescription medications), or using any combination of alcohol or drugs that impairs your ability to drive.

It is illegal for any person to operate a vehicle with a:

- BAC of 0.08% or higher, if the person is age 21 or older.
- BAC of 0.01% or higher, if the person is under age 21.
- BAC of 0.01% or higher at any age, if the person is on a DUI probation.
- BAC of 0.04% or higher, in any vehicle requiring a CDL—with or without a CDL issued to the driver. Federal Laws and Penalties

The Controlled Substances Act (CSA) is the statute establishing federal U.S. drug policy under which the manufacture, importation, possession, use and distribution of certain substances is regulated.

- First conviction: Up to one year imprisonment and fined a minimum of \$1,000 or both.

## XII. DRUG AND ALCOHOL POLICY

- After one prior drug conviction: At least 15 days in prison, not to exceed two years and fined a minimum of \$2,500.
- After two or more prior drug convictions: At least 90 days in prison, not to exceed three years and fined a minimum of \$5,000.

### **Federal Student Aid (FSA) Penalties for Drug Law Violations**

A conviction of any offense involving the possession or sale of illegal drugs can result in a loss of eligibility for federal student aid. Convictions only count against a student for aid eligibility purposes if they were for an offense that occurred during a period of enrollment for which the student was receiving federal student aid—they do not count if the offense was not during such a period, unless the student was denied federal benefits for drug trafficking by a federal or state judge. Also, a conviction that was reversed, set aside, or removed from the student's record does not count, nor does one received when she was a juvenile, unless she was tried as an adult.

### **Health Risks Associated with the Use of Illicit Drugs and the Abuse of Alcohol**

Signs of abuse or addiction - The physical signs of abuse will vary according to the type of drug being abused. The short term and long term effects of drugs are the symptoms that will present themselves during abuse. Addiction is a complex brain disease with symptoms that include strong drug cravings, active seeking of the drug, and use of the drug that continues even in the presence of devastating life consequences including loss of job, the incurring of debt, family and personal relationship problems, and physical health problems.

The following is a description of health risks associated with the use of illicit drugs and abuse of alcohol:

Alcohol - Alcohol is made from the fermentation of sugars by yeast organisms. It is commonly served as beer, wine and spirits.

Short term effects: decreased brain function, mood swings, decreased coordination.

## XII. DRUG AND ALCOHOL POLICY

Long term effects: Cardiomyopathy, Arrhythmias, stroke, high blood pressure, Steatosis, hepatitis, Fibrosis, Cirrhosis, pancreatitis, increased risk of cancer, decreased function of immune system.

Inhalants - Inhalants are solvents, aerosols, gases and chemical vapors that are used to alter the perceptions of the user. They can be found in many common household products including: spray paints, glues, markers and cleaning fluids.

Short term effects include: confusion, nausea, poor speech, decreased coordination, euphoria, dizziness, hallucinations, intense headaches, sudden death due to heart failure or asphyxiation, seizures and coma.

Long term effects include: Liver and kidney damage, bone marrow damage, nerve damage, and brain damage.

Marijuana - Marijuana is made from the plant Cannabis sativa. Its main ingredient is the mind altering chemical THC (delta-9-tetrahydrocannabinol).

Short term effects: enhanced sensory perception, euphoria, decreased reactions, balance and coordination, difficulty with learning and memory, hallucinations and anxiety.

Long term effects: Mental health problems, frequent respiratory infections.

Methamphetamines - Methamphetamines are extremely addictive amphetamine stimulants.

Short term effects: increased alertness, decreased appetite, increased breathing, heart rate and blood pressure, irregular heartbeat.

Long term effects: anxiety, confusion, drastic mood swings, violent behavior, paranoia, hallucinations, weight loss, severe dental problems, skin sores from uncontrollable itching.

Tobacco/Nicotine - Tobacco is grown for its leaves which carry a large content of the perception altering and highly addictive chemical Nicotine.

Short term effects: increased blood pressure, breathing and heart rate.

Long term effects: increased risk of cancer (especially lung, mouth and throat), chronic bronchitis, emphysema, increased risk of heart disease, leukemia, cataracts and pneumonia.

Prescription Drugs – Prescription drugs are any substance prescribed for an individual by a licensed healthcare provider. There are a number of prescription drugs that are highly addictive and have potential for abuse. These include opiate painkillers (e.g., OxyContin, hydrocodone), central nervous system depressants (e.g., Xanax, Vicodin), and stimulants (e.g., Adderall, Ritalin).

## XII. DRUG AND ALCOHOL POLICY

Short term effects: impaired reflexes and perceptions; slowed respiration and heart rate, significantly greater risk of having an accident while driving, seizures and memory difficulties; withdrawal symptoms such as nausea, shaking, sweating and nervousness, bone pain, insomnia, vomiting and uncontrolled leg movements, depression, exhaustion and sleep problems.

Long term effects: organ damage and failure, especially to kidneys and liver; dependency and addiction; intense withdrawal symptoms; increased mental health symptoms such as paranoia and depression; decreased cognitive function; risk of overdose and death.

### **Alcohol and Other Drug Prevention, Intervention, Treatment, Recovery and Rehabilitation Services**

Healing Hands School does not provide direct health or counseling services. The school can provide information about drug awareness programs, penalties for violations, and references to local resources.
