Definitions

- “Number of Students Who Began the Program” means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- “Students Available for Graduation” is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.
- “Number of On-time Graduates” is the number of students who completed the program within 100% of the published program length within the reporting calendar year.
- “On-time Completion Rate” is the number of on-time graduates divided by the number of students available for graduation.
- “150% Graduates” is the number of students who completed the program within 150% of the program length (includes on-time graduates).
- “150% Completion Rate” is the number of students who completed the program in the reported calendar year within 150% of the published program length, including on-time graduates, divided by the number of students available for graduation.
- “Graduates Available for Employment” means the number of graduates minus the number of graduates unavailable for employment.
- “Graduates Unavailable for Employment” means the graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- “Graduates Employed in the Field” means graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the announcement of the examination results for the first examination available after a student completes an applicable educational program.
- “Placement Rate Employed in the Field” is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.
- “Language” means the driver qualification requirement that interstate drivers must be able to read and speak the English language sufficiently per 49 CFR 391.41(b)(2); all courses at WPTS are provided in English only.
- “Number of Graduates Taking Exam” is the number of graduates who took the first available exam in the reported calendar year.



- “First Available Exam Date” is the date for the first available exam after a student completed a program.
- “Passage Rate” is calculated by dividing the number of graduates who passed the exam by the number of graduates who took the reported licensing exam.
- “Number Who Passed First Available Exam” is the number of graduates who took and passed the first available licensing exam after completing the program.
- “Salary” is as reported by graduate or graduate’s employer.
- “No Salary Information Reported” is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.

Student’s Right to Cancel or Withdraw and Refund Policy

1. The Student has the right to cancel or withdraw their agreement for a course of instruction without penalty or obligation—less a \$250.00 registration fee and \$1,000.00 incidental costs, totaling \$1,250.00, which will be made non-refundable after the 1st class session or the seventh day after enrollment, whichever is later. The date by which the Student must exercise their right to cancel is _____ / _____ / _____, _____ (initial). The Student also has the right to stop School at any time and will only receive a pro-rata refund if they have completed sixty (60) percent or less of the program. The amount of this refund is determined on a “pro-rata” basis according to the unfinished portion of the program less the aforementioned fees and non-refundable fees. Any absence, no show or tardy will count towards days completed—there will be no exceptions. All refunds will be paid within forty-five (45) days of withdrawal.
2. Cancellation or withdraw will occur when the Student provides a written notice of cancellation at the School address—2119 West March Lane STE A, Stockton, CA 95207—which expresses the Student’s intentions that they no longer wish to be bound by the Enrollment Agreement. This can be done by mail or by hand delivery.
3. For purposes of determining a refund under this section, a Student shall be deemed to have withdrawn from a program of instruction when any of the following, but not limited to occurs:
 - a. The Student notifies the School of withdrawal in writing.
 - b. The School terminates the Student’s Enrollment Agreement for failure to maintain satisfactory progress, failure to abide by the School’s Rules and Regulations, and/or absences in excess of the maximum set forth by the School.
 - c. The Student has failed to attend class: for three (3) days of the Class A program, or for one (1) day of the Class B program.
 - d. Failure to return from a leave of absence.
 - e. Failure to meet the financial obligation.

4. For purposes of determining the refund, the date of the Student's withdrawal shall be deemed the last date of recorded attendance.
5. If the Student has received federal student financial aid funds, the Student is entitled to a refund of moneys not paid from federal student financial aid program funds. If the Student defaults on a federal or state loan, both of the following may occur: the federal or state government or a loan guarantee agency may take action against the Student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan; and the Student may not be eligible for any other federal student financial aid at another institution or other government financial assistance until the loan is repaid.
