NOTICE OF REQUEST FOR CANCELLATION OR WITHDRAWAL

In the event that Coach In Training seeks to cancel or terminate this Agreement and/or withdraw from the Coaches' Training Program before the scheduled end of the program, Coach In Training shall provide Accomplishment Coaching with written notice of Coach In Training's request for cancellation or withdrawal via a method for providing notice described in Section 25 below (a "Notice of Withdrawal").

Upon the effective date of Coach In Training's providing of a Notice of Withdrawal, Coach In Training shall forfeit any and all tuition discounts and the total tuition owed under this Agreement shall be prorated to fifteen hundred (\$1,500.00) per month.
