STUDENT'S RIGHT TO CANCEL

A student has a right to cancel his or her agreement for a course of instruction, without any penalty or obligations, through attendance at the first class session, or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period, you have the right to stop school at any time. If you have completed sixty (60) percent or less of the scheduled days in the current payment period, you also have the right to receive a refund based on the percentage of time attended. If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from student financial aid program funds. Student must exercise his/her right to cancel or withdraw by midnight of the 7th calendar day after enrollment.

CANCELLATION POLICY

1. Cancellation may occur when the student provides a written notice of cancellation at the following address: DeHart Technical School, 311 Bitritto Way, Suite C., Modesto, California 95356. This can be done by email, mail or by hand delivery.
2. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
3. The written notice of cancellation need not take any particular form and; however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
4. If the Enrollment Agreement is cancelled, the school will refund any money he/she paid, less a registration or administration fee not to exceed \$200.00, and less any deduction for equipment not returned in good condition, within 45 days after the notice of cancellation is received.
