

#### **OBJECTIVE AND GOALS**

Our goal is to provide the highest quality education to students, who, after graduation, can successfully, enter the job market.

We believe that while theory is taught in the classroom, hands-on experience and modern practical training is stressed to assist the students to meet his/her job market goals.

Students will be encouraged to approach the training as though they were reporting to "WORK". The instructors are the "EMPLOYERS" and the students are the "EMPLOYEES". Each day the students will be provided with realistic project activities as through they were at work. #### **PROFESSION**

The occupations that SoftTech prepares the students for are occupations listed under the Demand Occupations as reported by Private Industry Council. None of the educational programs require a licensure.

SoftTech is a Private Institution that was founded in May 2000 and was granted full approval to operate. All Training will be provided at 3150 Hilltop Mall Road, Suite 27, Richmond CA 94806. The site was chosen because it is centrally located within close proximity of local transportation such as, Bart, Buses, and 80 Freeway. The Bureau for Private Postsecondary Education (BPPE) granted the institution approval to operate, which mean, "compliance with the state standards as set fourth in this chapter by the California Private Postsecondary Act of 2009, Title 5, California Code of Regulations, Division 7.5 To Operate By Bureau For Private Postsecondary Education.

As a prospective student, you are encouraged to review this catalog prior to signing an enrollment agreement. You are also encouraged to review the School Performance Fact Sheet, which must be provided to you prior to signing an enrollment agreement.

#### ADMISSION STANDARDS AND PROCEDURES

#### **Ability-to-Benefit Students**

"Ability-to-benefit student" means a student who does not have a certificate of graduation from a school providing secondary education, or a recognized equivalent of that certificate.

An institution is required, prior to executing an enrollment agreement with an ATB student, to have the student take and pass an independently administered examination from the list of examinations prescribed by the United States Department of Education (USDE).

- ➤ Students enrolling in the school who are required to complete the **Wonderlic Basic Skills Test** (WBST) Verbal Forms VS-1 & VS-2; Quantitative Forms QS-1 & QS-2 must have a passing score of at least 200 on the verbal section and at least 210 on the quantitative section.
- The student's satisfactory completion of six credit hours (or equivalent course work) that are applicable toward a certificate offered by the institution.
- If any applicant fails, the **WBST** test must wait a minimum of 7 calendar days before retaking a second version of the **WBST** test. If the applicant fails both versions of the **WBST** test, the applicant must wait a minimum of 60 days from the date of the second attempt before reapplying for admission to the school. Passing scores for the **WBST** are valid for five years.

#### Ability-to-Benefit Test

The ABT exam is independently administered on the "Wonderlic Online" testing website for "Ability-to-Benefit" students and administered by a certified proctor (the institution is not involved in the testing).

Students must be able to read, write, and speak English proficiently on at least a 12<sup>th</sup> Grade Level, additionally proof of high school diploma or its equivalent is required. An entrance examination which is the **ATB Wonderlic Basic Skills Test (WBST)** Verbal Forms VS-1 & VS-2; Quantitative Forms QS-1 & OS-2) will be given to determine the students' basic knowledge and abilities.

Each applicant will have an interview with a School Representative and the student academic and career goals discussed. Applicants not meeting the above requirements will be denied admission.

**Enrollment:** Accepted applicants may complete their enrollment by signing an Enrollment Agreement and arranging to pay tuition and fees. The enrollment becomes official only upon acceptance by the Director and payment of the registration fee. A copy of the Enrollment Agreement will be provided to the Student.

#### Admission of Foreign Students on an M-1 VISA

This school is not authorized under federal law to enroll nonimmigrant students.

# "NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION"

"The transferability of credits you earn at SOFTTECH is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in "Educational Programs" is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending SOFTTECH to determine if your certificate will transfer."

**Accreditation:** SoftTech is not accredited nor or any of its programs offered. Students please be advised that you are not eligible for federal financial aid programs.

*Credit Transfer:* Students who expect to transfer course/hours/credit to other schools, private and postsecondary institutions should confirm acceptance of SoftTech hours/credits.

**Prior Education Credit:** Credit for prior education will be considered for enrolling Students. In keeping with the policies of the institution SoftTech request that veteran or eligible person(s) provide documentation of previous education and training, this include but is not limited to, transcripts from all prior institutions, including military training, traditional college coursework and vocational training. Students must complete a series of tests to measure their past and current level of knowledge and skills. The amount of credit given will be based on achievement of a minimum grade of 85% percent SoftTech reserves the right to limit prior education credit.

Experiential Credit: The school does not award credit for prior experiential learning.

#### **DESCRIPTION OF FACILITIES**

The institution is located next to the Richmond Hilltop Shopping Mall, 3150 Hilltop Mall Road, Suite 27, Richmond, CA 94806 it is accessible to BART, AC Transit Buses, and easy access to US Highway 80. The 2 classrooms are 225 square feet each and can accommodate 8 students per class. The Administrative Office is 225 square feet. There is access to restrooms for Women and Men and is handicap accessible and free parking. There are many shops including restaurants, and other stores.

#### ACADEMIC POLICIES

**Curriculum Changes:** In keeping with the school's philosophy of an immediate response to the needs of Students and employers, the school reserves the right to make modifications in the course content and the structure of the curriculum. Any such changes, however, will not alter the financial obligation of previously enrolled Students.

*Unit of Credit:* The curriculum is structured in terms of clock hours. A clock hour equals one class period of 60 minutes where lectures, demonstrations and similar activities are conducted.

*Grading System:* Overall grade points of 70% or better will be considered passing. The Instructor does all the grading. Students are given examinations periodically and graded on academic subjects and practical skills. The grading is as follows:

Course Incomplete: An "IC" is given, as a final grade when the student does not have any time remaining in one or more required course(s). However, at the end of the term students may, with the instructor's approval, be granted an extension to complete the required course or work, assignments, and tests within a reasonable time frame. The extension cannot be used to make up accrued absences from class. If students do not complete the required course or course work, assignments and tests within the extension period, they will receive a failing grade of "F" for the course. The "F" will be averaged in with the students' other grades to determine the cumulative GPA.

#### **GRADUATION REQUIREMENTS**

An overall of 70% grade point average and 80% of class time attendance is required in order for a Student to graduate. A Certificate of Completion is issued upon successful completion of course requirements.

*Grade Transcripts:* Students will receive one transcript at the time of graduation without charge. Additional transcripts are available for \$10.00 each, payable in advance.

#### ADVISING

Students are advised regularly on academic issues and are encouraged to discuss their scholastic and vocational goals at length. The school has a sincere interest in the personal welfare and success of each Student and, therefore, the faculty and Director regarding advising employ an open-door policy.

#### PROGRAM CHANGES

Students may make a change in their program only until the end of the seventh day after an enrollment agreement has been signed. Such changes include transferring from one course to another in the chosen program. This is not recommended; however, students who can demonstrate that they can or have had training within the course can select a course equal to the same hours. If this request is approved, it will be considered and documented as a customized change to the selected program.

#### ATTENDANCE POLICIES

Good attendance will not only help a Student academically, but also reflect well on a Student should a potential employer want to know a Student attendance history. Attendance is recorded at the beginning of the instructional period.

**Absenteeism:** Students may be granted excused absences with the approval of the Director and with appropriate documentation for the following: injury or illness of the Student, death of an immediate relative and other special circumstance.

The Student should notify the Instructor to make special arrangements. Students are requested to notify the school if they are to be absent and why. If the Student is absent for three (3) days, the Instructor will contact the Student to ascertain the reason for the absence. Students are charged tuition for all absences, excused or unexcused, with the exception of an approved Leave of Absence. Students terminated for absences shall receive a refund of tuition in keeping with the refund policy. The Director will determine re-admission.

*Tardiness:* Class starts at a specific time; we expect Students to be on time. Students who are late for class miss valuable parts of the training and are very disruptive to the class. A Student tardy more than 15 minutes of the hour is considered absent for that hour. A Student missing all day will be counted absent for the total number of scheduled hours for the day. Students needing special scheduling to prevent tardiness should make arrangements with the Instructor.

**Consecutive Absence:** A Student shall be terminated when the Student is absent in excess of eight (8) consecutive school days or in excess of 20% of total clock hours in the program, whichever occurs first. To avoid such a termination a student must take a Leave of Absence or have a legitimate excuse, such as a Doctor's off-work order. VA will be notified accordingly.

**Make-up Work:** Students with excessive absenteeism or tardiness will have to make-up time missed, this includes any missing assignments. Work may be made up after school, during lunch hours, or at times, when regular classes are not in progress.

Class work not completed due to absence shall be addressed according to the Incomplete (I) grading policy; however, makeup work shall not be authorized for the purpose of removing an absence.

**Required Study Time:** In order to complete the required course assignments, students are expected to spend outside time studying. The amount of time will vary according to individual student abilities. Students are responsible for reading all study materials issued by the instructors and must turn in assignments at the designated period of time.

Leave of Absence: Leave of absence, including military leave, National Guard or Reserves annual two-week training or call to temporary active duty, shall be reasonable in duration, and shall not exceed the lesser of 30 school days or 60 calendar days in any twelve-month period and shall be for specific and acceptable purposes. The school attendance records shall clearly show leave of absence granted. A written request for leave of absence must be properly signed and dated by both the Student and an authorized school official and be placed in the individual Student file within one week of the beginning of such leave of absence. If the Student fails to return from leave, the Student will be automatically terminated, and a refund totally consummated within 30 days.

#### STUDENTS RIGHT TO CANCEL AND OR WITHDRAWAL

Students have the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first-class session, or the seventh day after enrollment, which is later. You may withdraw from the school at any time after the cancellation period as described in the (Student's Right to Cancel) provision located on the student enrollment agreement) and receive a pro-rata refund if you have completed 60 percent or less of the scheduled days in your "Enrollment Period". Enrollment Period is defined as the time period encompassed by "Program Start Date" through the "Program End Date" as they appear on the first page of the Student's Enrollment Agreement. Any refund will be less a registration or administration fee not to exceed \$250.00. Any Refund will be paid to the student (or third-party payer) within 45 days of withdrawal. If the student has completed more than 60% of their Enrollment Period, all tuitions considered earned and the student will receive no refund.

You may withdraw from the school at any time after the cancellation period (described above) and receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance. The refund will be less a registration or administration fee not to exceed \$100.00, and less any deduction for equipment not returned in good condition, within 45 days of withdrawal. If the student has completed more than 60% of the period of attendance for which the student was charged, the tuition is considered earned and the student will receive no refund.

For the purpose of determining a refund under this section, a student shall be deemed to have withdrawn from a program of instruction when any of the following occurs:

- > The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- ➤ Cancellation shall occur when you give written notice of cancellation at the address of the school shown on page 1 of the "Student Catalog". You can do this by mail, hand delivery, or telegram. The written Notice of Cancellation, if sent by mail, is effective when deposited in the mail properly addressed with postage prepaid.
- ➤ The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that you no longer wish to be bound by this agreement. You can also obtain

- The institution terminates the student's enrollment for failure to maintain satisfactory progress; failure to abide by the rules and regulations of the institution; absences in excess of maximum set forth by the institution; and/or failure to meet financial obligations to the School.
- The student has failed to attend class for 8 consecutive days.
- The student fails to return from a leave of absence.

If any portion of the tuition was paid from the proceeds of a loan or third party, the refund shall be sent to the lender, third party or, if appropriate, to the state or federal agency that guaranteed or reinsured the loan. Any amount of the refund in excess of the unpaid balance of the loan shall be first used to repay any student financial aid programs from which the student received benefits, in proportion to the amount of the benefits received, and any remaining amount shall be paid to the student.

If the student has received federal student financial aid funds, the student is entitled to a refund of monies not paid from federal student financial aid program funds.

#### CONDITIONS OF DISMISSAL/TERMINATION

A Student is subject to probation or dismissal for unsatisfactory academic progress, offensive personal conduct, dishonesty, nonpayment of tuition or fees, absence without prior notification, chemical abuse, and for any other reason derogatory to the welfare of SoftTech or the Student body.

#### **RE-ADMISSION**

An appeal and request for reinstatement must be submitted in writing to the Director. The Student must state the mitigating circumstances that he/she felt led to the termination or withdrawal, and state reasons for which it would not reoccur. The appeal decision rests with the school Director and is final. The Student will be notified of any conditions to be met, in the case of reinstatement. Any re-admitted Students are required to start at the beginning of the program. Credit is given for previous training, only if they successfully completed that course(s).

#### CONDUCT AND PERSONAL APPEARANCE

This school assumes that Students eligible to attend are adults who know and practice the social rules governing behavior in the workplace. The school's personal conduct rules prohibit dishonesty, unprofessional demeanor, and use of profanity, insubordination, and violation of safety rules.

- Students are encouraged to dress in a neat, clean manner, consistent with apparel required in a business environment. Recreational attire is not acceptable, nor is any clothing, which in the opinion of a school official is hazardous to the Student, other Students, equipment, or facilities.
  - This school prohibits the use of any controlled substance, including alcohol, anywhere in the training facility including the parking area. Students under the care of a physician may have prescription medication as long as the use of said medication does not interfere with the Student's learning ability nor pose a hazard to other Students.
- 3) No Student will be allowed to interfere with another Student's right to learn or the Instructor's right to teach.
- 4) Smoking, Beverages, and Food are not allowed in the training area.
- Failure to behave in an acceptable manner can lead to probation or termination, at the Director's discretion. A Student terminated for unacceptable conduct may appeal the decision. A Student who has been terminated for inappropriate conduct and who wants to be reinstated must petition the School Director, in writing. Reinstatement is only with the approval of the School Director. Strong demonstration by the Student of mitigating circumstances and/or corrective action must be

evident to insure that the situation will not reoccur. Any Student reinstated will be placed on conduct probation and subject to termination for recurrence of the behavior problems. Students will receive written notification of termination and/or reinstatement within three days of each occurrence.

# STANDARDS OF SATISFACTORY PROGRESS

Students will be judged to be making satisfactory progress if the following conditions are met:

Students are evaluated monthly to determine satisfactory progress. Satisfactory progress in the Word Processing and Computer Application programs is defined as the Student having and maintaining a cumulative grade point average (GPA) of 2.0. To avoid academic probation Students must maintain a minimum grade point of a C 70%.

If the Student is maintaining a C, he/she will be counseled by the Instructor, which shall be noted on the satisfactory progress report.

If the Student has not met the conditions, a conference will be scheduled with the Director, and may result in probation.

**Notice of Student Academic Progress:** Students not maintaining a cumulative grade point average of 70% and 80% attendance shall be provided with a Notice of Student Academic Progress outlining the academic and/or attendance problems. Additionally, a consultation will be scheduled with the Director to discuss the problems surrounding the student's non-satisfactory progress. The student will have 30 days to comply with the minimum standards as described above. If the end of the 30-day period student's benefits do not meet the minimum standards will be terminated. VA will be notified accordingly.

Appeal Process of Satisfactory Progress Report: Students may appeal a negative satisfactory progress determination, and/or disenrollment by providing a written appeal to the SoftTech Director, explaining in detail any mitigating circumstances or reasons for the appeal. The Director will provide a written response to the appeal within 10 days of its receipt, during which time the Student will be allowed to remain in school and continue with his/her course work. However, no financial aid will be disbursed during this 10-day period.

#### PROBATION:

If the Student has failed to maintain satisfactory progress after the midpoint, the Student will be placed on probation for 30 days. At the end of the period, the Student will be re-evaluated. During this period the Student must:

- 1) Maintain at least 80% percent attendance.
- 2) Maintain satisfactory progress 70% academic minimums based on feedback from his/her Instructors.

If these conditions are met, the probationary status will be lifted. The Students will be judged as making satisfactory progress if the conditions of the probationary period are met. Failure to achieve satisfactory progress after the probationary period will result in dismissal from the school unless a special condition is made and documented by the Director.

**Appeal of Probationary Status:** If a Student is placed on probation for any reason, said Student may submit a written appeal of this status to the Director. All such requests will be evaluated and acted upon promptly.

#### **EDUCATIONAL RECORDS**

The Family Educational Rights and Privacy Act of 1974 gives the Student the right to inspect their educational records upon reasonable notice. The Act also guarantees the privacy of Student educational records, and sets forth the conditions and circumstances under which a Student's educational records may be shown to others. Students who feel that their rights under the Act have been violated are entitled to request a hearing with the Director of the school in an effort to resolve the problem.

**Record Retention Policy:** The institution shall maintain Student records for each Student, whether or not the Student completes the educational service, for a period ending five years after the date of the Student's graduation, withdrawal, or termination, and transcript kept permanently.

**Examination of Student Records:** Students may make a written request to see their academic records. Challenges, for the purpose of correction or deletion, must be made in writing. Grades and course evaluations may be challenged **ONLY** on the grounds that they are improperly recorded.

#### SEXUAL HARASSMENT

Students or applicants who feel they are victims of sexual harassment should report any such incident to a staff member of the school immediately. Reports of incidents received by the school will be investigated in a confidential manner immediately. Students receiving independent government agency funding (such as EASTBAY WORKS, AND CAL-WORKS, etc.) should also report the incident to their agency representative. Any Student who is found to have sexually harassed other Students will be terminated immediately.

#### **CAMPUS CRIME**

As required by the State of California, this school will publish all known occurrences of crime committed on campus. In the event of a crime, an incident report must be completed and a police report may be filed.

Incident forms are available from the administrative offices. Any and all occurrences of crime should be reported immediately. In addition to the above information, the State of California requires that the institution post policies pertaining to sexual assault.

The victim and any witnesses present are to report the crime to campus staff immediately. Precautions will be taken to ensure the comfort, support and dignity of the victim.

The crime will be fully investigated and brought to justice the police will be contacted. It is the policy of the institution to summon a medical emergency team to ensure the health and well being of the victim.

#### STUDENT RIGHTS & GRIEVANCE PROCEDURE

A Student with a grievance first must make a reasonable attempt to resolve the issue on an informal basis with the person involved. The student should request a Summary of the Institution's Complaint Procedure Summary and a Student Complaint Form and submit it to a school official for investigation. If the issue is not resolved satisfactorily, the Student will meet with the Director of the school, and provide a written statement of the issues involved. If the grievance is not yet resolved, the Director will review the grievance with all parties involved. If the Director cannot resolve the complaint the student will be advised of his/her right to contact the Bureau for Private Postsecondary and Education for further resolution of the complaint.

Students may appeal a grade by:

- 1) Discuss with the Instructor the grade received and the criteria for its determination.
- 2) A copy of the documented conference that took place with the Student and Instructor should be presented at the appeal.
- 3) The Student and the Instructor should request a conference with the Director of the school. The Director's determination is final.

Please Note: For all students, once 60% of the course is offered and no drop has been requested, tuition is due in full and the student will receive no refund.

**Hypothetical Refund Example:** Assume that a student, upon enrollment in a 400-hour course, pays the full tuition of \$2,000, \$100 for non-refundable registration and \$150 for equipment as specified in the Enrollment Agreement and withdraws after completing 100 hours without returning the equipment he/she obtained. The pro rata refund to the student would be \$1,500 based upon the above calculations. If the student returns equipment in good condition within forty [40] days following his/her withdrawal, the School shall refund the charge for the equipment paid by the student.

#### **Student Tuition Recovery Fund**

The STRF is a fund administered by the Bureau for Private Postsecondary Education (Bureau) that relieves or mitigates economic loss suffered by a student while enrolled in a qualifying institution - generally, one that is approved or registered by the Bureau. At the time of his or her enrollment, the student must have been a California resident or enrolled in a California residency program, prepaid tuition, and suffered economic loss.

Effective April 1, 2022, the Student Tuition Recovery Fund (STRF) assessment rate changed from fifty cents (\$.50) per one thousand dollars (\$1,000) of institutional charges to two dollars and fifty cents (\$2.50) per one thousand dollars (\$1,000) of institutional charges. (5, CCR section 76120).

Effective April 1, 2024, the Student Tuition Recovery Fund (STRF) assessment rate will change from two dollars and fifty cents (\$2.50) per one thousand dollars (\$1,000) of institutional charges to zero dollar (\$0.00) per one thousand dollars (\$1,000) of institutional charges. (5, CCR section 76120). Institutions will still be required to complete and submit all STRF Assessment Reporting Forms on a quarterly basis and maintain specified student information for STRF-eligible students.

# 76120. Amount of STRF Assessment.

(a) Each qualifying institution shall collect an assessment of fifty cents (\$0.50) two dollars and fifty cents (\$2.50) per one thousand dollars (\$1,000) of institutional charges, rounded to the nearest thousand dollars, from each student in an educational program who is a California resident or is enrolled in a residency program. For institutional charges of one thousand dollars (\$1,000) or less, the assessment is zero dollars (\$0).

Note: Authority cited: Sections 94877, 94923 and 94924, Education Code. Reference: Sections 94843, 94911(b), 94923 and 94924, Education Code.

# **Student Tuition Recovery Fund Disclosures**

(a) A qualifying institution shall include the following statement on both its enrollment agreement and school catalog:

"The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. - 1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
- 2. You were enrolled at an institution or a location of the institution within the 120-day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120-day period before the program was discontinued.
- 3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
- 4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
- 5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
- 6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
- 7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number."

#### SYNOPSIS OF EACH COURSE

#### TY101 TYPING I

Electronic keyboarding is introduced to each Student to aid individuals in developing efficient alpha/numeric keyboarding skills on both the standard keyboard and the ten-key pad. Emphasis is placed on learning the keyboard by touch, and extensive drills. Pretest/practice/post testing, foster speed and accuracy.

#### **TY201 TYPING II**

# AP101 (COMPUTER APPLICATIONS ONLY) ADOBE MEDIA DESIGN PHOTOSHOP, ILLUSTRATOR, AND INDESIGN FUNDAMENTALS INTEGRATED W/ MICROSOFT OFFICE SUITE

Adobe Design is a suite of powerful applications – Adobe Illustrator, Adobe Photoshop, and Adobe InDesign. This part of the course includes exercises that incorporate tasks and features from each of the three programs to give you a comprehensive understanding of the suite. Additionally, it provides an integrated approach as to how the applications work together. Hands-on exercises and applications provide students with a practical method to learning software skills as well as design concepts for print publications. Exercises introduce basic skills then build to **integrate Photoshop**, **Illustrator and InDesign** together with **Microsoft Office Suite**.

# AP201 (COMPUTER APPLICATIONS ONLY) WEB DESIGN FUNDAMENTALS

Adobe Web is a suite of powerful applications that include: Adobe Dreamweaver, Adobe Fireworks, and Adobe Flash. This aspect of the course incorporates tasks and features from each of the three programs to give you a comprehensive understanding of the major programs in the Web Premium suite. This course and its exercises are designed to replicate the steps you take when you create a new site for a client. The students will create the site in Dreamweaver, adding pages and page elements, and then move to Fireworks to create and enhance graphics for the site. After you add the graphics to the Website in Dreamweaver, you moved to Flash to learn how to create simple animations for the site. Hands-on exercises and applications provide students with a practical method to learning software skills as well as web design concepts. Exercises introduce basic skills then build to **integrate Dreamweaver**, **Flash and Fireworks** together with **Microsoft Office Suite**.

#### **GWD 101 ADOBE PHOTOSHOP**

Professional imagery is critical in differentiating your creative work from the others. Photoshop is a foundational tool for most creative projects and effective designers know Photoshop well. This class is an easy and fun way to learn layer basics, photo retouching and image editing. If you want to create great images, this is the place to start.

This class is appropriate for novice to intermediate level users of Photoshop. We also recommend that you have the Adobe Photoshop software before starting the class. You can purchase the software or obtain a trial version of it from the Adobe website.

It is expected that users have a basic understanding of why and how they expect to use InDesign for publishing their documents. Bringing samples of desired or previous work is helpful but not required. We also recommend that you have the Adobe InDesign software before starting the class. You can purchase the software or obtain a trial version of it from the Adobe website.

You will learn how to configure the panels and document windows in Fireworks to suit your workflow. You will learn how to edit bitmap images and work with vector paths to create web interfaces. You will learn how to create and edit symbols, a powerful feature of Fireworks, and learn how Fireworks integrates with other Adobe applications like Dreamweaver, Photoshop, Bridge, and Flash. You should have a working knowledge of your computer and its operating system. Make sure that you know how to use

#### **GWD 501 ADOBE FLASH PROFESSIONAL**

Over this two-day course, you will build a Flash based website with interactivity, video and components, with some beginning Action Script, in addition to learning the key elements of the Flash interface, including panels, timelines, and frames, you'll learn how to work with graphics, create and edit symbols, modify text, add interactivity with Action Script 3.0, and incorporate animation and sound into your projects. This class also covers the new text engine, Deco drawing tools, and Spring feature for inverse kinematics, video enhancements, and more.

This class is designed for both new users to Flash and intermediate users interested in learning the latest features of Flash. No previous experience with Flash is necessary, but if you have used some Flash you'll still get a lot from the class. Knowledge of your operating system and basic computer navigation is required for all classes.

We also recommend that you have the Adobe Flash software before starting the class. You can purchase the software or obtain a trial version of it from the Adobe website.

We also recommend this course for those planning to obtain the Adobe Certified Expert status.

This class is appropriate for novice to intermediate level users of Premiere. It is expected that users have a basic understanding of why and how they expect to use Premiere in their environment. We also recommend that you have the Adobe Premiere software before starting the class. You can purchase the software or obtain a trial version of it for the Adobe website.

# Title 38 United States Code Section 3679(e) School Compliance Form
