- “Graduates Employed in the Field” means graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the announcement of the examination results for the first examination available after a student completes an applicable educational program.

STUDENT'S RIGHT TO CANCEL

You are entitled to a full refund of any monies paid to the California Phlebotomy if your cancelation request is received at least 1 full business day before the first class of the session for which you have enrolled. Any cancelation request received on, or after, the first day of class will be subject to the refund amounts listed in the table below.

After the commencement of class if the student quits attending OR requests to withdraw, we will refund based on the following attendance schedule. Once a student has attended 70% or more of the classes offered during the session they signed up for, NO REFUNDS will be given pursuant to CEC 94920.

All requests to withdraw must be submitted in writing to Info@CaliPhlebotomy.com

- Attended 1 Saturday Class or 1 &/or 2 Morning or Evening Classes = 75% full tuition (Minus registration fee)
- Attended 2 Saturday Classes or 3 &/or 4 Morning or Evening Classes = 50% full tuition (Minus registration fee)
- Attended 3 Saturday Classes or 4, 5 &/or 6 Morning or Evening Classes = 25% full tuition (Minus registration fee)
- Attended 4 or 5 Saturday Classes or 7+ Morning or Evening Classes = NO REFUND
