Student's Right To Cancel:

You have the right to cancel your agreement for a program of instruction, without any penalty or obligation. You also have the right to withdraw from school at any time; and you have the right to receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the current payment period in your program through the last day of attendance. Students may obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later.

Refunds due will be processed within 45 days of the last day of attendance if you provided written notification of withdrawal to the institution or from the date the institution terminates you or determines you withdrew. Refunds due will be paid without requiring a request from the student. Student's Right To Cancel:

California law says: A student has the right to cancel the enrollment agreement and obtain a refund of charges. BAFPTP shall refund 100 percent of the amount paid for institutional charges, less the application fee of \$50, if notice of cancellation is made through attendance at the first class session, or the seventh day after enrollment, whichever is later.

Date to exercise the right to cancel or withdraw: First day of class, which is October 4, 2024.

If the student has received federal student financial aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds.

To cancel the enrollment agreement and withdraw from the institution and obtain a refund, a student must send written correspondence by letter to Elizabeth Beringer at the Feldenkrais Institute of San Diego, 3680 6th Avenue, San Diego, CA 92103 or by email to office@feldenkraisresources.com stating they would like to leave the program.

Furthermore, the Feldenkrais Institute of San Diego extends the Right to Cancel through the entire training. During the course of training, if a Student chooses not to continue the training program—whether due to evolving personal or financial circumstances—a full refund will be made for any tuition paid in advance, that is any tuition paid for training days not completed. BAFPTP shall refund to the Student all tuition payments for any full-day training sessions of the program that the Student has not yet attended at the time of the notice of the Student's withdrawal.

The BAFPTP shall credit refunds within 45 days of a student's cancellation or withdrawal.
