### **Definitions**

- 'Number of Students Who Began the Program' mean the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- 'Students Available for Graduation' is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.
- 'Number of On-time Graduates' is the number of students who completed the program with 100% of the published program length within the reporting calendar year.
