### **Definitions**

- “Number of Students Who Began the Program” means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period.
- “Students Available for Graduation” is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.
- “Number of On-time Graduates” is the number of students who completed the program within 100% of the published program length within the reporting calendar year.
- “On-time Completion Rate” is the number of on-time graduates divided by the number of students available for graduation.
- “150% Graduates” is the number of students who completed the program within 150% of the program length (includes on-time graduates).
- “150% Completion Rate” is the number of students who completed the program in the reported calendar year within 150% of the published program length, including on-time graduates, divided by the number of students available for graduation.
- “Graduates Available for Employment” means the number of graduates minus the number of graduates unavailable for employment.
- “Graduates Unavailable for Employment” means the graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- “Graduates Employed in the Field” means graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the announcement of the examination results for the first examination available after a student completes an applicable educational program.
- “Placement Rate Employed in the Field” is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.
- “Number of Graduates Taking Exam” is the number of graduates who took the first available exam in the reported calendar year.
- “First Available Exam Date” is the date for the first available exam after a student completed a program.
- “Passage Rate” is calculated by dividing the number of graduates who passed the exam by the number of graduates who took the reported licensing exam.
- “Number Who Passed First Available Exam” is the number of graduates who took and passed the first available licensing exam after completing the program.
- “Salary” is as reported by graduate or graduate’s employer.
- “No Salary Information Reported” is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.

## Refunds

### Students' Right to Cancel (cancellation policy)

A refund, minus the STRF Fee\* and the registration deposit, will be issued to any student who cancels enrollment prior to the start date of their first course or within seven (7) days after signing the enrollment agreement, whichever occurs later.

*\* Effective April 1, 2024, the STRF assessment rate will change to \$0.00 per \$1,000 of institutional charges, resulting in 185.00 STRF Fee and Registration Deposit.*

### Refund Policy Enrollment Cancellation and Withdrawal

Students at TTC College have the right to cancel their enrollment agreement and/or withdraw from their program at any time. To initiate the withdrawal process, students must submit a written request via email to [academics@tarzanatc.org](mailto:academics@tarzanatc.org), with a CC to [ttcrecords@tarzanatc.org](mailto:ttcrecords@tarzanatc.org). The email subject should read: "Withdrawal and Refund Request." Once processed, the student will receive an email confirmation.

In accordance with the Bureau for Private Postsecondary Education (BPPE) regulations:

- Students are entitled to a pro-rata refund if they cancel enrollment or withdraw from the program by the first-class session or within seven (7) days after enrollment, whichever occurs later.
- Refunds will be issued within 45 days of receiving the withdrawal request.

#### Refund Calculation

- Refunds are calculated on a pro-rata basis for students who have completed 60% or less of the program.
- Students who complete more than 60% of the program are not eligible for a refund.
- For students who paid tuition in full and completed 60% or less, the refund will cover the unused portion of tuition minus the non-refundable registration fee of \$185 and the STRF fee.
- Students on a payment plan who withdraw after completing 60% or less will not be billed for any installments following their official withdrawal date.
- Students on payment plans will not be charged for any installments following the effective cancellation or withdrawal date.
