3. The written notice of cancellation need not take any particular form and, however, expressed, it is effective if it shows that the Student no longer wishes to be bound by the Enrollment Agreement.
4. You are due for a complete refund within 45 days after the school receives a valid Notice of Cancellation.
5. After the end of the cancellation period, you also have the right to stop school at any time; and you have the right to receive a pro-rata refund if you have completed 60 percent or less of the scheduled hours in the current payment period in your program through the last day of attendance.

7. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
